Minutes for Regular Meeting of October 22, 2002

1. CALL TO ORDER:

The meeting was convened at 5:02 p.m. by Assembly Chairman Dick Traini in the Assembly Chambers, 3600 Denali, Anchorage, Alaska.

Chairman Traini advised the Assembly the reason he pulled the item was in Protest since there was no conditional use for the establishment. Chairman Traini presented a letter dated 10-21-2002 from Planning Department Platting Supervisor, Jerry Weaver, in which he said enclosed was a copy for the conditional use permit application form. Mr. Weaver advised that failure to apply for the conditional use permit would result in Assembly Protest of the license application. The individual has not yet applied for a conditional use permit.

Chairman Traini questioned Municipal Clerk Greg Moyer if this was becoming a problem. Mr. Moyer explained the Clerk's Office wanted to make certain the permits "marry up together" and when the license comes over early enough, it needs to be submitted to the Assembly before the Protest date. Chairman Traini gave the history of the item and noted no motions were pending.

In response to Municipal Clerk Greg Moyer, Municipal Manager Harry Kieling advised there was an (S) version to be distributed. A copy was provided to the applicant and the Administration would make it available to the public.

In response to Chairman Traini, Planning Department Platting Supervisor, Jerry Weaver, advised he had met with the applicant on 10-17-02 to review his application for conditional use and the applicant had 6 requests. The requests are itemized on the AM provided to the Assembly. The applicant wanted to modify his occupancy date to 12-3l-04, and additionally the applicant wanted to have 100 indoor unfixed seating for the present facility on Lot 12, 104 indoor unfixed seating for the proposed facility on Lot 11, 204 indoor seating total and 300 total outdoor seating. He further requested the hours of operation be changed from 2:00 p.m. to 2:00 a.m. which Mr. Weaver concurred with, liquor sales to be 80% of the gross receipts and alcohol advertisement visible from off property and no limitation on outdoor live or recorded music. The occupancy levels are to be determined by the Anchorage Fire Department.

Ms. Fairclough moved, seconded by Ms. Shamberg,

Ms. Fairclough stated she found it difficult to digest 4 pages of information and would therefore make amendments on the original AR 2002-317 rather than the (S) version.

Ms. Fairclough moved, seconded by Ms. Taylor, and it passed without objection,

to amend AR 2002-317, Page 1, Section 3, Item 2, Line 32, to change date from "December 31, 2003" to "December 31, 2004".

Ms. Fairclough moved, seconded by Ms. Taylor, and it passed without objection, to amend AR 2002-317, Page 2, Line 4, to strike from "Thursday 2:00 p.m. to midnight and Friday through".

In response to Ms. Fairclough, Planning Department Platting Supervisor, Jerry Weaver, advised the typical time period is from 2:00 a.m. to 2:00 p.m.

Mr. Sullivan moved, seconded by Mr. Tesche, and it passed without objection,

to take up AR 2002-317(S) after the Assembly dinner break.

Chairman Traini instructed Municipal Clerk Greg Moyer to take up this item after the Assembly dinner break.

Ms. Fairclough withdrew her motion to approve AR 2002-317 or substitute for AR 2002-317(S).

Mr. Sullivan moved, seconded by Ms. Von Gemmingen, and it passed without objection, to substitute AR 2002-317(S) for AR 2002-317.

Ms. Fairclough moved, seconded by Ms. Taylor, and it passed without objection, to amend AR 2002-317(S), Page 1, line 22, change **"100"** to **"200"** non-fixed seats.

Ms. Fairclough moved, seconded by Ms. Taylor,

to amend AM 867-2002, Line 19, insert the word under No. 5, "no alcohol advertisement shall be viewed from off property."

The Assemblymembers discussed the amendments.

Ms. Fairclough moved to withdraw her amendment.

In response to Mr. Tesche, Mayor Wuerch noted that on Line 6 of AM 867-2002, are the issues the owner was asking to be considered. Reading the paragraph in its context perhaps Line 19, item 5 should not be amended, because it would be an incorrect statement of the meeting that was held between staff and the owner. Mayor Wuerch clarified the owner had asked that alcohol advertisement be viewable from off the property.

Ms. Fairclough and Ms. Taylor withdrew their amendment.

Ms. Taylor, speaking as Chair of the Public Safety Committee spoke against waiting until the 12-10-02 meeting and said she would schedule a meeting of the Committee as soon as possible.

Ms. Taylor offered a friendly amendment to the motion to postpone action on AO 2002-144 to 11-19-02 to allow the Public Safety Committee to meet and provide input. Mr. Tesche and Mr. Sullivan accepted the friendly amendment. Chairman Traini asked if anyone objected to Ms. Taylor's amendment. No one objected and approval of the motion was so ordered by the Chairman.

Ms. Taylor will schedule a hearing for the Public Safety Committee and advise the Assembly of the date and time.
