#### **DIRECTOR'S COMMENTS**

Mike Braniff, Parks and Recreation director

- 1. **Maintenance** Began making ice and making the transition into winter on the trails. There is some overflow on the Campbell Creek Trail in several locations.
- 2. **Beetle Kill** Beetle kill removal is finishing up this week. There will still be a small tree crew to continue work.
- 3. **Horticulture** Working on hanging Christmas lights and preparing poinsettias for our public.
- 4. **Lifeguards** In need of staff. Hoping to pick up several teens after swim team is finished for the season.
- 5. **Abatement** Working on camps all over town, especially near the jail. We are making a big push from east to west along the campbell creek trail
- 6. **Broadband in the Rec Centers** Big push to get broadband in the four recreation centers.
- 7. **Ice** Chanshtnu Muldoon is complete, Tikishla is almost there, Delaney park strip is taking some additional time, Cuddy Midtown Park is active.

# PRC 22-12: Proposed Naming of a Portion of A/C Couplet Buffer Park

Resolution No. 2022-09

Presented by Darrell Hess and Mead Treadwell

Darrell Hess, Staff support for the renaming panel, and Mead Treadwell requested a resolution from commissioners to rename a portion of A/C Couplet Buffer Park to the Johnny Ellis Rainbow Bridge Park. The park parcel is a designated and would like to both

rename and dedicate this parcel. The naming panel did its due diligence and what resonated with the naming panel was that the park and bridge has a lot of symbolism and bridging two communities. When they learned that the park area was not dedicated, there was a desire to provide that additional protection. There will need to be an ordinance to both dedicate the park and to provide the permission to rename the park. Johnny helped to secure funding for this bridge. This area meant a lot to him personally and many folks in the neighborhood supported this.

Mead Treadwell was one of four individuals that were named to the naming panel.

# **Discussion**

Mike Braniff mentioned that there is support from the Mayor's office. Blair commented that the park area is not a massive area and it looks like it would be in danger in the future for expansion. Hess mentioned that there is a 20 ft easement and there is no setback and no vehicle access from 15<sup>th</sup> Ave. Part of the reason the group came together was to dedicate and protect the park. Looney says that from watching Johnny's career over the years that he supports the renaming of the bridge and the park. Rafuse asked if the commission would like to go on record to say that they support the dedication of the park.

PRC 22-14: 2022 AMATS Project Updates

# Presented by Steve Rafuse, Parks Superintendent

Steve Rafuse, Parks Superintendent, presented on two upcoming Anchorage Metropolitan Area Transportation Solutions (AMATS) projects.

- Ship Creek to Coastal Trail Connection Project
  - o Mr. Rafuse showed the trail map that connects Ship creek along the railroad track and Small Boat Launch to Elderberry Park. It is a 1.3 mile connection and could open new opportunities for winter grooming. He continued by saying how it would also improve trail connections. It has been signed-off by the Alaska Railroad. Anticipated construction timeline is 2024.
- Fish Creek to Coastal Trail Connection Project
  - o Mr. Rafuse presented the project area map that shows the connection from the Fish Creek Trail to Coastal Trail. This area has some complicated land use, but luckily the railroad is a solid partner. There are currently three potential options for this connection, but as this project is just kicking off they are still evaluating options.
