General Obligation Bonds: These are bonds approved by voters of the Municipality of Anchorage and carry the full faith, credit, and taxing power of the Municipality. The payment of principal and interest (debt service) on General Obligation Bonds is assessed to each property owner depending on the location of that property and the use of those bonds. General Obligation Bonds are used for the purchase or construction of capital assets. General Purpose Bonds: These bonds are General Obligation Bonds issued for non-school capital acquisition purposes. School Bonds: These bonds are General Obligation Bonds issued for educational capital acquisition purposes. For the State fiscal year ending June 30, 2024, the State of Alaska will reimburse 100% of eligible debt service payments which equates to approximately 41.6% of the Schools' overall debt service payments for the year. Such payments are subject to yearly legislative appropriation. The omission of the state reimbursement of school debt service in 2025 and future years by the Legislature would have a significant negative impact on all property taxpayers in the Municipality of Anchorage. Numbers in the table are rounded to the nearest \$0.01.
