This notice announces that a zoning conditional use has been duly approved by the Municipal Assembly of the Municipality of Anchorage providing for the development of the herein described property in accordance with the provisions of the Anchorage Municipal Code of Ordinances and the terms and conditions of the zoning special land use permit approval as set forth in the Municipal zoning file 2023-0012. Under the provisions of the specified ordinance the subsequent development of the subject property shall be in accordance with the terms of the approved zoning conditional use or any subsequent amendments hereto.

13 THE ANCHORAGE ASSEMBLY RESOLVES:

15 **Section 1.** An alcoholic beverages conditional use is hereby approved for
16 beverage dispensary tourism license number, 6100 for Northern Pacific Airways,
17 Inc., dba Navigator Lounge; in the TR (transition) district; located at 4600 Postmark
18 Drive, Suite ND206, within Ted Stevens Anchorage International Airport, North
19 Terminal, ADA 31879 International Airport North Terminal Lease; generally located
20 south of de Havilland Avenue, west of Postmark Drive, and North of Tower Road.
21 This conditional use generally meets the applicable provisions of Anchorage
22 Municipal Code (AMC) 10.50, AMC (old code) 21.15.030, AMC (old code)
23 21.40.240D.5., AMC (old code) 21.50.020, and AMC (old code) 21.50.160.

25 **Section 2.** This alcohol special land use permit is approved subject to the
26 following conditions.

28 1. A notice of zoning action shall be filed with the State of Alaska Recorder's
29 Office within 120 days of the Assembly's approval of this conditional use.

31 2. All uses shall conform to the plans and narrative submitted with this
32 conditional use application, except that the licensee may change the hours
33 of operation listed on the application in accordance with all applicable laws
34 without having to modify the conditional use.

36 3. This alcoholic beverages conditional use approval is for beverage
37 dispensary tourism license number 6100 in the TR (transition) district, in
38 accordance with AMC 10.50, AMC (old code) 21.15.030, AMC (old code)
39 21.50.020, and AMC (old code) 21.50.160, for 2,825 square feet of gross
40 leasable floor area, inside security at 4600 Postmark Drive, Suite ND206,
41 within Ted Stevens Anchorage International Airport, North Terminal, ADA
42 31879 International Airport North Terminal Lease.

- 1 4. On-premises sale of alcoholic beverages may be seven days a week as
- 2 permitted by AMC 10.50.010 and Alaska Alcoholic Beverage Control Board
- 3 requirements.

- 5 5. Servers will be trained in accordance with the Alcoholic Beverage Control
- 6 Board's "Liquor Server Awareness Training Program," in accordance with
- 7 Alaska Statute 04.21.025. Upon demand, the applicant shall demonstrate
- 8 compliance with a liquor "Server Awareness Training Program" approved
- 9 by the State of Alaska Alcoholic Beverage Control Board, such as or similar
- 10 to, the program for "Techniques in Alcohol Management (T.A.M.)."
- 11
- 12 6. The use of the property by any person for the permitted purposes shall
- 13 comply with all current and future federal, state and local laws and
- 14 regulations including but not limited to laws and regulations pertaining to the
- 15 sale, dispensing, service and consumption of alcoholic beverages and the
- 16 storage, preparation, sale, service and consumption of food. The owner of
- 17 the property, the licensee under the Alcoholic Beverage Control license and
- 18 their officers, agents and employees shall not knowingly permit or
- 19 negligently fail to prevent the occurrence of illegal activity on the property.
- 20
- 21 7. A copy of the conditions imposed by the Assembly in connection with this
- 22 conditional use approval shall be maintained on the premise at a location
- 23 visible to the public.
- 24

25 **Section.** Failure to comply with the conditions of this conditional use permit
 26 shall constitute grounds for its modification or revocation.

 28 **Section 4.** This resolution shall be effective immediately upon passage and
 29 approval by the Assembly.
