

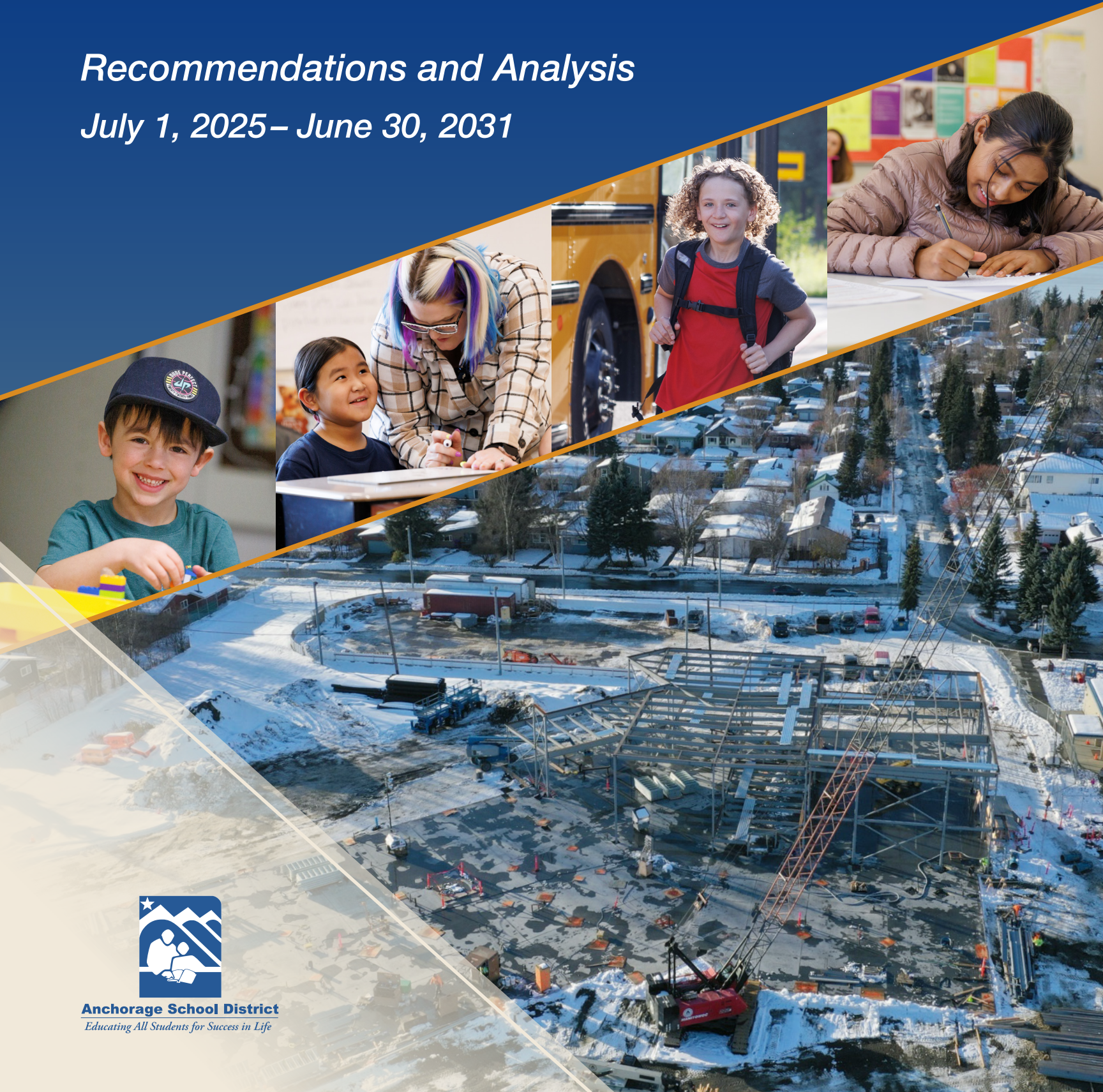

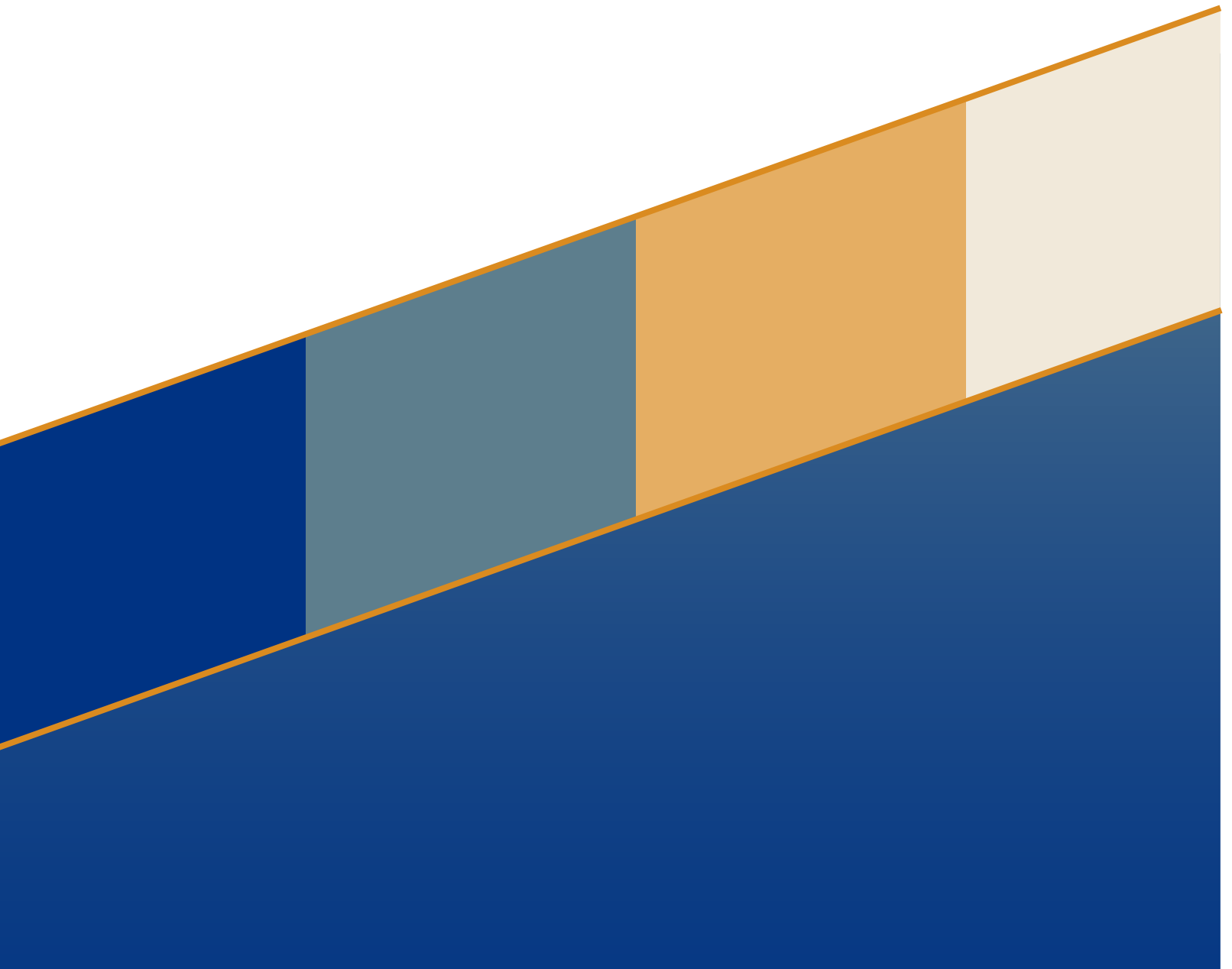

Introduction and Overview of CIP



I. Introduction and Overview

The Anchorage School Board is responsible for ensuring adequate educational and operational facilities for the students and staff of the Anchorage School District. To fulfill this obligation, the school board regularly engages in comprehensive long-range planning of school facility construction, renovation, and maintenance. On an annual basis, the school board adopts a Six-Year Capital Improvement Plan (CIP) that addresses capital needs, anticipated levels of student enrollment and municipal planning efforts. The CIP delineates the district's construction priorities over a six-year period.

The steps in preparing and approving the Six-Year CIP are listed below:

1. Review school board guidance and policy regarding capital planning.
2. Survey all principals to determine space utilization.
3. Collaborate with local demographer to determine enrollment projections by school and grade.
4. Receive administrative recommendations regarding capacity & membership projections.
5. Evaluate the Facility Condition Assessment Program (FCAP) to identify, validate and prioritize aged-out facility systems.
6. Collaborate with the municipality planning department to determine short and long range educational facility needs.
7. Present CIP to the Municipal Planning and Zoning Commission for recommendations.
8. Present CIP to the Superintendent and school board for approval.
9. Transmit adopted Six-Year CIP to the Anchorage Assembly and to the State Department of Education and Early Development (EED).

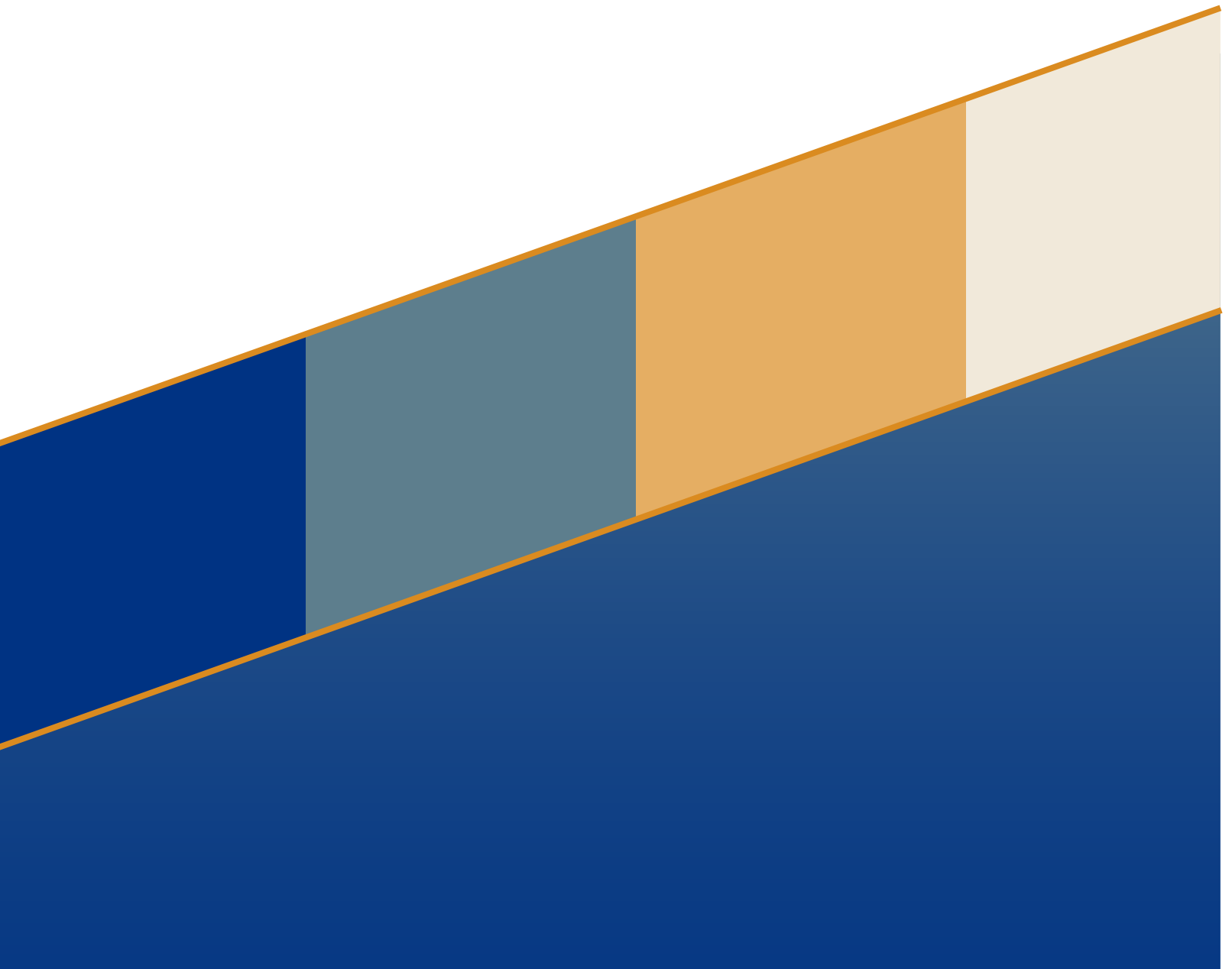

The Six-Year Capital Improvement Plan is a thorough, good faith document intended to convey the Anchorage School District's planned, future investment in its infrastructure. The plan is assessed annually and is subject to modification based on evolving educational needs, changes to facility conditions within the district, and other environmental factors (to include bond passage, budgetary matters, and demographic changes) that influence priorities and contribute to a more informed six-year investment plan.

II. School Facilities

The Anchorage School District (ASD) operates and maintains one of the largest physical plants of any public entity in the state, with over 7.8 million square feet worth over \$2 billion. The district has 90 facilities; 84 schools and 6 support facilities. There are 10 alternative and charter school programs that utilize leased facilities. The district houses approximately 42,600 students and more than 5,700 staff members. Currently the district is developing a Rightsizing plan that considers school closures, repurposing, and boundary revisions for the School Board to consider and approve for implementation. Final decisions will be included in future CIPs.

ASD has 25 (preK-5) and 31 (K-5) elementary schools, one preK-8 and one K-8 schools (table A). Aurora, Orion, Ursa Major and Ursa Minor elementary schools are located on Joint Base Elmendorf Richardson (JBER). Due to declining enrollment, Mt. Spurr closed at the end of the 2018-19 academic year. Ursa Major was closed in 2021-22 due to structural issues; however a replacement school is planned. Abbott Loop was closed in 2023 and repurposed as the Alaska Native Cultural Charter school.

ASD has 10 middle schools grades 6-8 and eight high schools grades 9-12 (table A). The District transitioned seven middle school grades 7-8 to 6-8 at the start of the 2024/25 academic year.

ASD has 8 charter schools and 11 alternative schools (table A).

Special Education services are offered in all elementary and secondary schools in the district. Some schools support self-contained programs for students with more significant disabilities who require this type of setting. Tyson, Kasuun, Lake Hood, Baxter and Whaley School, are dedicated to serving students with significant disabilities that require intensive behavior support. The district also provides services at our Alternative Career Education (ACE) and Adult Community Transition (ACT) programs for students 18 – 22 who require continued transition services.

In addition, the district operates three state contract programs: Alaska State School for the Deaf and Hard of Hearing, Providence Heights, and McLaughlin. The district also operates special educational programs for students in eleven short and long term residential facilities: Bragaw Heights, Cordova Heights, DeBarr Heights, Humphrey Heights, Jesse Lee Home, Maplewood, McKinley Heights, Piper Heights, Providence Heights, Puffin Heights, and Turning Point Heights.

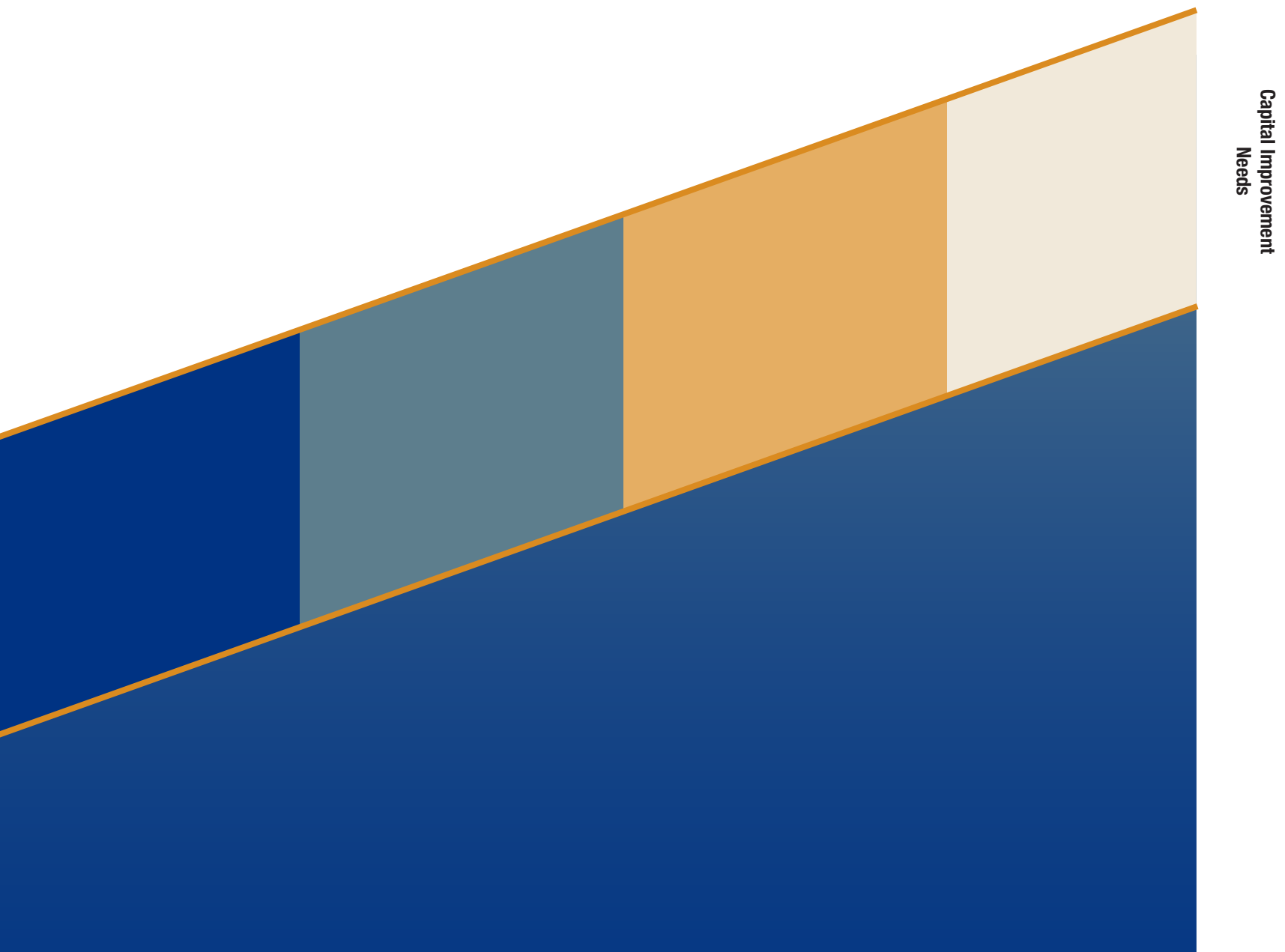

III. CAPITAL NEEDS

The Anchorage School District operates and maintains 90 facilities; 84 schools and 6 operational facilities. The average age of district facilities is 39 years. There are 35 facilities over 50 years old, including 16 facilities that are 60 years or older.

To properly identify and prioritize requirements across such a large physical plant, the district has implemented an integrated Facility Condition Assessment Program (FCAP). In 2009, the district initiated the development of an asset management system to assist in capital planning. Information was collected by Architect and Engineer teams during facility condition assessments utilizing a systematic and consistent methodology. Facility condition assessments have been completed for all district-owned facilities. Additionally, educational program assessments have been completed for all schools except the King Tech High School. Facility assessment data is updated routinely as facility condition assessment and construction projects are completed.

Educational program requirements are defined by districtwide educational specifications for elementary, middle and high schools. An Educational Adequacy Index (EAI) determines the ability of a school to meet educational program requirements by evaluating the quantity, configuration, size, and existence of spaces defined by the district's educational specifications. For example, a school may not have enough classrooms to offer health classes, or lack a gymnasium in addition to a multi-purpose room in order to facilitate concurrent lunches and physical activity. The EAI for a facility is calculated by dividing the cost to correct the educational specification deficiency by the replacement cost of the facility. The higher the EAI, the greater the level of educational inadequacies of the facility compared to ASD education specifications.

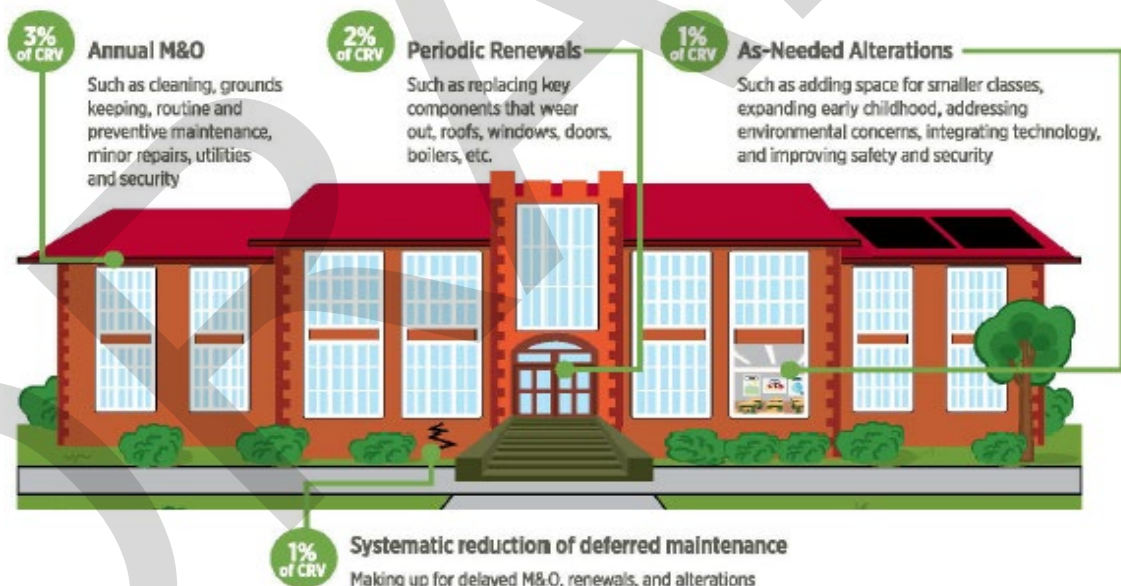
A Facility Condition Index (FCI) is also calculated to determine a facilities relative condition and estimates the investment cost needed to address aged-out facility systems. It is a percentage index derived from dividing the cost to replace "like" aged-out building component/systems by the facility's replacement cost. The higher the FCI, the greater the level of investment needed to sustain/renew the facility. The FCI can also be applied districtwide to measure the condition and

determine the level of annual investment needed to sustain/renew the district's capital infrastructure.

According to the national standard, an FCI less than .05 is considered "Excellent", .05-.10 is considered "Good" and .10-1.0 ranges from "Fair to Poor". With an estimated ~\$2 billion Current Replacement Value (CRV) and ~\$1.237B of deferred unfunded sustainment backlog, the current districtwide FCI is ~0.50.

Best practice within the facility management industry is to re-invest 4% of the CRV annually into capital projects. These projects can be broken down into three categories: Periodic Renewals (2%), As-Needed Alterations (1%) and Systematic Reduction of Deferred Requirements(1%), figure 1. For the ASD, this would equate to \$80M/year; \$40M for Periodic Renewals, \$20M for As-Needed Alterations and \$20M for Systematic Reduction of Deferred Renewals.

The FCAP centralizes information on the district's facility system conditions (FCI) and educational specification deficiencies (EAI). This information is reviewed and validated during routine facility assessments by utilizing systematic, consistent, and

repeatable methodologies. The FCAP serves as the basis to determine capital needs, priorities, educational inadequacies, capital costs and is used to develop short and long term capital planning and funding strategies for the district. Current and forecasted FCAP requirements and costs will be evaluated and prioritized annually based on the following criteria:

- **Category I-1 thru I-3:** year one requirements that address life safety, security, legal compliance, repair damaged/deteriorating facility to prevent loss of the facility, avoid high-cost emergency repairs and capitalize on rapid energy savings
- **Category II-1 thru II-3:** year two requirements that address educational program priorities, repairs less compelling than Priority I and deferred repairs that will lead to a loss of facility, hamper educational program or affect efficient operations
- **Category III-1 thru III-4:** year 3-5 requirements that address facility or site improvements necessary for proper functioning, economic maintenance & suitable appearance of new construction left uncompleted because of inadequate project funding, delayed deferred maintenance that can be postponed, anticipating actions for long-range planning and delayed to be combined with a future project.

Facility condition and educational program assessments highlight the following key considerations of sustaining the district's physical plant.

Building Component Life Cycle: Facility systems only last so long. Roofs deteriorate and leak; heating, plumbing, and ventilation systems wear out; and structural systems age. As components age-out, their reliability exponentially decreases and exposes maintenance and operational budgets to more emergency expenditures and increases the risk of impacting educational programs.

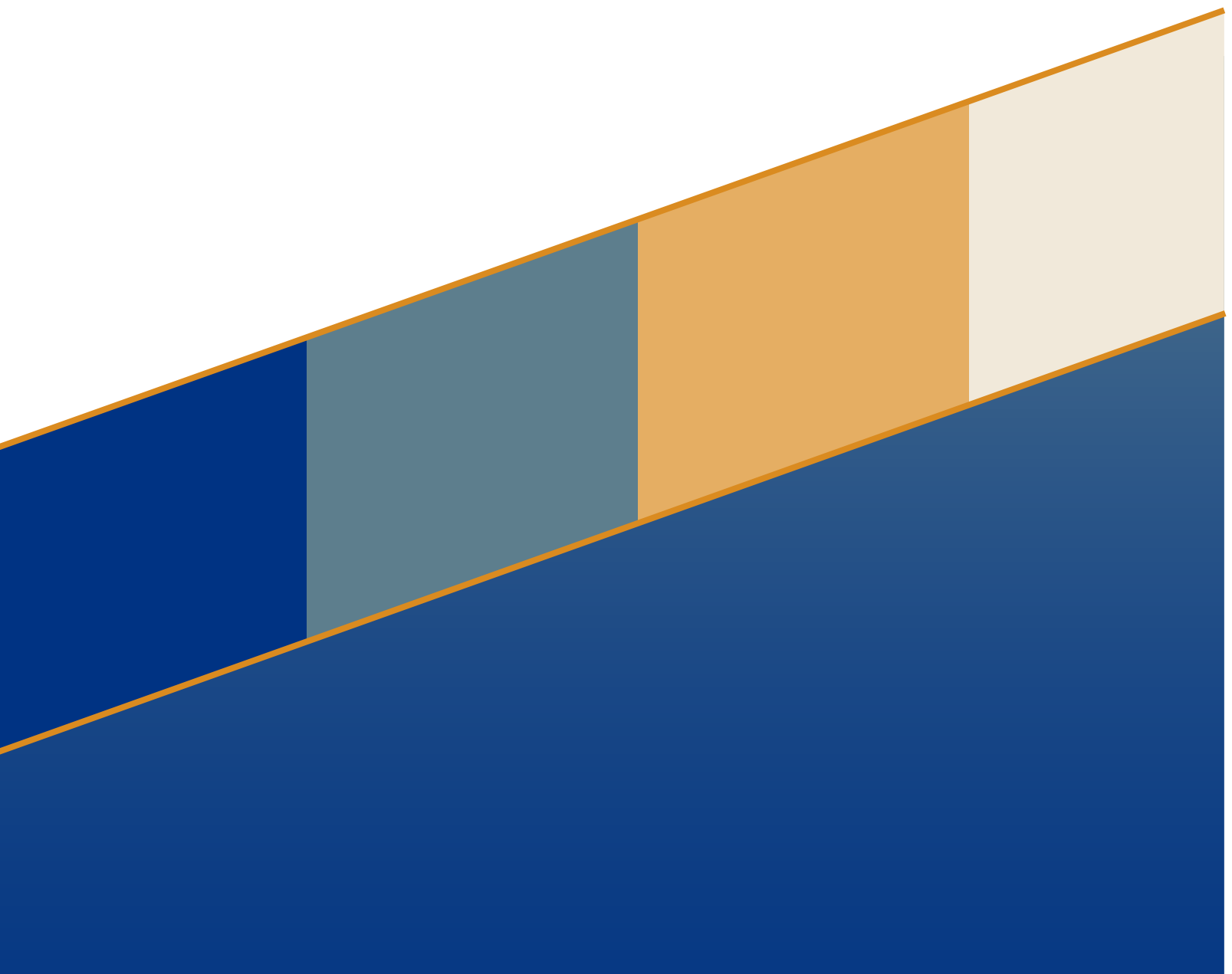
Functional Obsolescence: Over the life of a school, programmatic changes take place that demand updating the facility infrastructure. Current educational delivery methods require more technology and physical layouts that are often different and more flexible than those of 30 to 40 years ago. Additionally, various code changes require updating structural, electrical mechanical systems and improving accessibility for persons with physical disabilities. Moreover, significant renewals

often require structural upgrades to meet more stringent seismic codes. Overall, schools are considered for replacement after 50 years of service.

Capacity: The ASD is the largest school district in the state, and while overall enrollment has been in decline in recent years, the geographic distribution of students continues to shift due to the mobility of the state/city population. In order to meet short-term over-capacity situations, the district has 82 relocatable classrooms. However, the District will proceed in optimizing District facilities.

IV. CAPITAL IMPROVEMENT RECOMMENDATIONS:

The recommended six-year capital improvement projects, short description and their estimated project costs are reflected in Table 1. Projects funded through alternative means are also included in Table 1.

Initial project cost estimates are based on Fiscal Year 2023 DEED Cost Model with 7% inflation adjustments for years two through six. Adjustment to these cost estimates may be made in future years to accommodate fluctuations in construction costs and scope of work identified during initial planning or design stages of the projects.

The six-year CIP was developed through collaboration with municipal planners and extensive data-driven analysis. The plan considers board guidance and policy. This plan takes a more aggressive approach in addressing the district's deferred sustainment requirements, foregoes un-necessary large-scale renewals through the state's moratorium on debt reimbursement and addresses the district's top educational program priorities. The District is currently looking at optimization of space within District facilities, to include adjustment of school attendance boundaries, school closures and consolidations, repurposing, and review of current open-enrollment policies.

Table 2 identifies the agency coordination required for developing property currently managed by the district. Table 3 summarizes information from the FCAP.

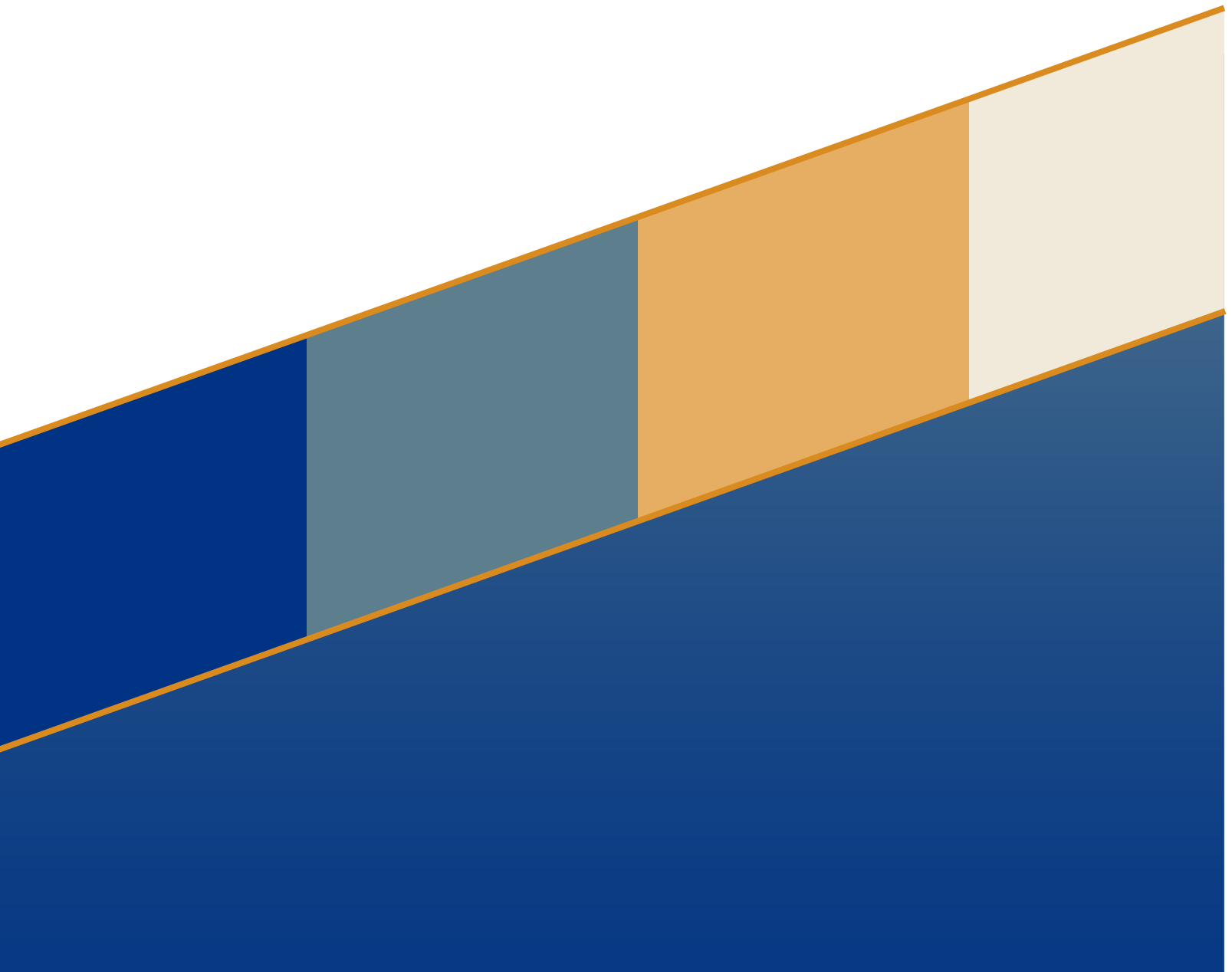

V. Membership Summary: 2025 to 2030

Forecasting Methodology and Assumptions: The principal method used to project the 2025 through 2030 enrollment is an econometric model which combines cohort-survival technique with a GIS-enabled database of school age children based on PFD data. For each school and grade there is an underlying statistical relationship derived from comparing historic enrollment with historic cohort survival and PFD counts. Cohort survival accounts for historical retention trends for each individual school and grade. Counts of eligibility based on PFD data aid projections when cohorts have not matriculated into the district, and historical enrollment data is unavailable.

After running initial statistical models, results for each school and grade level projection are assessed to ensure that the results are supported by underlying historical patterns or, if there is a change in pattern, that the change is supported by shifting demographic or economic factors.

ASD projections contained in this document do not reflect the impact of any major events occurring in the next six years that would be considered speculative: major projects that would boost population, closure or expansion of military installations, or major changes in the state's economic or political structure. Further, it is assumed that oil and mineral exploration will continue in Alaska throughout the decade, other industry and commercial sectors in Anchorage will continue to track overall economic activity levels, and employment levels will affect ASD membership.

During the spring 2019-2020 school year, the COVID-19 global pandemic was declared in the United States. The State of Alaska and Municipality of Anchorage immediately issued mandates to slow the transmission of COVID-19. Due to the ongoing pandemic, the District experienced an unprecedented reduction in student enrollment at the beginning of the 2020-2021 school year. While enrollment increased in the two years after, the long-term downward trend in enrollment continued in 2023-2024 and is expected to continue over the forecast period. Additionally, the District Administration acknowledges that 6-year membership projections represent declining enrollment accelerated by the pandemic.

Past Enrollment: From fall of 2019 to fall of 2020, the Anchorage School District experienced a decline in enrollment of over 4,200 students as a result of COVID-19. This decline followed several prior years of declines, and after an increase in fall 2022 enrollment, 2023 enrollment was down by almost 900 from 2022. Several factors are thought to be driving the longer-term losses:

- U.S. Unemployment: When jobs are abundant in the contiguous United States, net outmigration from Alaska generally increases. There have been six other instances from 2000 to 2023 when enrollment declined by over 600 students ('06, '07, '13, '17

'18, '19, and '20). During 2006 and 2007 enrollment lows, the U.S. unemployment rate was also remarkably low. In 2019, U.S. unemployment stayed low, below 4 percent for much of the year. U.S. unemployment remains below 4 percent as of November 2023;

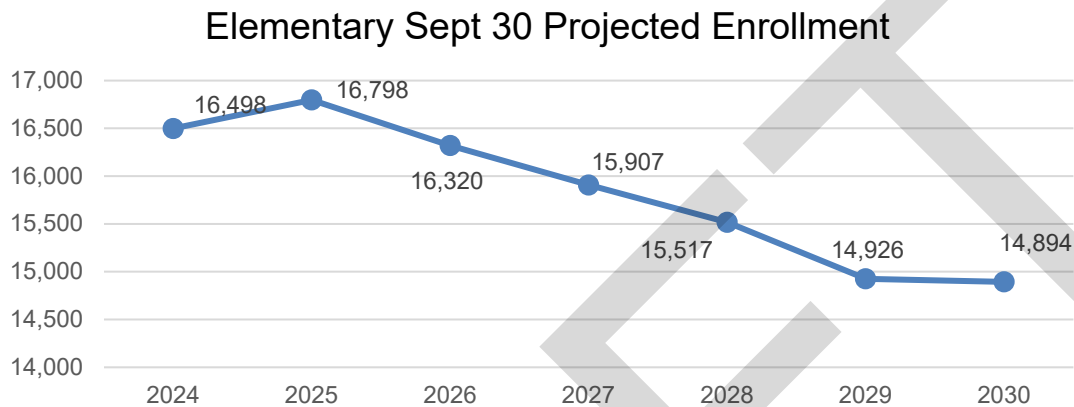
- **Alaska's Recession and Population:** Alaska's recession was thought to have ended in 2019, though the pandemic put it back into recession in 2020. While employment has recovered, economists see the last three years of slow employment growth as recovery toward pre-pandemic levels;
- **Anchorage's Aging Population:** Anchorage's population is aging, its population has been declining overall, and the population associated with school age children has been declining. Over the last decade, Anchorage School District's enrollment as a percentage of the Municipality of Anchorage's total population has been steadily declining. Outmigration as well as a declining share of the total population has been driving lower enrollments;
- **Correspondence Schools:** There has been an increasing trend of transfers from the ASD into statewide correspondence programs since the 2015–16 school year, and the PAIDEIA Cooperative school changed from a Charter program to an Alternative program in FY2018-19. Expansion of homeschooling options and interest as a result of the pandemic has shifted some students away from traditional education.

2024 to 2029 Enrollment Projections

Barring significant improvements in Alaska's economic landscape and/or a weakening U.S. employment picture, we expect moderate net student losses to continue into 2025 because of the negative and positive drivers detailed below:

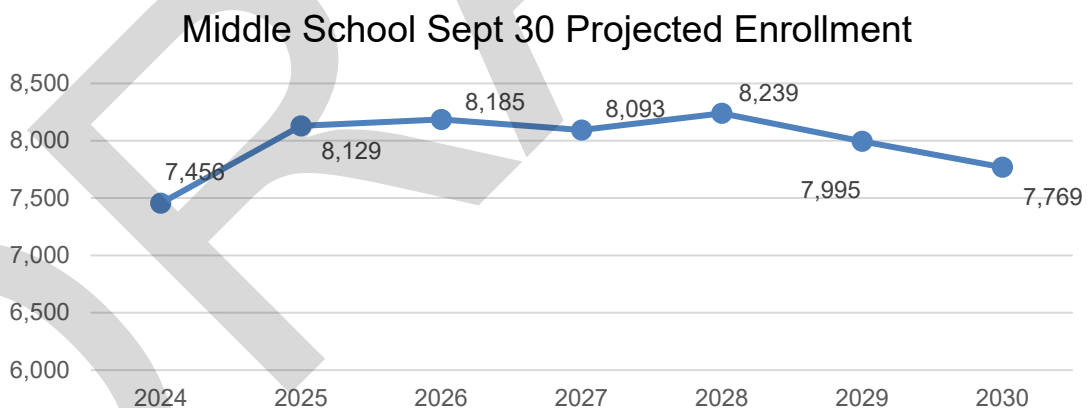
- annual declines in births, with 240 fewer 2025–26 qualifying births reported compared to 2024-25 figures;
- a general decline in past enrollment since the late 2000s;
- 419 fewer school age Anchorage PFD applications in 2024 than in 2023, and 413 fewer applicants that will become school age in the next one to four years;
- Anchorage's population loss due to out-migration, resulting in an estimated 2022 population that is 319 lower than it was in the 2022 and 1,433 lower than it was in the 2020 Census. Migration information for 2023-2024 is expected to be available in mid-January 2025, after publication of this document.

Elementary school estimates show an increase in 2025, followed by a gradual decline through 2030 (-11.3%), due to attrition. Enrollment is projected to experience a steeper decline than expected last year.



Note: Does not include alternative, charter, or special schools.

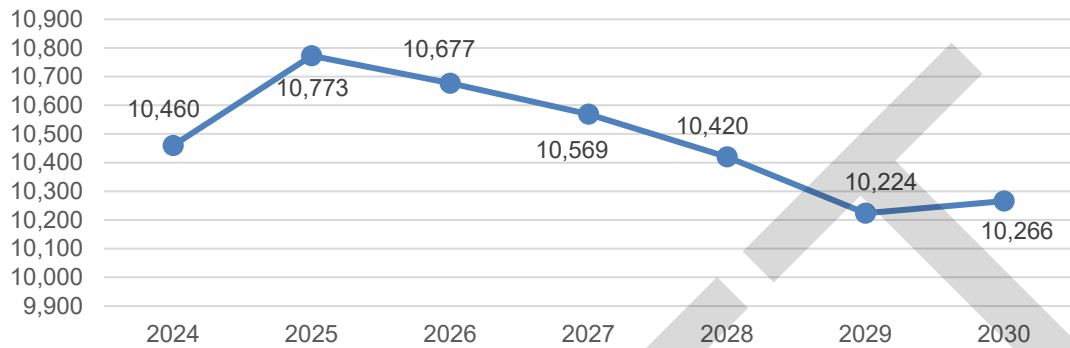
Middle school projections show an increase in 2025, followed by a period of stability through 2028 and then decline. Enrollment is projected to peak in 2028 (up 4.2% from 2024 levels) and then decline through 2030 (-5.7%), ending the period up about 300 students from 2024.

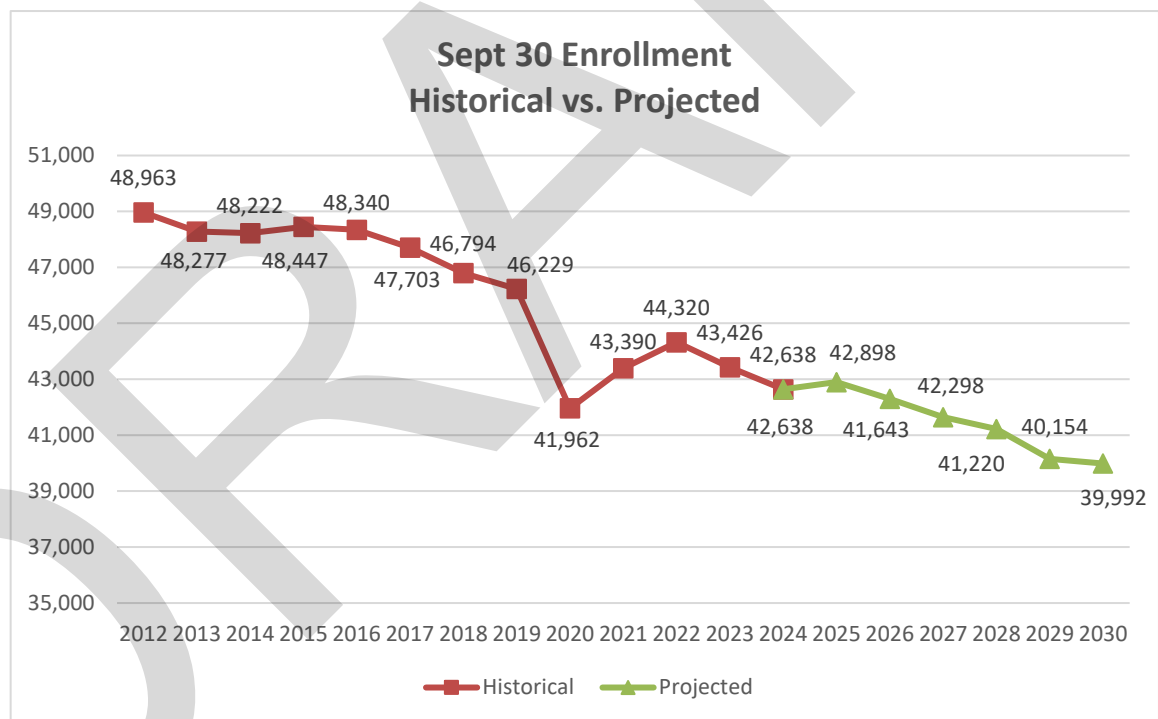
High schools are expected to see an increase in 2025, followed by a gradual decline through 2029 (-5.1%) before remaining steady.

The net effect across all grades is a gradual decline through the fall of 2030, averaging 1.1% each year.

Decreased enrollment in schools could drive decreased classroom and staff requirements for most grades over time, continuing the trend seen since 2012.

The enrollment projections are a base case that considers past student enrollment, birth data, and school age PFD applications. Overall employment in Anchorage has increased in each of the last three years, but June 2024 employment was almost 1,200 jobs (0.8%)

higher than it was in June 2013. It is still not fully known how the current economic climate will affect the school age population. The district will continue to monitor employment and enrollment trends, updating projections if a significant deviation from current trends begins to occur.

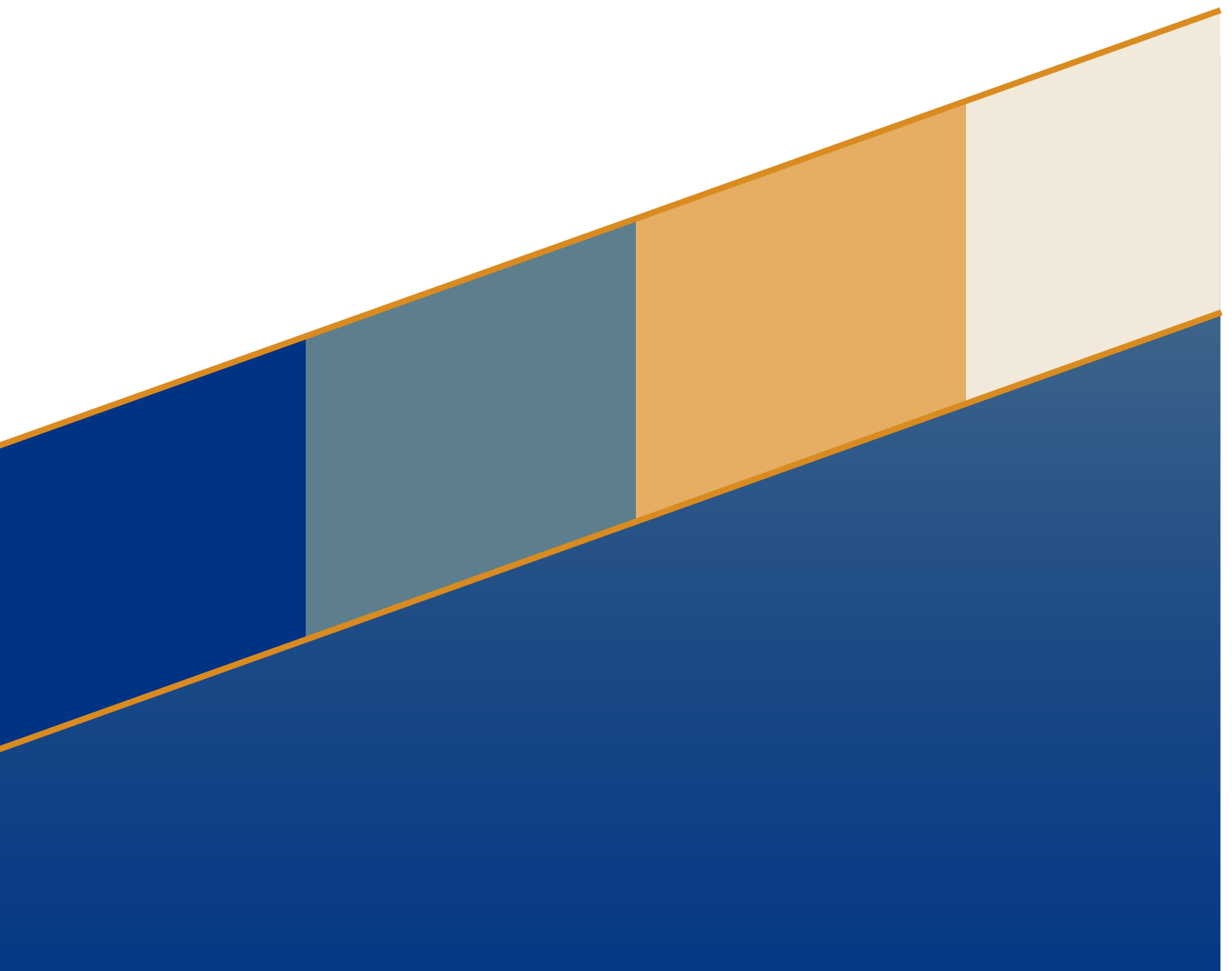

DEED Capacity: Alaska Department of Education & Early Development (DEED) calculates allowable space based on Anchorage's attendance area. Allowable space is calculated based on the total number of students/total gross square footage in the attendance area.

Program Capacity: The district utilizes Educational Specifications and Administrative "Guiding Principles" to determining the program capacity of each school. It considers all educational programs, maximum student occupancy, support requirements and schedule flexibility. Relocatables are not included in determining program capacities.

Facility Utilization: Annually, principals are surveyed to determine their school's utilization capacity to reflect how the school is "actually" utilizing their space to support their academic program. When comparing against program capacity, this survey provides the Administration a tool to determine efficient use of all ASD schools.

School Program Capacity Projections: Table 16 lists projected enrollments of all schools over the next six years, as a percentage of program capacity. Those schools at which the projected enrollment is greater than 100 percent are highlighted in bold print.

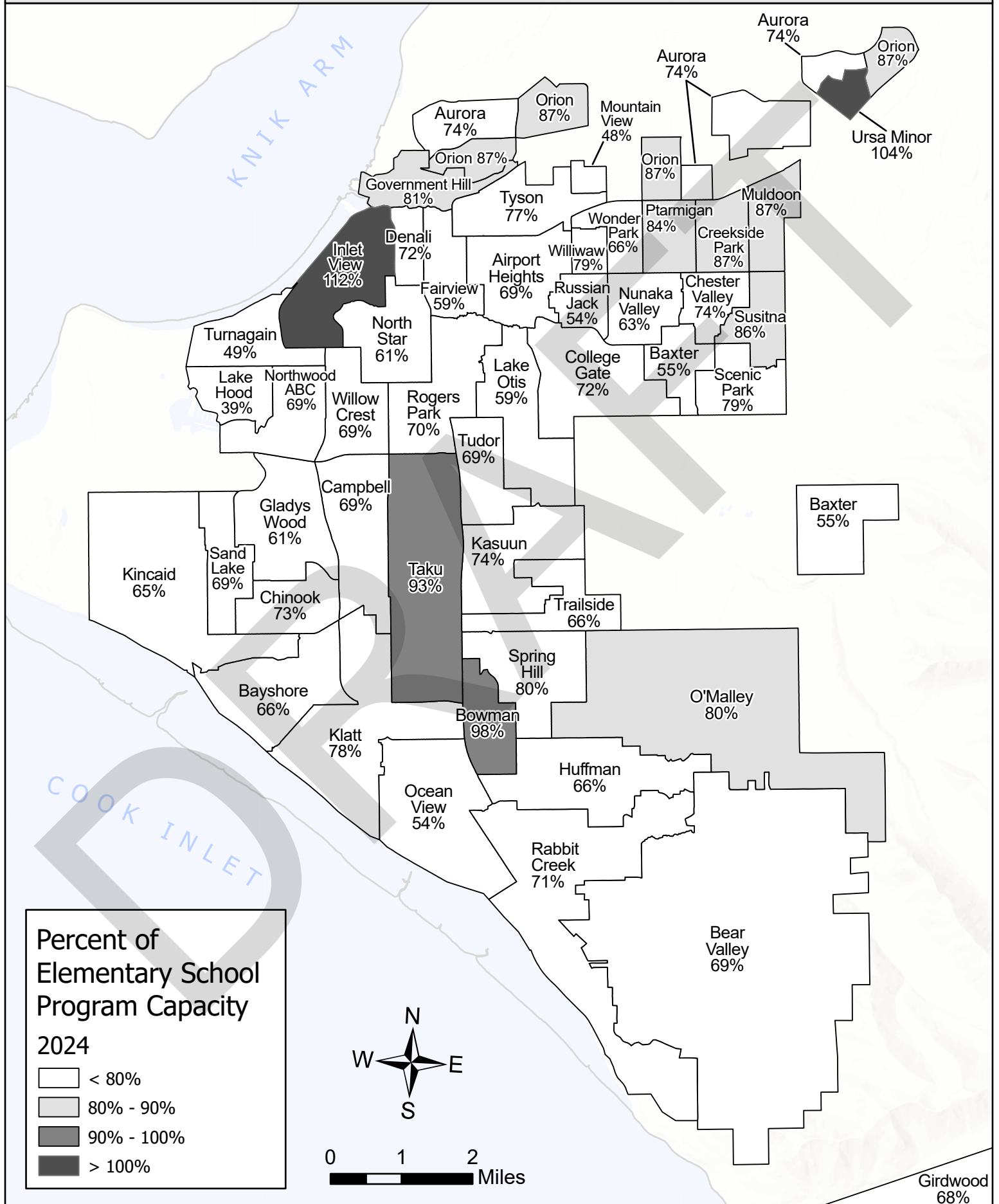

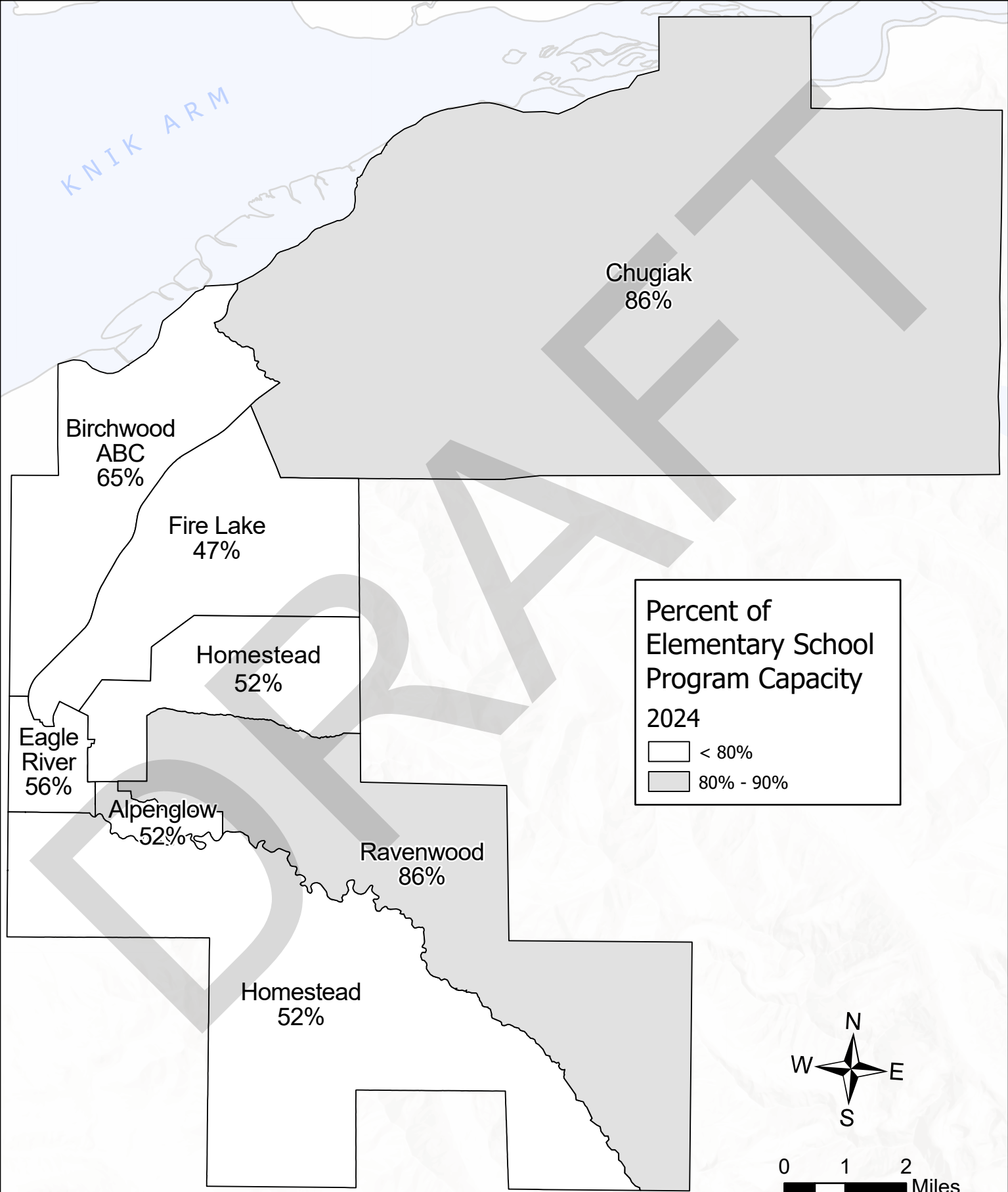

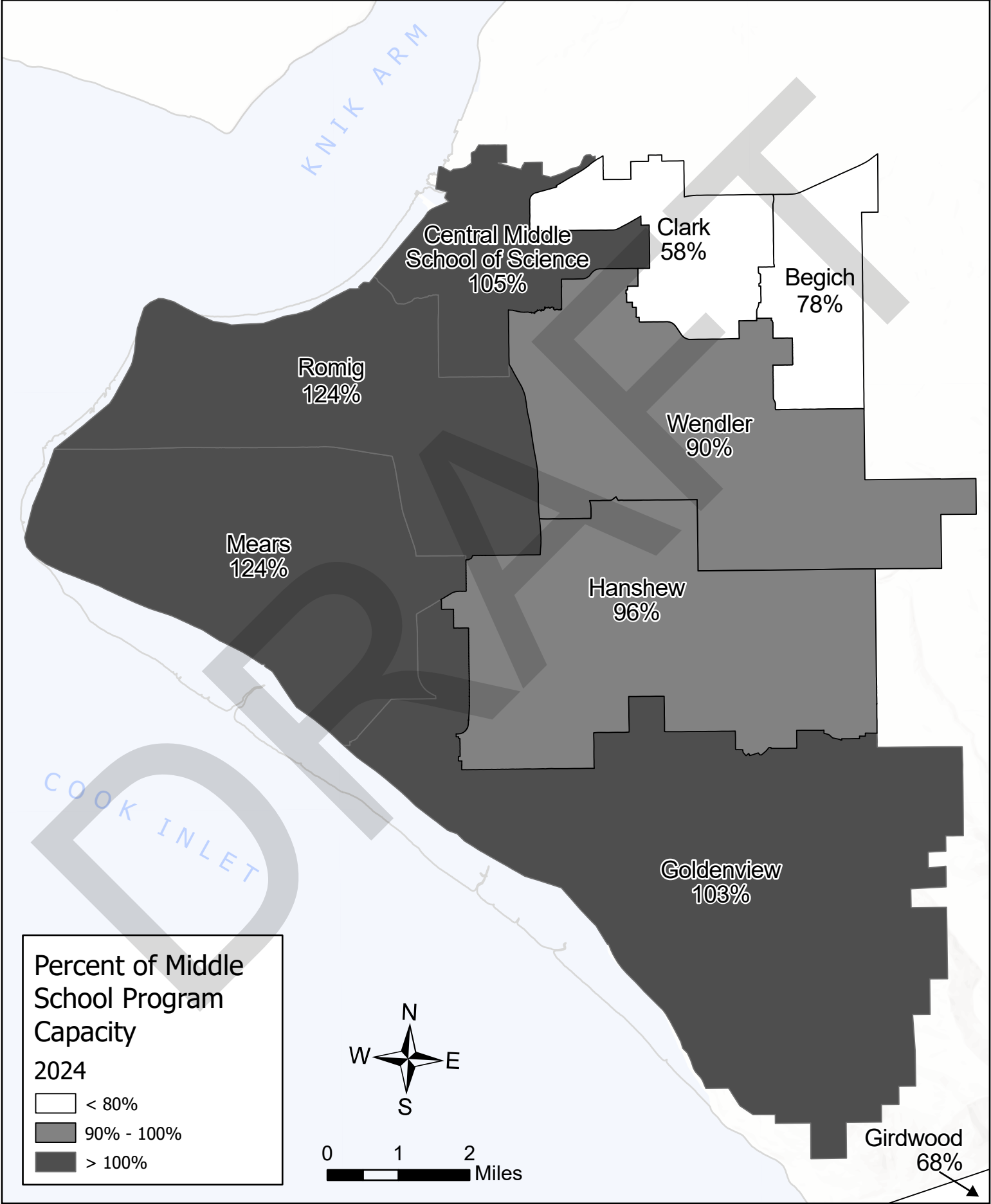
Anchorage School District 2024

Capacity by Attendance Area

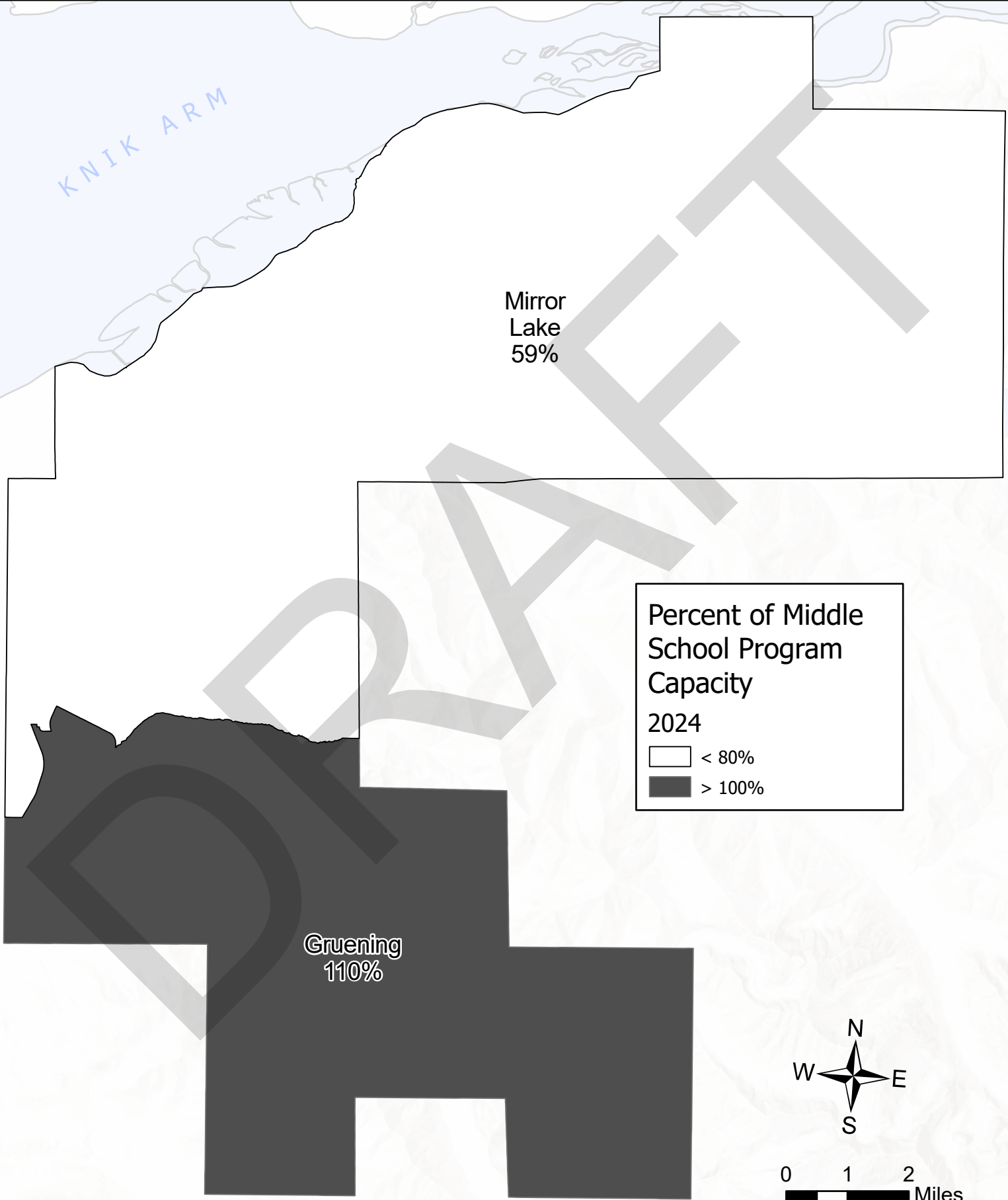

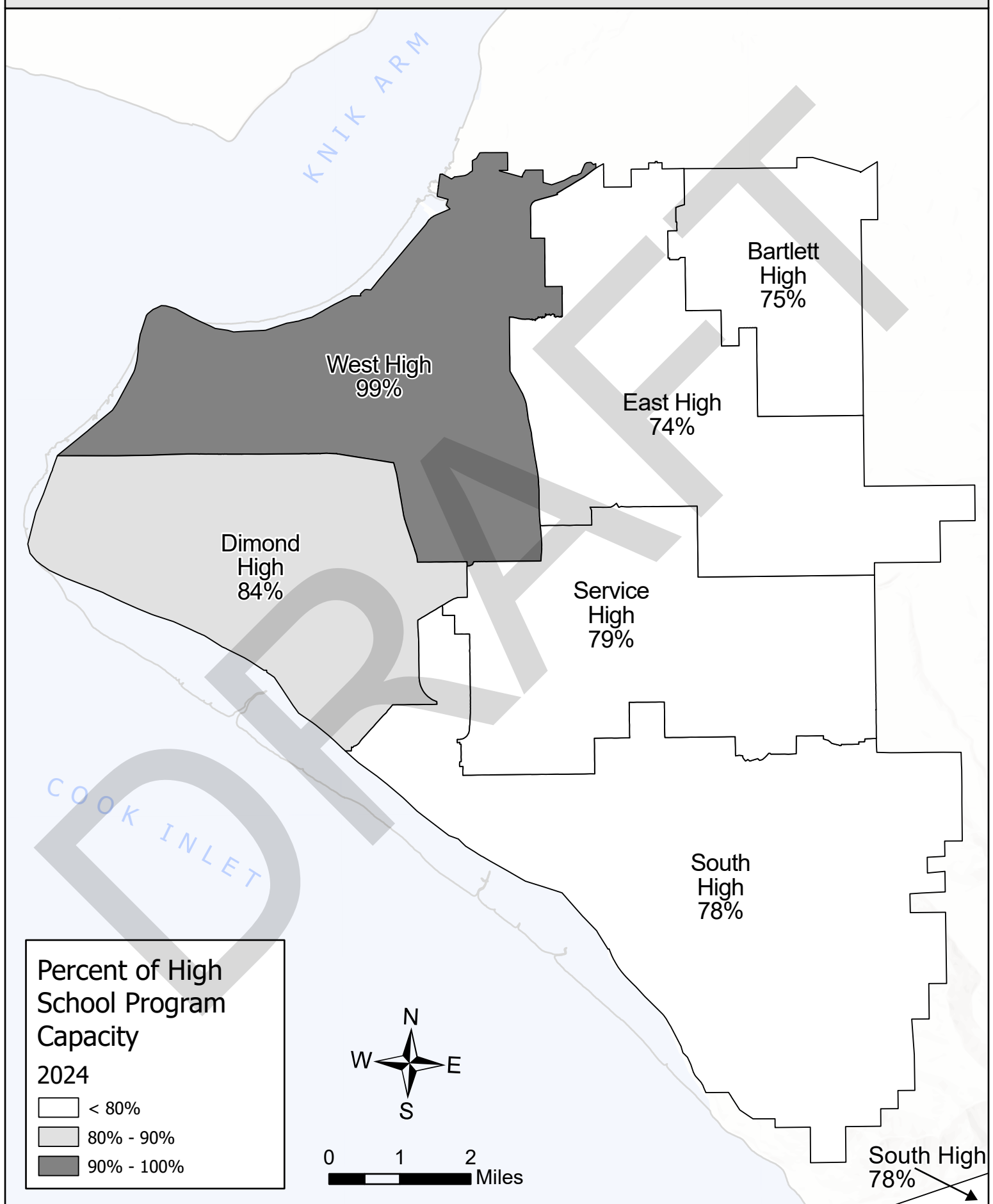
Middle School

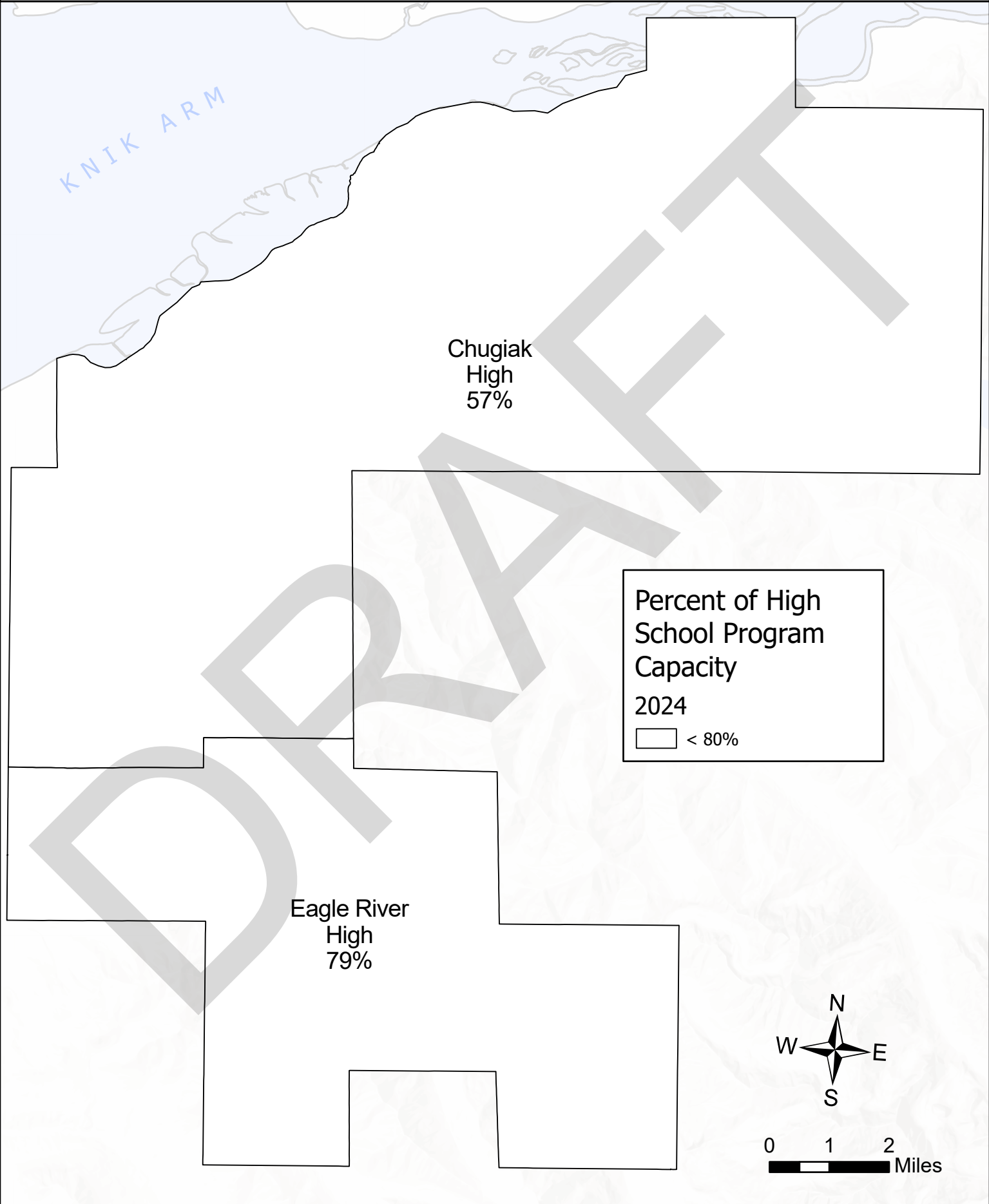
High School

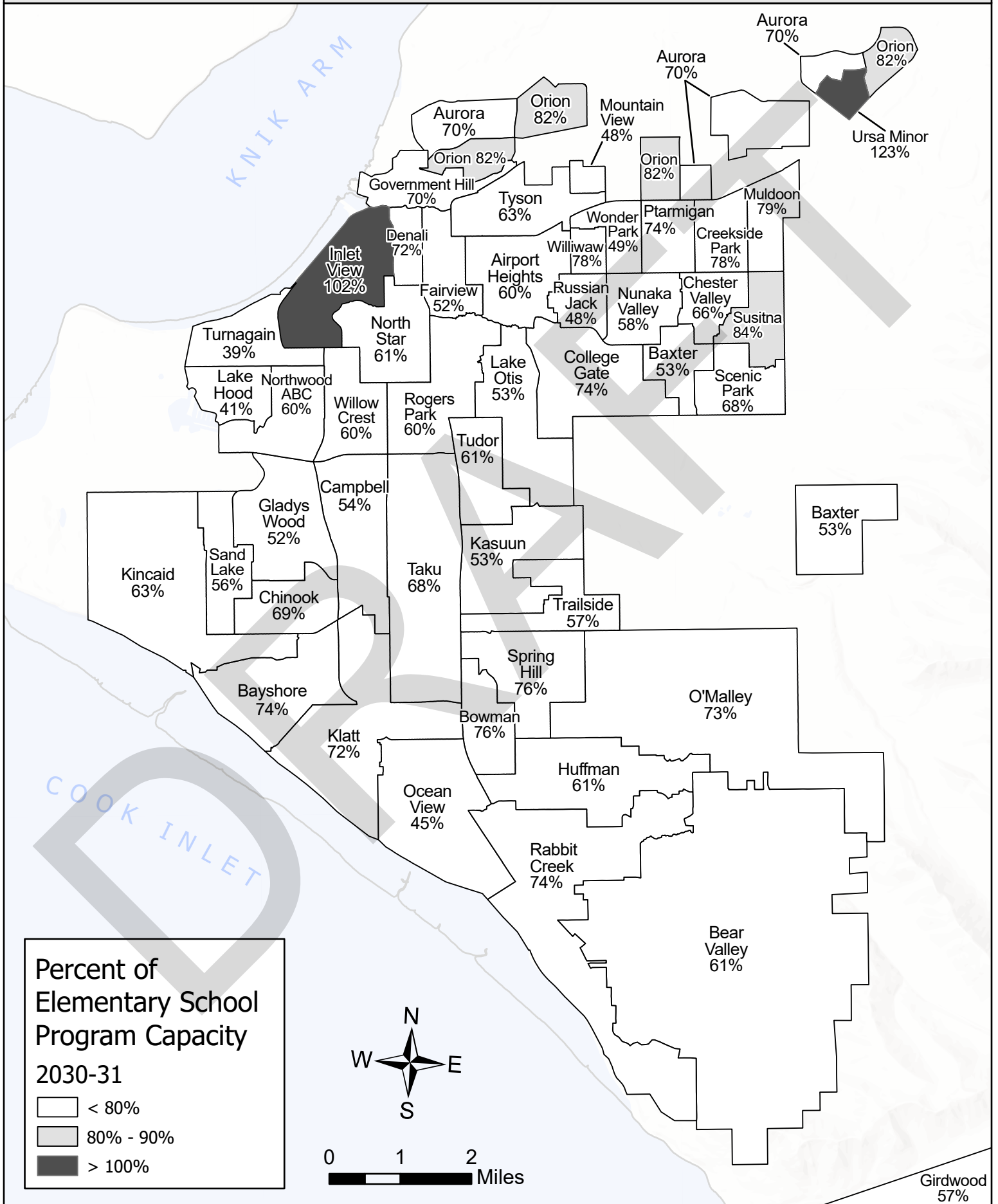

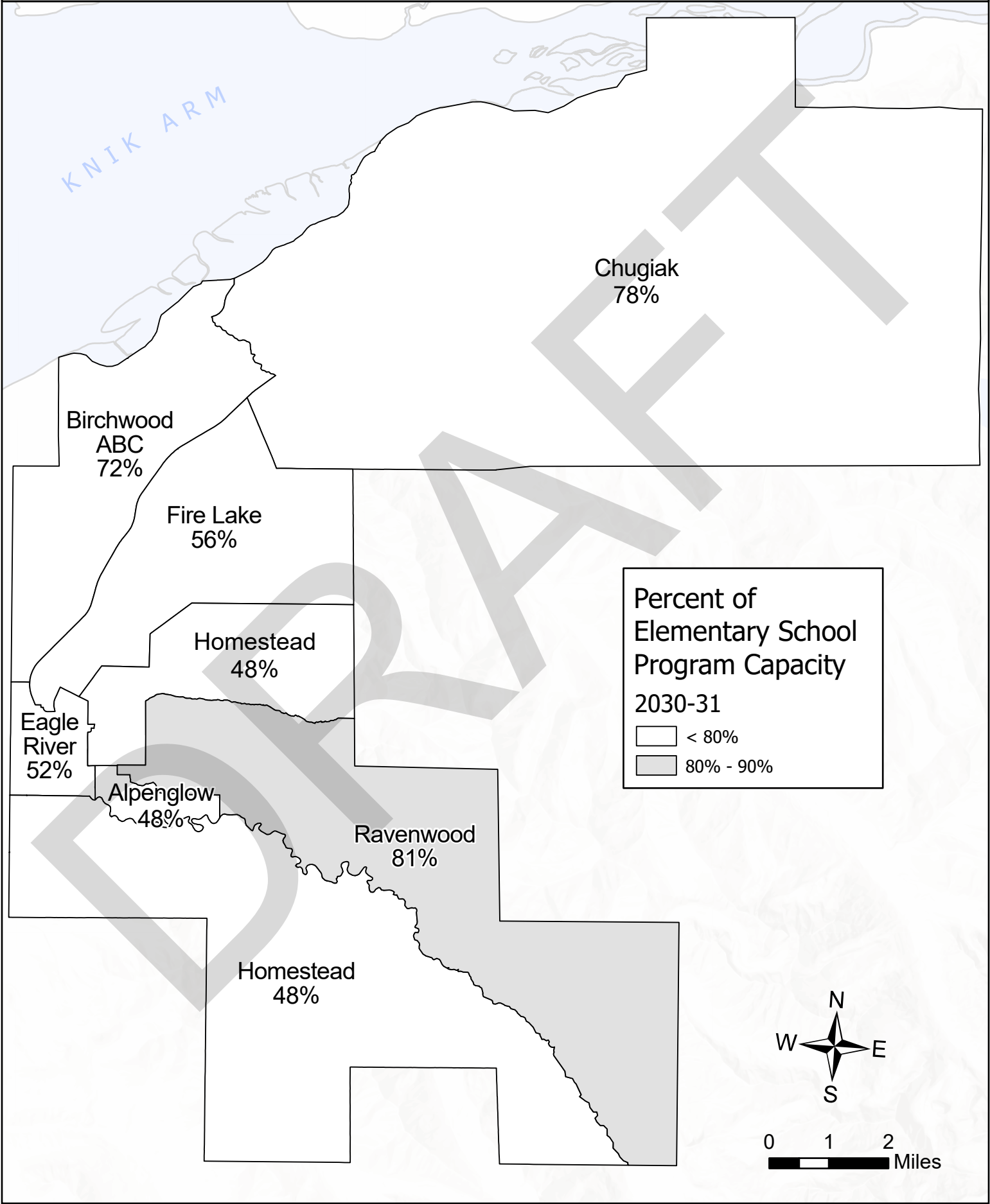
Elementary School Capacity by Attendance Area

Anchorage School District 2030-31



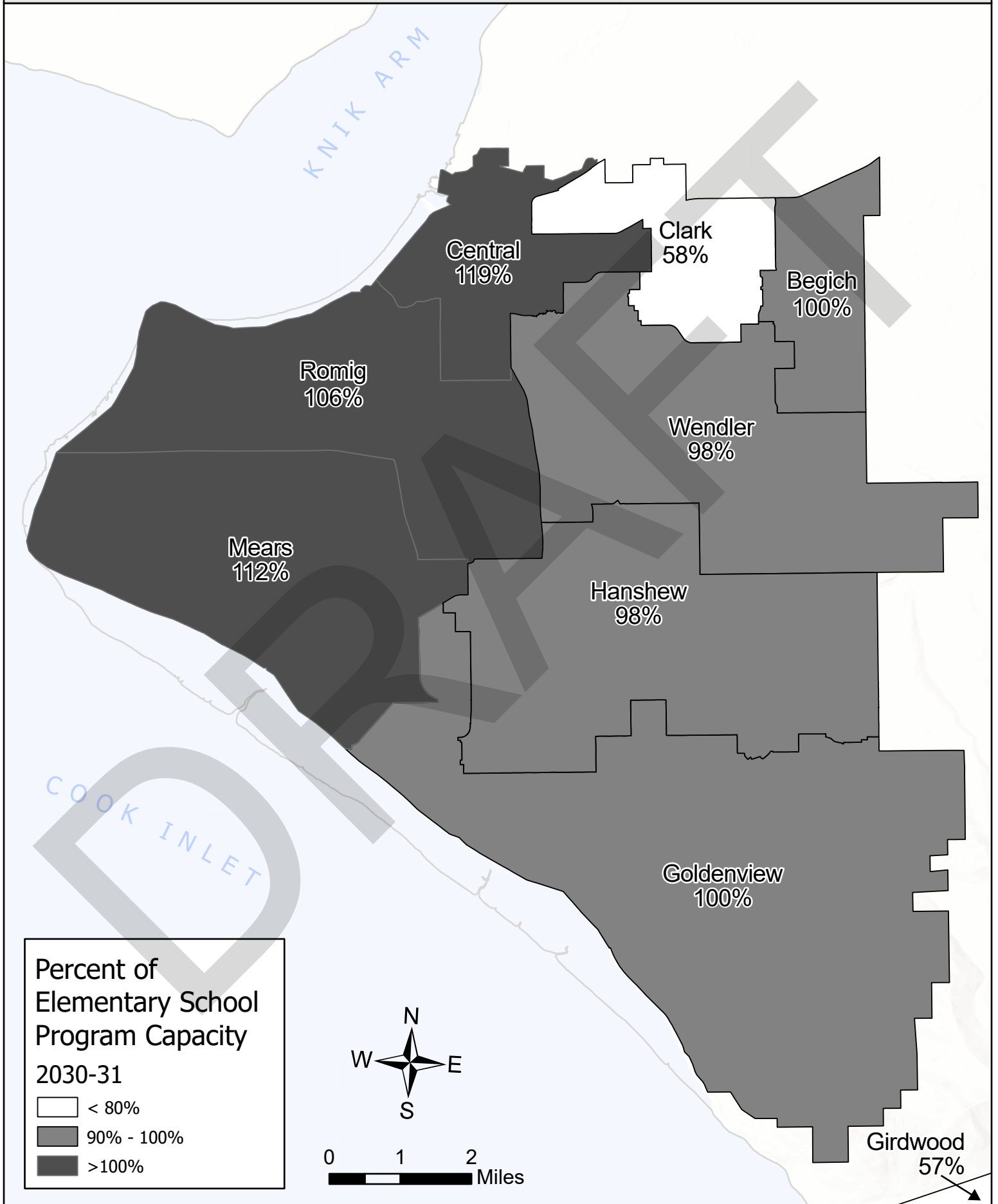

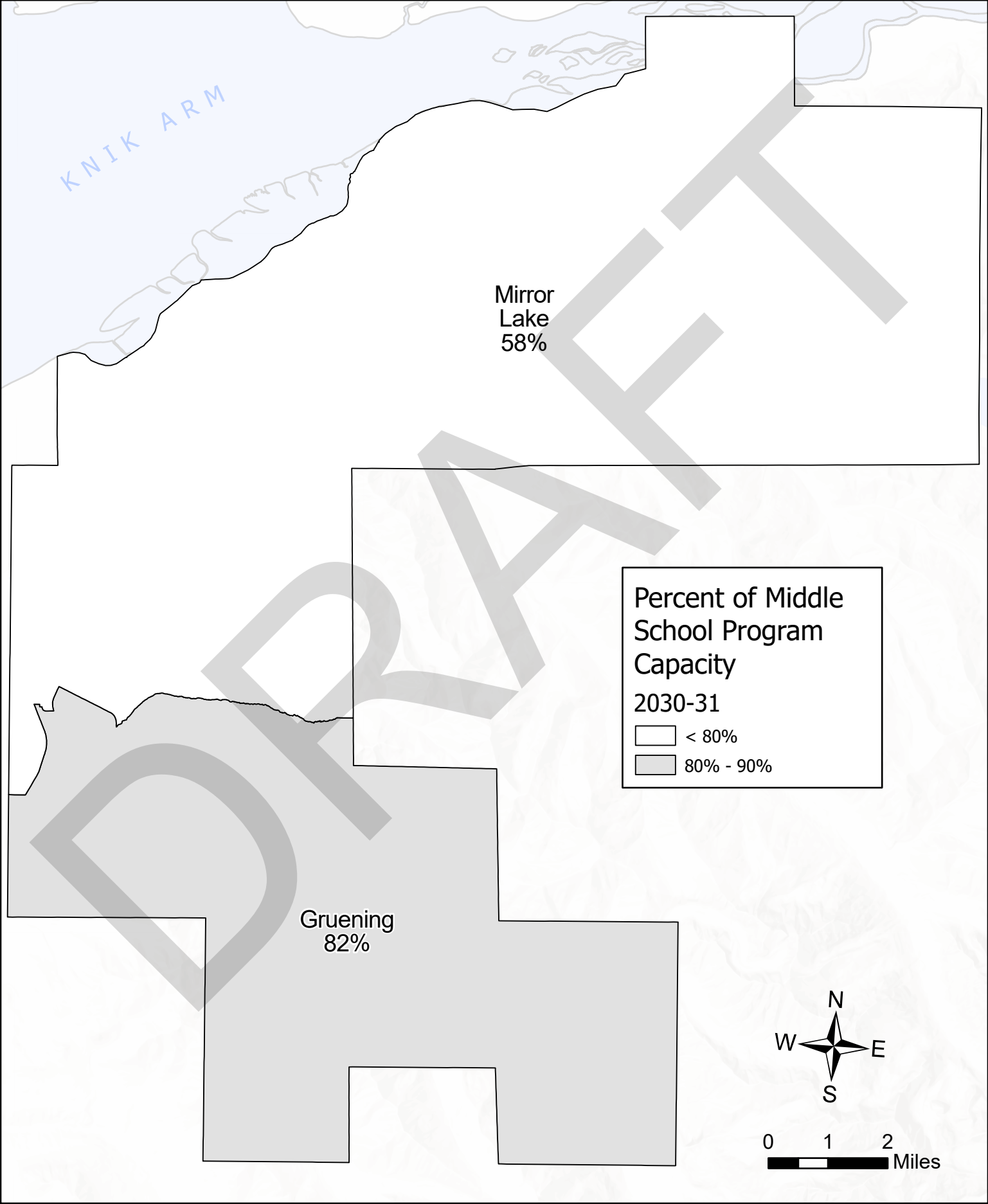
Middle School Capacity by Attendance Area

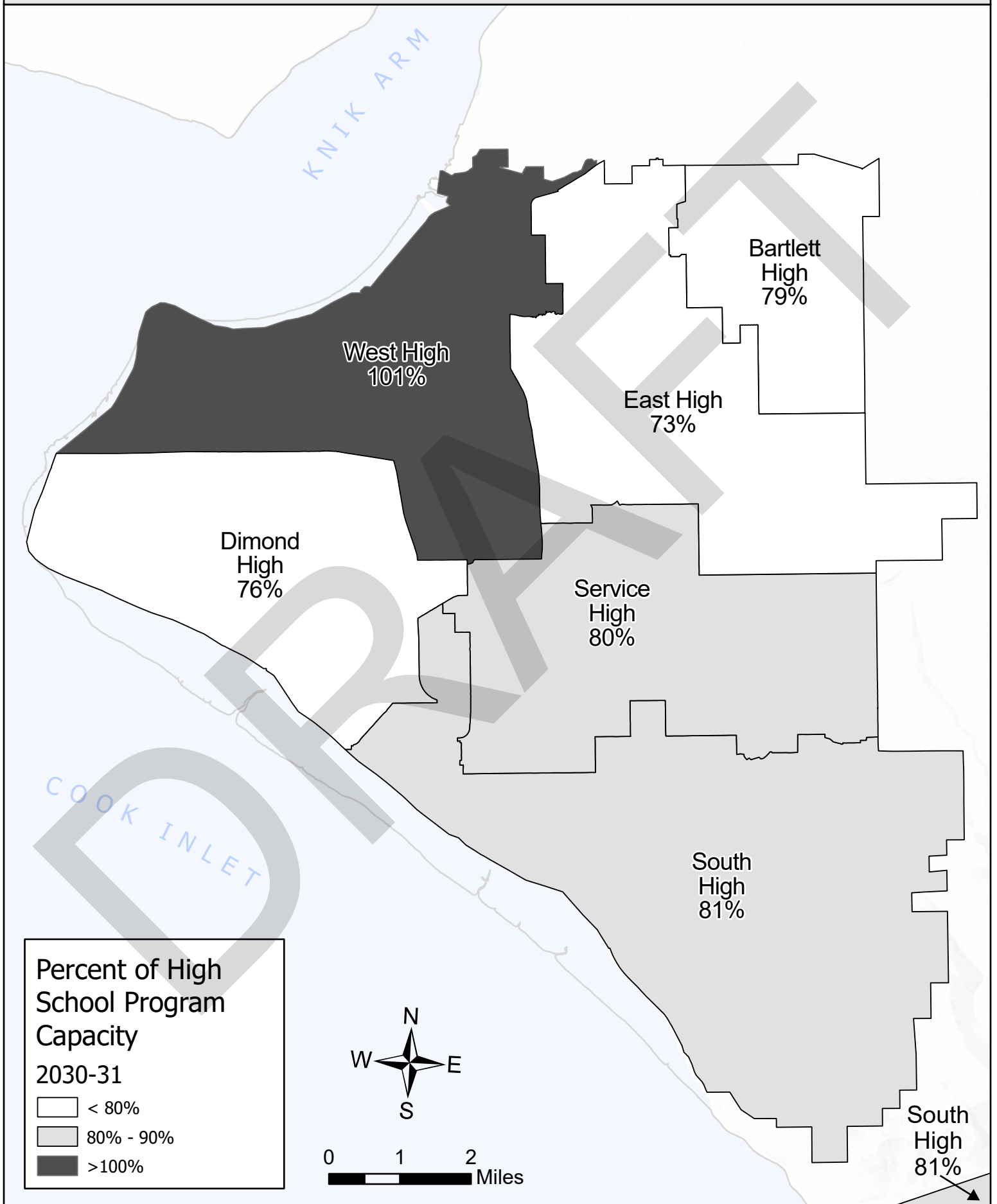

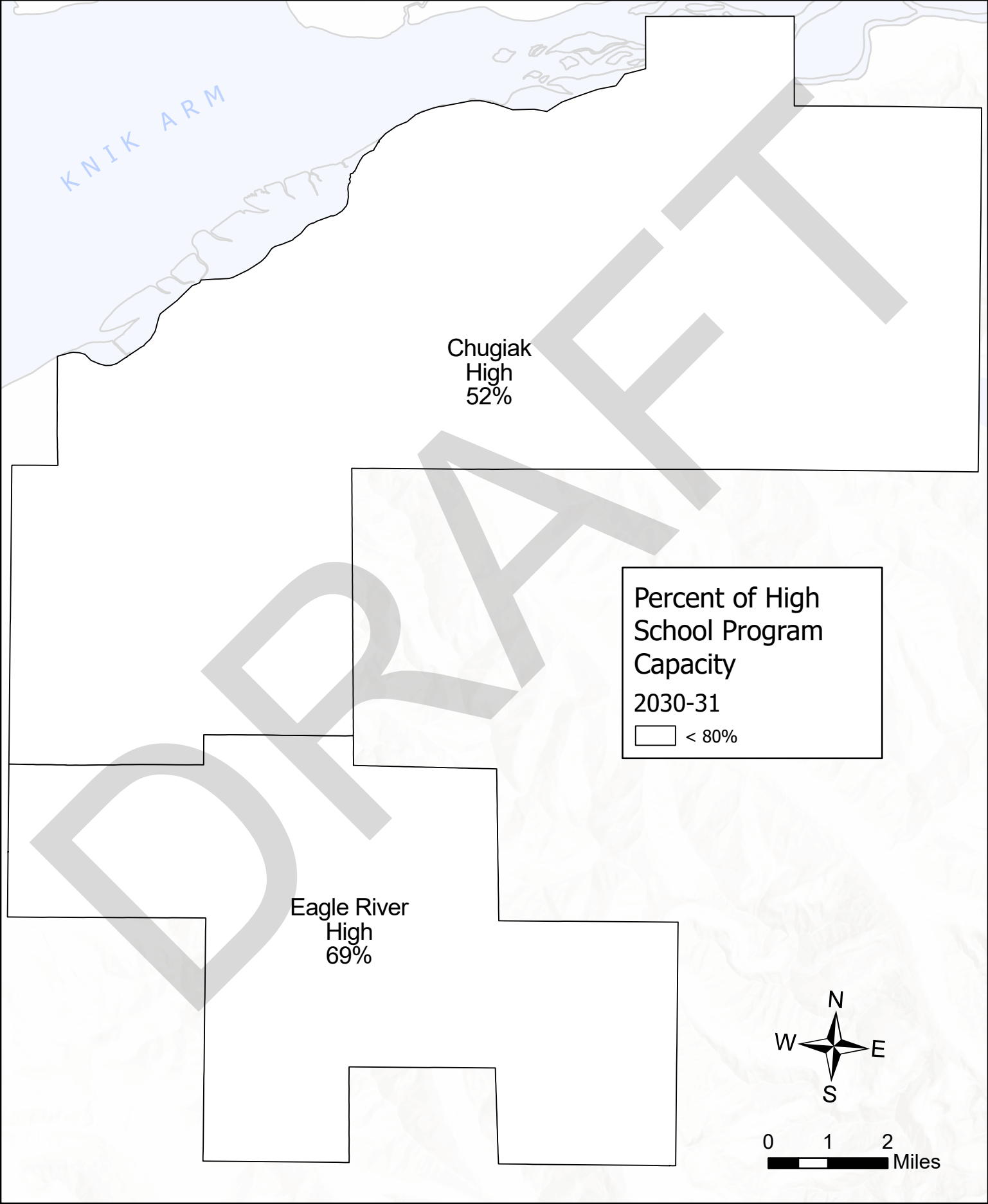
High School Capacity by Attendance Area

SUBJECT: SIX-YEAR CAPITAL IMPROVEMENT PLAN (CIP) PROJECT TABLES

ASD Core Value: *The District will be open, transparent & accountable to the public.*

RECOMMENDATION:

The Administration recommends that the School Board approve the attached Anchorage School District Six-Year Capital Improvement Plan Project Tables for July 1, 2025 to June 30, 2031.

PERTINENT FACTS:

The Administration is committed to providing safe, functional schools and facilities for students and employees. In accordance with School Board Policy 7100, the District updates the Six-Year CIP annually and includes capital improvement recommendations, membership and projections, current facility utilization, and other district facility information.

The capital improvement recommendations encompass a six-year period. The Administration is only submitting Project Table 1, Capital Improvement Plan, for approval.

Given continued forecasted enrollment declines, the Administration recommends that the Board approve the capital improvement plan for fiscal years 2025 through 2030 as presented. The 2030 planned projects, which are additive to this year's CIP, are informed by prioritizing infrastructure improvements that include Life, Safety & Emergencies, Facility Condition Improvements, Educational Improvements and Cost Savings. The final, approved CIP will be submitted to the Assembly for review by March 2025.

Pending the School Board's final decisions regarding the Rightsizing ASD initiative, the Administration offers the following recommendations:

- **Allocations focused on Secure Vestibules.** To enhance safety and security measures at ASD schools, allocations for secure vestibule upgrades continue at elementary schools throughout ASD for 2025.
- **Allocations for Intrusion System Replacements.** Facility Commander Intrusion Systems will become unsupported in October 2026. These old systems will be replaced with the ASD Standard Gemini C system.
- **Allocations for Access Controls.** To enhance safety and security measures at ASD schools, allocations for access control installations continue at schools throughout ASD for 2025 and 2026.
- **Deferred Requirement Projects at Spring Hill, Bear Valley, Lake Otis, Campbell, Benny Benson, Bowman, Williwaw, Chugiak elementary, SAVE, King Tech High School, Orion, Ravenwood and Mears.** The Administration recommends these capital investments over the six-year period to upgrade and/or replace multiple building systems at these facilities.
- **Roof and structural upgrades at 1990 Prototypical Schools.** To complete roof and structural issues at the remaining 1990 prototypical schools.
- **Construction for Romig and Bartlett.** The Administration recommends these capital investments over the six-year period due to emergent facility requirements.
- **Demolition of Abbott Loop Elementary.** At the direction of the School Board per ASD Memorandums #094 and #132 (2022-2023), the Alaska Native Cultural Charter School was approved to occupy the prior Abbott Loop Elementary School building no later than the end of the FY29 school year due to facility without a fire suppression system. The Administration recommends to forecast demolition funding for this project.

Years 2 through 6 include renovation projects at 2 secondary schools. Allocations are also included for Deferred Requirement Projects and Security Projects to address current backlog and growing facility sustainment needs.

Deferred Requirement Projects address emergent deficiencies and include replacement of systems to include structural, roofs, lighting, fire alarms, communications, mechanical systems, and site improvements at District facilities. These projects extend the life of existing facilities systems and will improve seismic performance.

Security projects address entryway security and safety improvements to vestibules, relocation of administration areas closer to main entryways, and main entry security upgrades.

The Capital Planning & Construction Department staff developed project costs utilizing the Department of Education and Early Development cost models and historical data from recently completed District projects of similar scope. They include a 7% per annum allowance for construction escalation to reflect the current trends in the market. Estimated project costs listed in Years 2 through 6 will be adjusted as planning & design efforts develop.

The total cost of projects over the six-year period included in this plan is \$332,635,000. The Administration anticipates retiring \$162,710,000 over this period for a projected net debt increase of \$169,925,000.

The Capital Planning & Construction Department staff is anticipated to present the draft CIP to the Municipal Planning and Zoning Commission (P&ZC) in January 2025.

The P&ZC's final resolution will be provided to the District and attached to the CIP for submission to the Anchorage Municipal Assembly no later than their last regular meeting in March 2025.
