

Dear Assembly Members:

Host International, Inc. ("Host"), a food and beverage concessionaire, currently holds Beverage Dispensary Tourism License #4988 to sell alcoholic beverages at Norton Sound Seafood House located on Concourse C at Anchorage International Airport (the "Airport").

Host opened Norton Sound Seafood House ("Norton Sound") in November 2010. Widely known for their locally caught, fresh seafood, Norton Sound brings a true Alaskan experience to passengers traveling through the Airport.

In order to increase tourism, as well as handle the constant influx of delayed passengers and airport workers through the Airport, Host would like to expand the licensed premise of Norton Sound to provide additional pre-security seating for its patrons.

We hereby request that the Assembly grant us approval to add an additional 236 square feet to the existing premise, to include 24 additional seats. No other changes will be made to Norton Sound.

We appreciate the Assembly considering our request for this premise extension.
