

13 THE ANCHORAGE ASSEMBLY RESOLVES:

15 **Section 1.** A conditional use permit is hereby approved for a duplicate beverage
16 dispensary tourism use and license number 5320, in the T (transition) district for
17 HMS Host International, Inc., dba Norton Sound Seafood House; at 5000 West
18 International Airport Road, Room C2052, within Ted Stevens International Airport,
19 South Terminal, Sec 34, T13N, R4W, S.M.; generally located south of West
20 International Airport Road. This conditional use generally meets the applicable
21 provisions of AMC 10.50, AMC 21.15.030, AMC 21.40.240D.5., AMC 21.50.020
22 and AMC 21.50.160.

24 **Section 2.** This conditional use is approved subject to the following conditions:

26 1. A notice of zoning action shall be filed with the State of Alaska Recorder's
27 Office within 120 days of the Assembly's approval for this duplicate
28 beverage dispensary tourism license.

30 2. All uses shall conform to the plans and narrative submitted with this
31 conditional use application, except that the licensee may change the hours
32 of operation listed on the application in accordance with all applicable laws
33 without having to modify the conditional use.

35 3. This alcoholic beverages conditional use approval is for a duplicate
36 beverage dispensary tourism use and license number 5320 in the
37 T (transition) district in accordance with AMC 10.50, AMC 21.15.030,
38 AMC 21.40.240D.5., AMC 21.50.020 and AMC 21.50.160, for 1,000 square
39 feet of gross leasable floor area outside of security at 5000 West

- 4. On-premise sale of alcoholic beverages may be seven days a week as permitted per Anchorage Municipal Code 10.50.015C. and Alaska Alcoholic Beverage Control Board requirements.
- 5. Servers will be trained in accordance with the Alcoholic Beverage Controls Board’s “Liquor Server Awareness Training Program,” as described in AS 4.21.025A. Upon demand, the applicant shall demonstrate compliance with a “Liquor Server Awareness Training Program” approved by the State of Alaska Alcoholic Beverage Control Board, such as or similar to the program for “Techniques in Alcohol Management (T.A.M.).”
- 6. The use of the property by any person for the permitted purposes shall comply with all current and future federal, state and local laws and regulations including but not limited to laws and regulations pertaining to the sale, dispensing, service and consumption of alcoholic beverages and the storage, preparation, sale, service and consumption of food. The owner of the property, the licensee under the Alcoholic Beverage Control license and their officers, agents and employees shall not knowingly permit or negligently fail to prevent the occurrence of illegal activity on the property.
- 7. A copy of the conditions imposed by the Assembly in connection with this conditional use approval shall be maintained on the premise at a location visible to the public.

Section 3. Failure to comply with the conditions of this conditional use permit shall constitute grounds for its modification or revocation.

Section 4. This resolution shall become effective immediately upon passage and approval by the Anchorage Assembly.
