

16 **Section 1.** An alcoholic beverages conditional use permit is hereby approved
17 for beverage dispensary-tourism license number 5469 for Host International, Inc.,
18 dba Sleeping Lady Airport Lounge; in the T (transition) district; at 5000 West
19 International Airport Road, on Level 3 Mezzanine of the Ted Stevens Anchorage
20 International Airport, South Terminal, within Section 34, T13N, R4W, S.M.,
21 Alaska; generally located south of West International Airport Road, in Anchorage.
22 This conditional use permit generally meets the applicable provisions of
23 Anchorage Municipal Code (AMC) chapter 10.50, AMC (old code)
24 section 21.15.030, AMC (old code) subsection 21.40.240D.5., AMC (old code)
25 section 21.50.020, and AMC (old code) section 21.50.160.

26
27 **Section 2.** This conditional use permit is approved subject to the following
28 conditions:

- 29
30 1. A notice of zoning action shall be filed with the State of Alaska Recorder's
31 Office within 120 days of the Assembly's approval for this beverage
32 dispensary-tourism license.
33
34 2. All uses shall conform to the plans and narrative submitted with this
35 conditional use application, except that the licensee may change the hours
36 of operation listed on the application in accordance with all applicable laws
37 without having to modify the conditional use.

39 3. This alcoholic beverages conditional use approval is for a beverage
40 dispensary-tourism use and license number 5469 in the T (transition)
41 district in accordance with AMC chapter 10.50, AMC (old code) section
42 21.15.030, AMC (old code) section 21.50.020, and AMC (old code)
43 section 21.50.160, for 2,000 square feet of gross leasable floor area inside

of security at 5000 West International Airport Road, on Level 3 Mezzanine, within Ted Stevens International Airport, South Terminal, Sec. 34, T13N, R4W, S.M., Alaska.

- 4. On-premise sale of alcoholic beverages may be seven days a week as permitted by AMC section 10.50.010 and Alaska Alcoholic Beverage Control Board requirements.
- 5. Servers will be trained in accordance with the Alcoholic Beverage Control Board's "Liquor Server Awareness Training Program," as described in Alaska Statute 04.21.025. Upon demand, the applicant shall demonstrate compliance with a liquor "Server Awareness Training Program" approved by the State of Alaska Alcoholic Beverage Control Board, such as or similar to, the program for "Techniques in Alcohol Management (T.A.M.)."
- 6. The use of the property by any person for the permitted purposes shall comply with all current and future federal, state and local laws and regulations including but not limited to laws and regulations pertaining to the sale, dispensing, service and consumption of alcoholic beverages and the storage, preparation, sale, service and consumption of food. The owner of the property, the licensee under the Alcoholic Beverage Control license and their officers, agents and employees shall not knowingly permit or negligently fail to prevent the occurrence of illegal activity on the property.
- 7. A copy of the conditions imposed by the Assembly in connection with this conditional use approval shall be maintained on the premise at a location visible to the public.

Section 3. Failure to comply with the conditions of this conditional use permit shall constitute grounds for its modification or revocation.

Section 4. This resolution shall become effective immediately upon passage and approval by the Anchorage Assembly.

12 OF WEST INTERNATIONAL AIRPORT ROAD, IN ANCHORAGE.

14 Host International, Inc., dba Sleeping Lady Airport Lounge, has made application for
15 an alcohol conditional use permit for retail sales of alcoholic beverages-tourism
16 license 5469 in the T (Transition) district. The petition site contains 2,000 square
17 feet of gross leasable floor area inside of security at the Ted Stevens International
18 Airport's south terminal.

19
20 On-premise sale of alcoholic beverages may be seven days a week as permitted
21 per Anchorage Municipal Code 10.50.010 and Alaska Alcoholic Beverage Control
22 Board requirements.

23
24 All servers of alcoholic beverages will be trained in accordance with the Alcoholic
25 Beverage Control Board's Liquor Server Awareness Training Program.

26
27 Within 1,000 feet of this application there are nine beverage dispensary tourism and
28 one package store alcoholic beverages licenses. There are no schools or churches
29 within 200 feet of this site.

30
31 On May 3, 2016, 237 public hearing notices were mailed. To date, there have been
32 no responses received from the public. Comments have not been received from the
33 Sand Lake or Spenard Community Councils.

34
35 The Anchorage Police Department reports a limited number of incidents at this
36 location, but there is no indication that these incidents were alcohol related.
