



III. Other Office Updates

<u>Staff Meetings.</u> City Hall Building management did repairs from the 8th floor down to the 1st floor at their cost over the three months after the earthquake and we have recently had the majority of the damage to the drywall in our office repaired. We are awaiting an update to our expressed concern that the Dena'ina Center is not the ideal evacuation site in a large earthquake emergency and for information about what kind of review and updating to the City Hall emergency evacuation plan is going to be undertaken by the MOA.





The Japanese American Day of Remembrance event commemorated the anniversary of President Franklin Roosevelt signing Executive Order 9066 on February 19, 1942. The executive order allowed the internment of over 100,000 Japanese Americans, and is considered one of the most egregious civil liberties violations in American history. The event focused on the story of Chiune Sugihara, the Japanese Vice-Counsel in Lithuania, who issued thousands of visas to Jewish refugees, saving them from certain death. Although punished by his government, his reputation in Japan was eventually rehabilitated, and the Israeli movement declared him to be "Righteous Among the Nations". This event was held at the Wilda Marston Theatre on Tuesday, February 19th, from 6:00 p.m. -8:00 p.m.

Meet the World: Commissioner Hess staffed the Welcoming Anchorage table, Commissioner Minaei staffed the Persian table, and Commissioner Olmos staffed the Mexican table at the "Meet the World" event. All three Commissioners helped staff the AERC table and provided information to the public regarding AERC services. The "Meet the World" event brings together multiple cultural communities in Anchorage, and provides an opportunity for them to share their cultures and interact with and educate the public. This was the first year that Identity, PFLAG, the Islamic Community Center of Alaska, and Congregation Beth Shalom participated in the event. This event was held at the Egan Center on Saturday, February 23rd, from 11:30 a.m. -4:30 p.m.
