NOTICE OF VACANCIES**

Notice is hereby given that the following offices will be filled at the Regular Municipal Election on APRIL 1, 2025. The period in which to file a declaration of candidacy will open JANUARY 10, 2025, at 8:00 a.m. and will close JANUARY 24, 2025, at 5:00 p.m. Candidate filing forms are available online at www.muni.org/elections. Forms are also available at the Municipal Clerk's Office, City Hall, 632 W. 6th Avenue, Suite 250, Anchorage, Alaska 99501 (9:00 a.m. to 3:00 p.m. Tuesday-Friday) and at the MOA Election Center, 619 E. Ship Creek Avenue, Door D Entrance, Anchorage, Alaska 99501 (8:00 a.m. to 5:00 p.m. Monday-Friday).

On JANUARY 9, 2025, at 1:00 p.m. at the Election Center (619 E. Ship Creek Avenue, Door D), the public is invited to witness the random drawing of letters of the alphabet, which will determine the order candidates' names will appear on the 2025 Regular Municipal Election ballot.

The Municipal Clerk's Office believes in the importance of voting in local elections because these decisions have a direct impact on the community and its quality of life. While national and state elections often draw more attention, local elections determine key issues such as public services, schools, infrastructure, and community resources—matters that influence neighborhoods, streets, and daily routines. Local elections decide leadership positions for the Assembly, School Board, and Service Area Board of Supervisors and play a vital role in bond measures. Participating in local elections gives voters the opportunity to shape policies and elect leaders who represent their values.

The Regular Municipal Election on APRIL 1, 2025, is a Vote at Home election. Our Vote at Home system is designed to allow voters to vote in the way that works best for them, meeting the needs of voters who may face barriers to traditional in-person voting, such as those who are elderly, disabled, or work long hours in essential fields. It also supports voters stationed out of state, such as college students or military personnel.

Ballots are mailed to voters at least 21 days before Election Day, giving voters time to research candidates and propositions to make informed decisions. Completed ballots can be returned to one of 18 secure drop boxes, an Anchorage Vote Center, or by mail with first-class postage.

To vote in a Municipal Election, you must be registered to vote. It is imperative to update your voter registration with the State of Alaska, Division of Elections to reflect where you currently reside. The deadline for voter registration, including updates, for the upcoming Regular Municipal Election is SUNDAY, MARCH 2, 2025. Make sure your vote counts by updating your voter registration so that you receive the correct ballot in the mail for your current residence address.

A candidate elected on APRIL 1, 2025, will be elected to a three-year term expiring upon certification of the Regular Municipal Election in April 2028, unless otherwise noted.

A candidate for a school board seat listed above must be a qualified voter of the Municipality of Anchorage and of the State of Alaska. Election is areawide.

SERVICE AREAS

A candidate for a service area board seat listed below must be a qualified voter of the Municipality of Anchorage and of the State of Alaska and shall have been a resident of the stated service area for at least three (3) months immediately preceding this election. Write in candidates must register with the Municipal Clerk at least seven (7) days before the election. If no candidate files, the vacancy may be filled by Mayoral appointment upon confirmation by the Assembly. Election is by service area.
