**MUNICIPALITY OF ANCHORAGE
AO No. 2025-15**

1 **AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE QUALIFIED**
2 **VOTERS OF THE MUNICIPALITY OF ANCHORAGE, ALASKA, THE QUESTION**
3 **OF THE ISSUANCE OF NOT TO EXCEED THREE MILLION DOLLARS**
4 **(\$3,000,000) OF GENERAL OBLIGATION BONDS OF THE MUNICIPALITY OF**
5 **ANCHORAGE TO PAY THE COSTS OF ROAD SAFETY IMPROVEMENTS IN**
6 **THE GIRDWOOD VALLEY SERVICE AREA AT THE ELECTION TO BE HELD IN**
7 **THE MUNICIPALITY ON APRIL 1, 2025.**

8
9 **WHEREAS**, the best interest of the citizens and property owners in Girdwood Valley
10 Service Area and the Municipality of Anchorage, Alaska (the "Municipality") require
11 the Municipality to construct road safety improvements (the "Projects"); and
12

13 **WHEREAS**, in order to provide financing for the Projects, it is deemed necessary
14 and advisable that the Municipality issue and sell its general obligation bonds in the
15 principal amount of not to exceed \$3,000,000 (the "Bonds"); now, therefore,
16

17 **THE ANCHORAGE ASSEMBLY ORDAINS:**

18
19 **Section 1. Purpose.** The Assembly hereby determines that the Projects are
20 needed throughout the Girdwood Valley Service Area. The Assembly hereby
21 determines that the best interest of the residents and property owners within the
22 Girdwood Valley Service Area require the Municipality to undertake the Projects at
23 the time and in the order and in the manner deemed most necessary and advisable
24 by the Municipality. The estimated cost of the Projects, including incidental costs
25 and costs related to issuing and selling the Bonds as provided in this ordinance, is
26 estimated to be \$3,000,000.
27

28 The Projects are described in more detail in the attachment to the Assembly
29 Memorandum accompanying this ordinance. The cost of all necessary planning,
30 acquisition of property for, site preparation, construction, installing and equipping of
31 the Projects, architectural, engineering, design, and other consulting services,
32 inspection and testing, administrative expenses, costs of issuance of the Bonds and
33 other costs incurred in connection with the Projects shall be deemed to be costs of
34 the approved Projects. The approved Projects may be completed with all necessary
35 equipment and appurtenances. All components of the Projects shall be situated on
36 property situated within the boundaries of the Municipality, and shall be owned by
37 the Municipality.
38

1 The Municipality shall determine the application of available moneys for the
2 Projects so as to accomplish, as nearly as may be, the Projects described or
3 provided for in this section.
4

5 If the Municipality shall determine that it has become impractical to
6 accomplish any portion of the approved Projects by reason of changed conditions
7 or needs, incompatible development or costs substantially in excess of those
8 estimated, the Municipality shall not be required to accomplish such portions and
9 shall apply Bond proceeds as set forth in this section.
10

11 If the approved Projects have been completed in whole or in part, or their
12 completion duly provided for, or their completion found to be impractical, the
13 Municipality may apply Bond proceeds or any portion thereof to other Municipality
14 capital improvements within the Girdwood Valley Service Area at its sole discretion.
15 Otherwise, the Municipality shall apply such remaining proceeds solely to payment
16 of principal or interest on the Bonds, as provided in the Home Rule Charter. In the
17 event that the proceeds of sale of the Bonds, plus any other monies of the
18 Municipality legally available, are insufficient to accomplish the approved Projects,
19 the Municipality shall use the available funds for paying the cost of those portions of
20 the approved Projects deemed by the Municipality most necessary and in the best
21 interest of the Municipality. No Bond proceeds shall be used by the Municipality for
22 any purpose other than a capital improvement of the Municipality.
23

24 For the purpose of providing funds for the undertaking of the Projects, which
25 is hereby found to be a public purpose and in the public interest, the Municipality
26 hereby proposes to issue general obligation bonded indebtedness in an amount not
27 to exceed Three Million Dollars (\$3,000,000).
28

29 **Section 2. Details of Bonds.** The Bonds shall be sold in such amounts and at
30 such time or times as deemed necessary and advisable by the Assembly and as
31 permitted by law and shall mature over a period of up to 20 years from date of issue.
32 The Bonds shall be issued in an aggregate principal amount of not to exceed
33 \$3,000,000. The Bonds shall bear interest to be fixed at the time of sale or sales
34 thereof. The exact form, terms, conditions, contents, security, options of
35 redemption, and such other matters relating to the issuance and sale of said Bonds
36 as are deemed necessary and advisable by the Assembly shall be as hereinafter
37 determined and/or delegated by ordinance and/or resolution of the Assembly.
38

39 The full faith and credit of the Municipality is pledged for the payment of the
40 principal of and interest on the Bonds, and ad valorem taxes upon all taxable
41 property in the Municipality shall be levied without limitation as to rate or amount to
42 pay the principal and interest on the Bonds when due. The principal of and interest
43 on the Bonds are to be paid first from ad valorem taxes levied and collected within
44 the Girdwood Valley Service Area.
45

1 **Section 3. Ballot Proposition.** The Assembly hereby submits to the qualified
2 voters of the Municipality the proposition of whether or not the Municipality should
3 issue the Bonds for the purpose of financing the costs of the approved Projects at
4 the regular municipal election to be held on April 1, 2025.

5
6 The Clerk shall prepare the ballot proposition to be submitted to the voters
7 as provided by this ordinance and the Municipal Code and shall perform all
8 necessary steps in accordance with law to place this proposition before the voters
9 at the regular election. The proposition must receive a majority vote of those in the
10 Municipality voting, both in the Girdwood Valley Service Area and areawide, on the
11 question to be approved. The proposition shall be substantially in the following form:

15 GIRDWOOD VALLEY SERVICE AREA BONDS

16
17 For the purpose of providing road safety improvements
18 to Timberline Road within the Girdwood Valley Service
19 Area, as provided in AO 2025-____, shall Anchorage
20 borrow money and issue up to \$3,000,000 in principal
21 amount of general obligation bonds?

22
23 Voter approval of this bond proposition authorizes for
24 each \$100,000 of assessed taxable property value
25 (based on the estimated 2025 assessed valuation in the
26 Girdwood Valley Service Area) an annual increase in
27 taxes of approximately \$24.35 to retire the proposed
28 bonds.

29
30 The debt shall be paid from real and personal property
31 taxes levied and collected within the Girdwood Valley
32 Service Area, without cost to properties in Chugiak,
33 Eagle River, the Anchorage Bowl, and other properties
34 outside the Service Area. The Municipality will also
35 pledge its full faith and credit for payment of the debt.

39 **Section 4. Effective Dates.** Section 2 of this ordinance shall become effective
40 only if the proposition described in Section 3 is approved by a majority of the
41 qualified voters voting on the proposition at the regular election held on April 1, 2025.
42 The remaining sections of this ordinance shall become effective upon passage and
43 approval by the Assembly.

PUBLIC SECTOR ECONOMIC EFFECTS:

Estimated annual debt service of \$218,343 assumes bonds are sold as a single bond issue with an interest rate of 3.877% with bond repayments corresponding to the expected life of the assets financed up to 20 years.

PRIVATE SECTOR ECONOMIC EFFECTS:

Estimated annual debt service payments of approximately \$218,343 equate to an estimated property tax increase of 0.2435 mills or \$24.35 per year on \$100,000 of assessed valuation in the Girdwood Valley Service Area.
