Subject: Certification of the Special Election of April 4, 1972

The Election Commission sat as a Canvass Board to canvass the challenged and absentee ballots on Thursday, April 6, 1972.

Ninety-one absentee ballots were returned, voted timely and were counted with the challenged ballots. The precincts returned 366 challenged ballots. After investigation 333 were accepted and 33 rejected for the following reasons:

Not registered with the State	21
Have not re-registered under married names; not able to contact to verify marriage within 90 days of election date	5
Not registered; State eliminated from registration list; married in 1970 and have not re-registered although notified several times	3
Registered too late	1
Lack residency requirement	2
Lack age requirement	1


