

This is an application on behalf of myself, Betty Bruckman also known as Elizabeth Bruckman, a candidate for Seat "G" on the Anchorage School Board at the October 6, 1981 general election. According to the results of the election announced after the completion of the canvass, I received 81 votes less than Mr. Wadsworth, out of approximately 50,000 cast, a difference of approximately 2/10ths of one percent. This application is submitted pursuant to AMC 28.10.300.

Pursuant to that section, the following information is set out.

(1) I believe a mistake was made in the counting and canvassing of votes because of (a) the possibility of computer error; (b) the fact that in the tallying of votes, canvassing of votes, preparation of facsimile ballots and other procedures connected with the election, my name was frequently confused with that of Jean Buchanan, a candidate for School Board Seat "F", whose name is similar to mine; (c) the possibility of mathematical error; and (d) the likelihood of error in a situation where the margin is so slim given the number of ballots cast.

(2) A recount is requested for all precincts within the Municipality of Anchorage.

(3) I am a candidate for School Board Seat "G".
