PROPOSITION 14 FORMATION OF THE CHUGIAK LIMITED ROAD SERVICE AREA

PROPOSITION 14: FORMATION OF THE CHUGIAK LIMITED ROAD SERVICE AREA: Shall there be established within the Municipality of Anchorage a limited road service area pursuant to AMC 27.10 and as provided below:

PROPOSED: A Limited Road Service Area, in the area commonly known as the Chugiak Area, to provide limited road maintenance and repair. A five-member Board of Supervisors shall be appointed by the Mayor and confirmed by the Assembly to administer the service area until the next regular election at which time Supervisors will be elected for staggered terms of one, two and three years. In the event of a vacancy, the Mayor shall appoint with confirmation by the Assembly. The service area will expire three years from the date of this election unless it is extended by a vote in the area affected at the regular election of 1983. No tax may be levied during the first year of operation. By a vote of the area residents at each succeeding regular election, a mill rate not to exceed .5 mill (one half mill) may be levied during the second year of operation, and if approved an additional .5 mill levy with the total not to exceed 1.0 mill may be levied for the third year of operation. Limited road maintenance and repair within the service area shall commence on January 2, 1981.

PROPOSITION 15: FORMATION OF THE RABBIT CREEK VIEW AND RABBIT CREEK HEIGHTS LIMITED ROAD SERVICE AREA: Shall there be established within the Municipality of Anchorage a limited road service area pursuant to AMC 27.10 and as provided below:

PROPOSED: A Limited Road Service Area, in the area commonly known as the Rabbit Creek View and Rabbit Creek Heights Area, to provide limited road maintenance and repair. A three-member Board of Supervisors shall be appointed by the Mayor and confirmed by the Assembly to administer the service area until the next regular election at which time supervisors will be elected for staggered terms of one, two, and three years, to administer the service area. In the event of a vacancy, the Mayor shall appoint, with confirmation by the Assembly. The service area will expire three years from the date of the election unless it is extended by a vote in the area affected at the Regular Election of October 1983. The mill rate shall not exceed 1 mill in any calendar year. Limited road maintenance and repair within the service area shall commence on January 1, 1981.
