The Anchorage Assembly has adopted AO 93-33 (S-4) creating a 4% sales tax subject to certain specified limits, exclusions and exemptions. The 4% tax will be apportioned as follows: During the period of imposition and levy of the sales tax, two percent (2%) will be applied to public safety. For areas within the police service area this 2% will apply to reduce the property tax levy assigned to fund the Anchorage Police Service Area. For areas outside of the Anchorage Police Service Area this 2% will be dedicated to areawide public safety services.

The remaining two percent (2%) of the sales tax will generate new revenue with one percent (1%) to be applied to the Municipality's contribution to the Anchorage public school district, and with the remaining one percent (1%) to be applied to transportation maintenance and support.

This tax is a new special retail sales tax (under Charter Section 14.01(b)). A portion is also considered a "special tax", meaning a "special tax" under Charter Section 14.03(b)(3), 2% of which is outside the tax increase limitation of Charter Section 14.03(a)).

Charter Section 14.01(b) requires voter ratification prior to imposition of a sales tax and Charter Section 14.03(b) requires voter approval of a tax as a "special tax" (meaning the revenues to be dedicated to a special purpose) in order for a tax to be considered outside the tax increase limitation of Charter Section 14.03(a); in this case with one percent (1%) to be applied to the Municipality's contribution to the Anchorage public school district and the remaining one percent (1%) to be applied to transportation maintenance and support.

This tax cannot be increased without a vote of the people.

A "Yes" vote authorizes the Assembly to proceed with imposing, and the Municipality to proceed with collecting, the tax created by AO 93-33(S-4).
