



ENERGY

- ❖Carbon Capture and Sequestration Sets up a statutory framework for the state to lease depleted gas wells to store carbon dioxide deep underground.
- **❖Gas Storage -** Establishes a regulatory framework for RCA oversight of the State's gas storage, particularly needed in Cook Inlet.
- ❖AIDEA Reserve Based Lending State financing through AIDEA loans (HB 388) for new Cook Inlet natural gas development based on natural gas reserves leased by producers.
- ❖Geothermal Expansion of the state's geothermal energy program (HB 74 / SB 69).

Transmission without "pancaking" – HB 307

Enables the lowest cost power to be delivered across the Railbelt, and the integration of more renewables

Key provisions in the bill:

- Creates a Railbelt Transmission Organization (RTO) within Alaska Energy Authority (AEA) to establish a transmission cost recovery mechanism for, and to ensure nondiscriminatory open access to, the Railbelt backbone transmission system.
- Eliminates practices known as "wheeling" and "pancaking," which refer to the added charges imposed on utilities for energy that runs through different segments of the system.
- Additionally, Independent Power Producers (IPP) who construct an electricity generation or a storage facility
 or electricity and places that facility into service after July 1,2024 will not be subject to state and local
 property, income and excise tax if the generation is sold or provided exclusively to a public utility.
- Expands the criteria the RCA may look at for determining just and reasonable rate charges

GREEN BANK AND NET METERING

HB 273 – Alaska Energy Independence Fund – 'Green Bank' - Establishes the Alaska Energy Independence Fund at the Alaska Housing Finance Corporation to capture both private and federal clean energy funding and to offer loans for renewable energy project: \$27 billion in EPA Greenhouse Gas Reduction grants; USDOE loan guarantees; and federal energy tax credits.

This bill also removes limitations of the Alaska Housing Finance Corporation and provides additional loan opportunities for residential lending.

<u>SB 152 – Net metering</u> - Currently, ratepayers for economically regulated utilities can utilize net metering, which lowers their electric bills based on the amount of electricity they generate from generators like solar panels or wind turbines. Unfortunately, many ratepayers including renters and condo owners are not able to take advantage of net metering because they do not have space available on-site. SB 152 will allow multiple ratepayers to pool their resources to receive net metering benefits from a single project.

THE EDUCATION BATTLE

Early in the session the Legislature passed Senate Bill 140. This bill raised perstudent funding by \$680 per student. The bill did not include many of the Governor's "must haves" resulting in a veto.

The Legislature included \$175 million in one-time school funding on top of the normal school funding formula—equivalent to a \$680 BSA increase.



MUNICIPAL BUDGET ITEMS PASSED

- Recapitalization of the Community Assistance Fund for FY24 and FY25, which will mean full payments to communities in FY25 and FY26.
- \$7 million to the Denali Commission to provide non-federal match for competitive grants that are allowing local governments to replace aging infrastructure. We know how important this is for local and tribal governments.
- \$26.5 million for the School Major Maintenance Grant Fund, as well as fully reimbursing for school bond and harbor debt service.
- \$77.2 million to AHFC for a variety of programs that will lower the cost of housing for Alaskans across the state

LEGISLATION

ENERGY

HB 50 - Carbon Capture Utilization and Sequestration; Gas Storage

Carbon Capture and Sequestration

Sets up a statutory framework for the state to lease depleted gas wells to store carbon dioxide deep underground.

Gas Storage

Sets up a regulatory framework for RCA oversight of the State's gas storage, particularly needed in Cook Inlet to ensure more gas supply during peak seasons.

AIDEA Reserve Based Lending

Intended to incentivize the smaller producers in Cook Inlet through an asset-based financing mechanism in the oil and gas industry in which loans are made based on either undeveloped or developed and producing oil and gas assets.

Geothermal

The geothermal section in the bill incorporates legislation originally introduced by Governor Dunleavy, (House Bill 74 and Senate Bill 69) that redefines geothermal energy and expands that size of the tracts that may be leased for development.

HB 273 - Alaska Energy Independence Fund - 'Green Bank'

- Establishes the Alaska Energy Independence Fund at the Alaska Housing Finance Corporation, intended to capture both private and federal clean energy funding and to offer loans for renewable energy project.
- Removes limitations of the Alaska Housing Finance Corporation on its residential lending programs to be able to provide additional loan opportunities for Alaskan families.

HB 307 – Integrated Transmission Systems

- Creates a Railbelt Transmission Organization (RTO) within Alaska Energy Authority (AEA) to establish a transmission cost recovery mechanism for, and to ensure nondiscriminatory open access to, the Railbelt backbone transmission system.
- Eliminates practices known as "wheeling" and "pancaking," which refer to the added charges imposed on utilities for energy that runs through different segments of the system.
- Mandatory State & Local Tax Exemptions: Independent Power Producers (IPP) who constructs an electricity generation
 facility or electricity storage facility and places that facility into service on or after July 1, 2024 will not be subject to state
 and local property, income and excise tax if the generation is sold or provided exclusively to a public utility. This provision is
 intended to keep rates to consumers as low as possible.
- Expands the criteria the RCA may look at for determining Just and Reasonable Rates to include whether the purpose of the rate is to increase diversity of supply, promote load growth, or enhance energy reliability or energy security.

SB 152 – Community Energy

Allows multiple ratepayers to pool their resources to receive net metering benefits from a single project.

PREEMPTION OF MUNICIPAL TAXES

SB 179 – Preemption of a municipal sales tax on the transfer of real property; Ag Land Mandatory Exemptions; Municipal Assessor Requirements

Prohibits cities and boroughs from collecting a sales or use tax on the transfer of real property, and further would prohibit the state from levying or collecting a sales or use tax on the transfer of real property.

This bill was amended to include several other bills:

Expansion of the Ag Land and Structures Mandatory Exemption (SB 161)

- This bill allows inclusion of structures on farm use land that are used for farm operations as part of a farm unit to be assessed on the basis of full and true value for farm use and may not be assessed as if subdivided or used for some other nonfarm purpose. It allows a municipality to partially or totally exempt a farm structure used exclusively for farming activity, or purposes directly related to farming activity from taxation, if the farm structure is owned or leased by a person that is actively engaged in farming and that derives at least 10 percent of the person's yearly gross income from farming activity.
- The property owner wishing to file for farm use classification having no history of farm-related income may submit a declaration of intent at the time of filing the application with the assessor setting out the intended use of the land and is certifying the intent to file an Internal Revenue Service Schedule F (Form 1040). Farm use is defined as products for sale that exceed \$1,000 in a tax year.

Property Assessments (HB 347)

- Requires the Department of Commerce to adopt assessment standards consistent with those of the International Association of Assessing Officers.
- Assessors shall be required to determine the full and true value of property as of January 1st using standards adopted by the Department or by standards provided by Local Ordinance.
- Requires a Municipal Assessor to hold a Level 3 Certification from the Alaska Association of Assessing Officers, or work under the supervision of someone with this certification.
- Directs City Councils or Borough Assemblies to appoint one or more Boards of Equalization for hearing an appeal from a
 determination of the Assessor and prohibits the Board of Equalization from raising the property assessment within the
 current year unless requested to do so by the appellant.
- A person receiving an assessment notice shall advise the assessor of errors or omissions and may request the assessor meet with them and answer reasonable questions relating to the methods used to determine the assessment. The meeting may be online or telephonic.
- Removes the 2.65 floor for required local contribution for schools for optional economic development exemptions approved by voters in a municipality.

^{**}Mandatory and Optional Senior Property Tax Exemption Expansion: There was a move at the end that tried to increase the mandatory senior exemption from \$150.0 to \$450.0 and increasing the optional exemption to \$150.0 -- which ultimately did not succeed.

CRIME

HB 66 – Ominbus Crime Package

- Increases the penalty for distributing fentanyl or methamphetamine that directly results in death from manslaughter to second degree murder.
- Closes a gap between our criminal justice system and our behavioral health system when a person is incompetent to stand trial and should be committed to the Alaska Psychiatric Institute. (SB 53 by Sen. Claman)
- Requires out-of-state sex offenders who move to Alaska register in Alaska (SB 65 by the Governor)
- It changes the term "child pornography" to "child sexual abuse material." (HB 265 by Rep. Sarah Vance)
- Establishes the crime of assault in the presence of a child as a class A misdemeanor (HB 11 by Rep. Andy Josephson)
- The bill allows police officers to summarize crime-victim statements in grand-jury proceedings. (SB 65 by the Governor)
- Directs the state to examine why minority groups are overrepresented in state prisons and make recommendations to reduce the number of people who commit crimes after being released from prison.
- Makes it a Class B felony to induce someone into sex trafficking by withholding drugs or a passport.

EDUCATION / HEALTHCARE / CHILDCARE

Crime Cont.

SB 151 - Missing and Murdered Indigenous People

The bill amends state law to require the Department of Public Safety to establish a Missing and Murdered Indigenous Persons Review Commission and to employ at least two persons to investigate missing and murdered indigenous persons.

EDUCATION

HB 148 – Alaska Performance Scholarship; Education Tax Credits; TVEP Grants

- Updates the Performance Scholarship program; Amends the Alaska Reads Act that had prevented rural Head Start programs from accessing funding. Extends the Education Tax Credit Program and the Technical Vocational Education Program

SB 189 -- Commission on Aging; Childcare Tax Credit Extends the Commission on Aging

- Creates a childcare tax credit encouraging employers to contribute to their employees' childcare expenses.

HB 193 – Internet for Schools

Provides funding for internet services to assist eligible schools in their district reach up to 100 megabytes per second download speed for internet services.

HB 202 - Opioids in Schools; Correspondence Program

- Requires all school districts to keep at least two opioid overdose drug kits in each main school building and at least one person trained to administer the opioid overdose drug is present during all hours that the main school building is open to students or the public.
- Instructs the State Board of Education to write temporary regulations allowing the Correspondence Program to continue. The regulations will expire next year giving the Supreme Court time to rule on the case.

HEALTHCARE

Education Cont.

HB 230 – Retired Teachers; Incentive Bonus

- Allows retired educators to receive a certificate that is good for life allowing the educator to work for up to 165 consecutive
 days in the State as a long-term substitute teacher.
- Incentive payment of \$5,000 to teachers employed by the district with have a current national board certification.
- Reimburse teachers who are pursuing an initial national board certification or renewal of a national board certification for the costs of course materials, registration, and testing.
- Removes the limit on the number of years of out-of-state school experience that may be substituted for in-state experience for the purpose of determining a teacher's salary.

HEALTHCARE

HB 17 Contraceptives Coverage

Requires a health care insurer to provide coverage for contraceptives and to provide reimbursement for a 12-month supply of contraceptives mandating the State and Municipal employee health benefit plans, Medicaid, and plans subject to Title 21.

HB 126 – Professional Counselors

House Bill 126 will help Alaska attract and retain talented behavioral health professionals to the state by allowing qualified candidates to obtain licensure as Associate Counselors and creates a pathway towards full accreditation as Licensed Professional Counselors in Alaska.

Healthcare cont.

HB 147 – Workers' Compensation Reemployment Rights and Benefits

- Relating to Workers' Compensation reemployment rights and benefits;
 Reestablishing a Workers' Compensation Stay-At-Work program;
 Relating to the Workers' Compensation Benefits Guaranty Fund;
 Presumption of Compensability for Workers' Compensation Claims related to Post-Traumatic Stress Disorder
- Extending the Alaska Senior Benefits Payment program

HB 226 – Pharmacy Benefit Managers

Extends state regulatory oversight and adds guidelines for Pharmacy Benefit Managers, or PBMs.

HB 237 – Nurse License Reinstatement Permit

Allows temporary permits to be issued to nurses looking to reinstate their lapsed Alaska licenses.

HB 344 – 1115 Waiver Demonstration Social Determinates of Health; Medicaid in Schools; Supplemental **Nutrition Assistance Program Benefits**

1115 Demonstration Social Determinates of Health

Defines "health-related needs" to include social or economic conditions that contribute to an individual's poor health outcomes, such as nutrition and food security, workforce development, transportation, temporary housing, and allows the State to move forward in negotiations with CMS.

Healthcare cont.

Medicaid in Schools

Expands school-based services to include all children who are Medicaid eligible and repeals the requirements that the child must be disabled and have an Individualized Education Program (IEP) to qualify.

Supplemental Nutrition Assistance Program

SNAP provisions mandate the Division of Public Assistance to execute Broad-Based Categorical Eligibility within the (SNAP) and allows the state to waive SNAP's asset test.

SB 134 – Insurance

Prohibits insurance companies from charging women at elevated risk for breast cancer for more detailed examinations more than routine mammograms (HB 285 Rep. Fields).

OTHER

HB 251 - Exempts homemade foods from labeling and inspection requirements.

Updates loan limits from the Alaska Division of Agriculture's Agricultural Revolving Loan Fund Increases the categories of loans to include food manufacturing and shipping and allows refinancing of loans

HB 345 – Municipal Harbor Safety Ladders

Requires safety ladders in all harbor projects that receive money from the state's harbor facility grant fund.

SB 67 – PFAS

Prohibits the use of PFAS-containing foam.

SB 127 - Rental Car Tax

This bill requires vehicle rental platforms such as Turo to collect and remit the existing State rental car tax.

FAILED LEGISLATION

Public Employee Defined Benefit – SB 88 (Passed Senate Only)

Would have created a Tier 5 Defined Benefit plan for all public employees, part of an effort to attract and retain public employees.

HB 183 – Transgender Sports Ban (Passed House Only)

Elements of the bill, which would have limited membership on girls' school sports teams to students who were female at birth, have already been passed into regulation by the State Board of Education, and the Alaska School Activities Association has been enforcing that regulation since last year.
