

- Tuesday, December 31, 2024
 - <u>Deadline to request new bills</u> <u>for prefile</u>
- Tuesday, January 7, 20025
 - Approval of first prefiled bills
- Friday, January 10, 2025 (noon)
 - Release of 1st prefiled bills
- January 14, 2025 (noon)
 - Approval of 2nd prefiled bills
- Friday, January 17, 2025
 - Release of 2nd prefiled bills
- Tuesday, January 21.2025
 - First day 2025 Legislative session



Revenue Projections

- The ANS oil price for FY 2026 is projected at \$78.00/barrel. This will likely be adjusted in December, 2024 when Governor Dunleavy releases his FY 2026 proposed budget.
- As of September 3, 2024, the price of Alaska North Slope crude oil was \$76.45, which is a 0.70% increase from the previous month, however oil prices have seen wide fluctuations recently.
- The revenue forecast for Alaska North Slope oil prices projects the following:
- 2025: \$76.00 per barrel
- 2033: \$70.00 per barrel
- The forecast also projects that oil production will average 470,300 barrels per day in 2024 and 463,800 barrels per day in 2025. By 2033, production is expected to increase to 633,000 barrels per day.
