PROPOSED AMENDMENT

Purpose/Summary of Amendment: This amendment is intended to assure the Administration continues the work at the former Golden Lion conversion to a roominghouse and begins receiving tenants and occupants before construction on the Navigation Center may begin. The Administration may do the preliminary steps of procuring a contractor and other preparation work before commencing construction.

AR Section 4, p. 3, beginning at line 49, renumbering current Section 4 to 5, and insert a new Section 4 to read as follows:

Section 4. The Assembly's approval of Section 1 is conditioned on the Municipal property at 1000 E. 36th Avenue (formerly the Golden Lion Hotel) first having tenants begin to move in to the property, before the Administration may authorize the contractor the Navigation Center and Emergency Shelter described in Section 1 to commence construction work.
