

NES1 updates

- All of the sheetpile has been removed marking a project accomplishment.
- Armor rock placement designed to protect the shoreline is began this week and anticipated to be complete next year.
- Dredge excavating continues and will continue next year to complete the project.
- All federal permits have been modified to accommodate and extra season of work in 2025.

Request for Additional Change Order Authority GHD-WSP (Contract C-2023001084) — Design Services for Terminal Replacement Project - \$717,753.00



- On April 11, 2023, through AM 280-2023, the MOA authorized award of Contract C-2023001084 in the amount of \$10,752,821.00 to GHD-WSP JV to provide design services to the MOA, for the Terminal 1 Replacement project.
- Pursuant to AMC 7.15.080.A.4, Change Order Authority in the amount of \$1,075,285.00 (approximately 10% of the contract) was initially authorized.
- The initial scope of work included providing complete design services through the Issued for Construction (IFC) milestone to include final plans, specifications, and cost estimates.

Change orders



- CO 1: Cone Penetration Testing (CPT) increase by \$97K
- CO 2: Stevedore Operations Building decrease by \$254K
- CO 3: Terminal 1 (T1) Maintenance dredging increase by \$98K
- CO 4: Geophysical survey increase by \$35K
- CO 5: Petroleum Transfer Operations Planning Feasibility
 Analysis and enabling design changes increase by \$361K
- CO 6: Terminal 1 (T1) Construction Bidding Support increase by \$198K
- CO 7: Shoreline Infill Seismic Mitigation Design increase by \$198K





- After the execution of the 7 change orders, the change order authority remaining is \$357,532.00.
- The project is now requesting an increase in change order authority in the amount of \$717,753.00 to restore our change order authority to the original amount of \$1,075,285.00.
- The funding source for these requested expenditures is the FY2023 State of Alaska Designated Legislative Grant No. 23-DC-045, \$25,000,000 awarded July 1, 2022.

Additional work



Additional work by GHD-WSP JV is now required to support the re-bidding process for the Terminal 1 (T1) Construction project.

This effort includes:

- Investigating and evaluating ideas for additional work that can be rephased and accomplished in construction year 2025
- Assisting with the preparation of updated design documents for issuance with the RFP
- Reviewing, analyzing, and implementing design changes requested by the Port of Alaska
- Reviewing and responding to bidder questions during the procurement process

The estimated cost for these services are not expected to exceed restoration of the CO authority.
