9 DUE DATES, APPLICATION OF PAYMENTS, DELINQUENCY, PENALTIES,  
10 INTEREST AND COSTS FOR DELINQUENCY AND ENFORCEMENT AND  
11 APPROPRIATING THE SUM OF \$478,109 IN ASSESSMENT REVENUES  
12 WHEN TENDERED TO SPECIAL ASSESSMENT FUND 271 FOR SERVICES  
13 BENEFITING THE PROPERTY OWNERS IN SPECIAL ASSESSMENT  
14 DISTRICT 1SD97.

16 THE ANCHORAGE ASSEMBLY HEREBY RESOLVES:  
17

18 **Section 1.** The services authorized in Anchorage Ordinance No. 2000-98  
19 extending the Downtown Business Improvement District, Special assessment  
20 District 1SD97, (herein "Services") are hereby levied against the properties, lots  
21 and tracts specially benefited as set forth in the attached Assessment Roll for  
22 Special Assessment District 1SD97 (herein the "Assessment Roll").  
23

24 **Section 2.** Timely notice was sent to each property owner whose  
25 property is specially benefited by the Services as indicated on the Assessment  
26 Roll, and each property owner was given notice of a public hearing before the  
27 Assembly for the purpose of providing property owners an opportunity to present  
28 objections to the Assessment Roll by showing errors and inequalities and by  
29 submitting any reason for amending or correcting the Assessment Roll for  
30 Special Assessment District 1SD97.


32 **Section 3.** In conformity with the notice to the property owners, the  
33 Assembly held a hearing on AR No. 2002-242 to hear objections by affected  
34 property owners to the Assessment Roll. At said hearing, all errors and  
35 inequalities to which valid objections were raised, if any, were corrected and the  
36 assessed properties and assessment amounts now indicated on the Assessment  
37 Roll are and shall be the assessed properties and the annual assessment  
38 amounts finally determined to be the properties and assessment and that  
39 assessment amounts are fairly proportionate to the special benefit to each  
40 property accruing from the services to be provided in Special Assessment District  
41 1SD97. The Assessment Roll has been duly certified by the Clerk. Special  
42 assessments are hereby levied against the properties, lots and tracts specially  
43 benefited by the said services as set forth in the attached Assessment Roll.  
44

**Section 4.** The Municipal Treasurer shall mail, postage prepaid, an assessment bill to each property owner shown on the Assessment Roll in accordance with Anchorage Ordinance No. 2000-98. Assessments shall be due, payable and delinquent, shall bear penalties, interest and costs and the application of payments on and enforcement of assessments shall be as prescribed in Anchorage Ordinance No. 2000-98.

**Section 5.** The Assessment Roll hereby established may be recorded with the District Recorder for the Anchorage Recording District, Third Judicial District, State of Alaska as appended hereto or showing only the property description and amount of assessment without the names of the property owners.

**Section 6.** That the sum of Four Hundred Seventy Eight Thousand One Hundred Nine Dollars (\$478,109) of Special Assessment District ISD97 assessment revenues is hereby appropriated tendered to Fund 271 for payment of services benefiting the property owners of said assessment district.





 8 AO 2000-98, the ordinance extending the Downtown Business Improvement District (BID)  
 9 provides that owners who use their property solely as their single family residence have the  
 10 opportunity to apply for an owner-occupied single family residential exemption.  
 11


12 When the notice of public hearing on AR 2002-242 was mailed to property owners in the BID  
 13 area, an application for residential exemption was included. The attached Assessment Roll  
 14 reflects those applications received and approved through August 2, 2002.
