ASSEMBLY AMENDING ANCHORAGE MUNICIPAL ETHICS CODE SECTION 1.15.035, ADDITIONAL PROVISIONS FOR ELECTED OFFICIALS, RELATING TO PARTICIPATION BY AN ELECTED

OFFICIAL AFTER DISCLOSURE OF A PRIVATE INTEREST.

Holding elective municipal office is a public trust. The Anchorage Assembly adopted a Code of Ethics to promote fair, honest, and impartial dealings with members of the public, to ensure proper use of municipal resources, and to avoid conflicts of interest.

Some potential conflicts of interest cannot be quantified in terms of dollars or financial interest. Familial relationships, for example, fall under the category of "private interest." The purpose of AO 2008-54 is to make clear that upon request by the elected official, participation will be excused on a matter involving a private interest.
