7 FOR CRISIS INTERVENTION TEAM TRAINING GRANT.

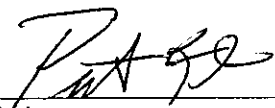

9 **THE ANCHORAGE ASSEMBLY RESOLVES:**

11 **Section 1.** That the sum of FORTY-FOUR THOUSAND FIVE HUNDRED DOLLARS (\$44,500),  
12 is appropriated from the Alaska Mental Health Trust Authority to the State Categorical Grants Fund  
13 (231), Anchorage Police Department, for a Crisis Intervention Team Training grant.

15 **Section 2.** That the sum of ONE THOUSAND EIGHT HUNDRED NINETY-EIGHT DOLLARS  
16 (\$1,898), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2010  
17 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund  
18 (231), Anchorage Police Department.

20 **Section 3.** This resolution shall take effect immediately upon passage and approval by the  
21 Anchorage Municipal Assembly.

3 **Subject:** APPROPRIATION FROM THE ALASKA MENTAL HEALTH TRUST AUTHORITY  
4 OF A CRISIS INTERVENTION TEAM TRAINING GRANT AND LOCAL MATCH  
5 REQUIRED (\$46,398)

7

8 The Municipality of Anchorage has received a grant from the Alaska Mental Health Trust Authority for  
9 Crisis Intervention Team Training in the Anchorage area. This is an annual training event designed to  
10 increase the knowledge of mental health disorders and skills for facilitating positive interactions between  
11 law enforcement and persons with mental health disorders.  
12

13 This grant funding will be used to reimburse the cost of classroom materials and the backfill overtime  
14 costs for up to fifteen officers of the Anchorage Police Department to attend the 2010 Crisis Intervention  
15 Team Training this year. Through increased law enforcement awareness of issues associated with mental  
16 illness, citizens residing in the Municipality of Anchorage will experience a safer living environment.  
17

18 A special condition of this grant agreement is that the department provides matching funds. The total  
19 projected Municipal cost is \$1,898, which has been budgeted in the 2010 Anchorage Police Department  
20 Operating Budget. This training will take place in Anchorage, Alaska, beginning January 25, 2010 and  
21 ending on January 29, 2010. This grant is being presented after the actual performance begin date of July  
22 1, 2009 due to late notification by the grantor. The grant will end on June 30, 2010.
