8 SEAT BELT ENFORCEMENT.

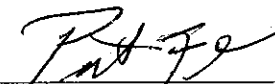

10 **THE ANCHORAGE ASSEMBLY RESOLVES:**

12 **Section 1.** That TWENTY-FIVE THOUSAND FOUR HUNDRED TEN DOLLARS
13 (\$25,410), is appropriated from the State of Alaska, Department of Transportation & Public
14 Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Seat Belt
15 Enforcement.

17 **Section 2.** That ONE THOUSAND EIGHTY-THREE DOLLARS (\$1,083) is appropriated
18 from the Anchorage Metropolitan Police Service Area Fund (151), 2010 Anchorage Police
19 Department Operating Budget as a contribution to the State Categorical Grants Fund (231),
20 Anchorage Police Department.

22 **Section 3.** This resolution shall take effect immediately upon passage and approval by the
23 Anchorage Municipal Assembly.

3 **Subject:** APPROPRIATION FROM THE STATE OF ALASKA, DEPARTMENT OF
4 TRANSPORTATION & PUBLIC FACILITIES OF A SEAT BELT
5 ENFORCEMENT PROGRAM GRANT AND LOCAL MATCH REQUIRED
6 (\$26,493)
7

8 The Municipality of Anchorage has received a grant from the State of Alaska, Department of
9 Transportation & Public Facilities, in the amount of \$25,410 for a Seat Belt Enforcement
10 program. This grant is intended to support focused enforcement during the period January 1,
11 2010 through February 28, 2010.
12

13 This grant will be used to pay officer overtime and benefits for focused traffic assignments
14 specifically targeted for enforcement of seat belt violations within the Municipality of
15 Anchorage. Through increased awareness and enforcement of seat belt driving offenses, the
16 citizens of Anchorage will experience safer roads and reduced traffic accident injuries.
17

18 A special condition of this grant is that the department provides matching funds. The total
19 projected Municipal cost is \$1,083 that has been budgeted in the 2010 Police Operating Budget.
20 This grant, which is being presented after the actual start date due to late notification from the
21 grantor, began on January 1, 2010 and will end on February 28, 2010.
