A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS PROTEST REGARDING THE RENEWAL OF BEVERAGE DISPENSARY-TOURISM LIQUOR LICENSE #4440 FOR BARRATT INN MGT CO LLC. DBA: CRAVE BAR & GRILL, LOCATED AT 4616 SPENARD ROAD AND AUTHORIZING THE MUNICIPAL CLERK TO TAKE CERTAIN ACTION.

WHEREAS, Barratt Inn MGT Co LLC. has made an application with the Alcoholic Beverage Control (ABC) Board and has paid the required fee for a renewal of Beverage Dispensary-Tourism Liquor License #4440, to be used for Crave Bar and Grill, located 4616 Spenard Rd, Anchorage, Alaska; and

WHEREAS, the Assembly must enter any protest to the ABC Board within 60 days following receipt of the application; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on January 15, 2010 and has determined that the last day for the Assembly to file a protest is March 16, 2010; and

WHEREAS, the Assembly Meeting on March 2, 2010 is the last scheduled regular meeting of the Anchorage Assembly prior to the expiration of the protest period; and

WHEREAS, the Municipal Clerk reports the following status concerning this location:

1. No ABC Board violations and/or incidents are on file that would lead to an ABC Board violation;
2. There are taxes owing to the Municipality of Anchorage in the amount of \$3,409.72.

WHEREAS, protest by the Assembly is in order until Municipal Clerk confirmation that outstanding items required for this location have been completed;

NOW, THEREFORE, THE ANCHORAGE ASSEMBLY RESOLVES:


Section 1. The Anchorage Assembly hereby enters its **PROTEST** for a Renewal of Beverage Dispensary-Tourism Liquor License #4440 until this condition is met:

- Taxes owing to the Municipality of Anchorage in the amount of \$3,409.72 are paid in full.

Section 2. A copy of this Assembly Resolution may be presented to the Alcoholic Beverage Control Board as proof that the Anchorage Assembly, as the local governing body, has stated its protest in order to allow the Director of the Alcoholic Beverage Control Board to hold processing of Beverage Dispensary-Tourism Liquor License #4440 under local protest, until receipt by the Director of confirmation from the Municipal Clerk that the conditions in Section 1 have been met, and this protest is lifted as authorized by this Assembly Resolution.


