2 **COMMISSION'S APPLICATION FOR A CERTIFIED LOCAL GOVERNMENT**

8 WHEREAS, pursuant to the National Park Service Historic Properties Act of 1966,
9 certain federal share matching grants for historic preservation projects are available
10 to certified local governments; and

12 WHEREAS, the Municipality of Anchorage is a Certified Local Government in good
13 standing; and

15 WHEREAS, the Anchorage Historic Preservation Commission serves as the
16 Municipality of Anchorage's certified local government review body; and

17
18 WHEREAS, Anchorage Ordinance 2006-175 charges the Commission to "Develop
19 and participate in public information, educational and interpretive programs and
20 activities to increase public awareness of the value of historic preservation"; and

22 WHEREAS, the Anchorage Historic Preservation Commission wishes to facilitate
23 development of a Adopt-A-Historic Property program in the Municipality; and



25 WHEREAS, Certified Local Government Historic Preservation Fund Grant
26 applications require a resolution of support from the Anchorage Assembly; and

28 WHEREAS, The Anchorage Historic Preservation Commission wishes to submit a
29 Certified Local Government Historic Preservation Fund Grant Application to assist in
30 funding the program; now, therefore;

35 Historic Preservation Commission's application for a Certified Local Government

3 SUBJECT: A RESOLUTION SUPPORTING THE ANCHORAGE HISTORIC
4 PRESERVATION COMMISSION'S APPLICATION FOR A
5 CERTIFIED LOCAL GOVERNMENT HISTORIC PRESERVATION
6 FUND GRANT TO ASSIST IN THE DEVELOPMENT OF AN ADOPT-
7 A-HISTORIC PROPERTY PROGRAM IN THE MUNICIPALITY OF
8 ANCHORAGE.

11 As a Certified Local Government (CLG), the Municipality of Anchorage is eligible to
12 apply for Historic Preservation Fund Certified Local Government 60/40 matching
13 grants. As the Municipality's certified local government review body, the Anchorage
14 Historic Preservation Commission wishes to apply for a CLG grant to develop a
15 local Adopt-A-Historic Property program.
16

17 The amount of the grant is \$19,895.00, with a \$13,064.00 local match. The cash
18 contribution by the Municipality is \$3,200.00, which will be appropriated from the
19 Municipality's Historic Preservation Fund. As of April 9, 2010, this fund has a
20 balance of \$186,471.31. The remainder of the local match requirement will be met
21 through professional services contributed by members of the Anchorage Historic
22 Preservation Commission.
23

24 Anchorage Ordinance 2006-175 charges the Commission to "Develop and
25 participate in public information, educational and interpretive programs and activities
26 to increase public awareness of the value of historic preservation." The Adopt-A-
27 Historic Property (AHP) Program falls within this charge to the Commission.
28

29 The goal of the AHP program is to increase public awareness of the value of historic
30 preservation by educating the community and local historic property owners on
31 methods of maintaining and rehabilitating historic resources and by recognizing
32 local examples of excellence in the preservation of historic buildings, structures, and
33 sites.
34

35 Increased public awareness of the value of historic preservation and educating
36 historic property owners on maintaining and rehabilitating historic resources are
37 essential to preserving the cultural heritage of Anchorage.

1 A resolution of support for the Certified Local Government grant application from the
2 local governing body is a requirement of the application process.
