12 Section 1. That THIRTEEN THOUSAND SEVEN HUNDRED TWENTY DOLLARS
13 (\$13,720), is appropriated from the State of Alaska, Department of Transportation & Public
14 Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Law
15 Enforcement Equipment.



8 The Municipality of Anchorage has received a grant from the State of Alaska, Department of
9 Transportation & Public Facilities, in the amount of \$13,720 for a Law Enforcement Equipment
10 program. The awarded grant funding is intended to enable the purchase of new less than lethal
11 Taser weapons for issue to sworn patrol officers.

13 The total projected Municipal cost is \$582 which has been budgeted in the 2010 Police
14 Department Operating Budget. This grant began on April 26, 2010 and will end September 30,
15 2010. Increased availability of less than lethal Taser weapons will enable an increased measure
16 of safety to sworn responders while reducing risk to violent offenders..
