**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS
PROTEST REGARDING A RENEWAL OF A RESTAURANT/EATING PLACE LIQUOR
LICENSE #4907 FOR NTF, LLC dba TACO DEL MAR, LOCATED AT 2001 EAST 88TH
AVE. #105, AND AUTHORIZING THE MUNICIPAL CLERK TO TAKE CERTAIN ACTION.**

WHEREAS, NTF, LLC has made an application with the Alcoholic Beverage Control (ABC) Board and has paid the required fee for a Renewal of a Restaurant/Eating Place Liquor License #4907, to be used for Taco Del Mar, located at 2001 East 88th Ave. #105, Anchorage, Alaska; and

WHEREAS, the Assembly must enter any protest to the ABC Board within 60 days following receipt of the application; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on January 13, 2011 and has determined that the last day for the Assembly to file a protest is March 14, 2011; and

WHEREAS, the Assembly Meeting on March 8, 2011 is the last scheduled regular meeting of the Anchorage Assembly prior to the expiration of the protest period; and

WHEREAS, the Municipal Clerk reports the following status concerning this location:

1. Any ABC Board violations and/or incidents are on file that would lead to an ABC Board violation are attached;
2. There are taxes owing to the Municipality of Anchorage in the amount of **\$1,792.42**.

WHEREAS, protest by the Assembly is in order pending Municipal Clerk confirmation that outstanding items required for this location have been completed;

NOW, THEREFORE, THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. The Anchorage Assembly hereby enters its **PROTEST** for a Renewal of Restaurant/Eating Place Liquor License # 4907 until this condition is met:

- Taxes owing to the Municipality of Anchorage in the amount of **\$1,792.42** are paid in full.


Section 2.


