A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND HONORING DR. SHARON CHAMARD.

WHEREAS, Sharon Chamard was born in Toronto, Ontario, Canada; attended Rutgers University; earned her M.A. in 1997 and her Ph.D. in Criminal Justice in 2003; and was hired as Assistant Professor at the University of Alaska Anchorage (UAA) Justice Center in 2003; earning tenure and promotion to Associate Professor in 2009; and

WHEREAS, Sharon choose to make her home in Fairview, one of Anchorage's oldest and most diverse neighborhoods, where "People Make The Difference", being elected Secretary of the Fairview Community Council in 2004, and after three terms as Council Secretary, was elected Council Vice-President in 2007, and Council President in 2008, winning re-election in 2009 and 2010; and

WHEREAS, during her tenure as President of the Fairview Community Council, Sharon has demonstrated exceptional leadership, helping to guide the Council and the neighborhood through contentious issues and public forums, with a steady, even hand; ensuring that all sides were given the opportunity to be heard; and

WHEREAS, Sharon has demonstrated exceptional citizenship through her community volunteerism, including service as Secretary of the NeighborWorks Anchorage Board, Vice-Chair of the Anchorage Public Safety Advisory Commission, and as a member of the Mayor's Police Chief Search Committee; and

WHEREAS, Sharon in her professional capacity, through the UAA Justice Center, has assisted the Anchorage Police Department (APD) with several projects, has provided valuable training for APD's Community Action Policing (CAP) Team and worked closely with them on implementing and evaluating the SARA Project; and

WHEREAS, Sharon has decided not to seek re-election as President of the Fairview Community Council, although she will continue to serve the citizens of Anchorage, both in her professional capacity through the UAA Justice Center, and through her service on boards, commissions and advisory groups.


NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

Section 1: That the Anchorage Municipal Assembly and Mayor recognize and honor


DR. SHARON CHAMARD
