7 WHEREAS, two years ago cadets in the Junior Reserve Officer Training Corps at  
8 Dimond High School researched Alaska Flag etiquette and could not find any  
9 instructions or directions; and

11 WHEREAS, subsequent research showed that Alaska flag statutes were vastly  
12 undeveloped and left many important aspects of flag protocol unaddressed; and

13  
14 WHEREAS, the cadets decided to develop protocols for how to properly fold the  
15 Alaska State flag and how to properly display a flag against a wall; and

16  
17 WHEREAS, the cadets, through much trial and error, figured out the best way was to  
18 fold it into a rectangle shape that results in the North Star being on top; and

19  
20 WHEREAS, State Representative Craig Johnson sponsored HB 98, which  
21 standardizes procedures for the display, folding, and an additional method for the  
22 retirement of our State flag, as developed by the cadets; and

24 WHEREAS, the legislation is designed to ensure consistent, respectful, and  
25 appropriate procedures for the handling of our State flag.

27 NOW, THEREFORE, the Anchorage Municipal Assembly resolves that the:

29 ***Cadets of the Junior Reserve Officer Training Corps***  
30 ***at Dimond High School***

32 are to be commended for their hard work and diligence in developing State flag  
33 protocols.
