15 **THE MUNICIPAL CLERK TO TAKE CERTAIN ACTION.**

17 WHEREAS, Hyun Ju Song & Kyong Teak Song has made an application with the
18 Alcoholic Beverage Control (ABC) Board and has paid the required fee for a Renewal of a
19 Beverage Dispensary Liquor License #1139, to be used for Spenard Paradise Inn & Lounge,
20 located at 3001 Spenard Road, Anchorage, Alaska; and

22 WHEREAS, the Assembly must enter any protest to the ABC Board within 60 days
23 following receipt of the application; and

25 WHEREAS, the Anchorage Municipal Clerk received a copy of this application on
26 February 9, 2011 and has determined that the last day for the Assembly to file a protest is
27 April 8, 2011; and

29 WHEREAS, the Assembly Meeting on March 29, 2011 is the last scheduled regular
30 meeting of the Anchorage Assembly prior to the expiration of the protest period; and

32 WHEREAS, the Municipal Clerk reports the following status concerning this location:

8 Section 2. A copy of this Assembly Resolution may be presented to the Alcoholic
9 Beverage Control Board as proof that the Anchorage Assembly, as the
10 local governing body, has stated its protest in order to allow the Director
11 of the Alcoholic Beverage Control Board to hold processing of Beverage
12 Dispensary/Tourism Liquor License #1139 under local protest, until
13 receipt by the Director of confirmation from the Municipal Clerk that the
14 conditions in Section 1 have been met, and this protest is lifted as
15 authorized by this Assembly Resolution.

17 Section 3. The Anchorage Assembly hereby authorizes the Municipal Clerk, upon
18 Municipal Clerk confirmation that all conditions in Section 1 have been
19 met, to provide written notification to the Alcoholic Beverage Control
20 Board that this protest by the Anchorage Assembly is lifted, without
21 further action by the Assembly.
