1 **A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING**

5 WHEREAS, Mike Felix began his career in telecommunications in 1975 at Tampa Electric  
6 Company, and in 1982, became one of the founding employees at what is today Sprint; and

8 WHEREAS, from 1992 to 2001, Mr. Felix served as CEO or COO of several venture capital-  
9 backed startups in the telecom and software space, and served on the boards of four start-up  
10 companies, a private venture capital company, and three private schools from 1989-2004; and  
11 Mike Felix has been the face of AT&T in Alaska for almost ten years; and

13 WHEREAS, throughout their years in Alaska, Mike Felix and his wife Bethany have been  
14 fixtures at local charitable events and fundraisers, giving generously of time, talent, and  
15 treasure to many worthwhile organizations; and

17 WHEREAS, Mike Felix has devoted thousands of hours of time to groups and organizations  
18 like AIDEA (Alaska Industrial Development and Export Authority); the University of Alaska  
19 Foundation; the Kenai River Sportfishing Association; the Foraker Group; and as an Honorary  
20 Commander for the 3rd Wing of the U.S. Air Force at Elmendorf AFB; and

22 WHEREAS, Mike Felix recently was given the "Robert B Atwood Award" by the YMCA for his  
23 unwavering support of military families through implementation of programs like free long  
24 distance calls for military members to the Lower 48 through the YMCA's offices on Fort  
25 Richardson and Elmendorf AFB; live streaming of high school graduation ceremonies for  
26 deployed parents; and helping to establish the Fisher House Board of Directors; and

28 WHEREAS, Mike Felix and his wife were recently relocated to Dallas, Texas.
