A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY IN OPPOSITION TO LOWERING THE LEGAL AGE FOR CONSUMPTION OF ALCOHOL AND TOBACCO PRODUCTS UNDER HOUSE BILL 210.

WHEREAS, the health risks and health care costs associated with smoking and personal consumption of tobacco products are recognized and well documented by health care providers, wellness programs, multi-million dollar liability court decisions, the Surgeon General of the United States, and many local governing bodies; and

WHEREAS, underage nicotine consumption has been characterized by some addiction experts as a gateway addiction to drugs illegal for consumption at any age; and

WHEREAS, Anchorage values our young people and holds in high esteem those who are active members of the armed forces and the Alaska National Guard; and

WHEREAS, membership in the armed forces and the Alaska National Guard is voluntary, subject to acceptance and discipline; and

WHEREAS, House Bill 210, introduced in the Alaska Legislature on March 28, 2011 by Representative Lynn, seeks to create enticements and exemptions for active service by legalizing underage drinking and underage consumption of tobacco products for active members of the armed forces and the Alaska National Guard; and

WHEREAS, compromising standards of law-abiding citizens to create unhealthy and potentially unwieldy exemptions for underage alcohol and tobacco product consumption is not a good way to support our military;

NOW THEREFORE BE IT RESOLVED that the Anchorage Assembly continues to recognize and support all members of the armed forces and the Alaska National Guard, but opposes the creation of alcohol and tobacco product consumption enticements and underage exemptions as proposed under House Bill 210; and

BE IT FURTHER RESOLVED that the Anchorage Assembly respectfully requests the sponsor and Anchorage Legislative Caucus to rethink better and healthier ways to legislatively support active members of the armed forces and the Alaska National Guard.
