A marijuana establishment may not operate in the municipality unless it has obtained the applicable marijuana establishment license/endorsement from the municipality per Anchorage Municipal Code (AMC) 10.80. The Municipal Clerk's Office encourages all applicants to read and keep a copy of AMC 10.80 for reference.
