B. Letter of Support for Strong Motion Instrumentation at Port of Alaska Terminal 1.

Speaking not as the Chair, **Commissioner Thornley** explained that terminal 1 would have seismic instrumentation at the Port. Discussion of what types of sensors, etc. to put in. Commissioners discussed that the Port would need a letter of support from GAC to the Assembly. **Commissioner Nutter** asked about the timeline and what the proposed plan is so the Commission could know what to write about.

Commissioner Kreitel moved that the GAC should write a letter; Commissioner Steiner seconded. Six commissioners voted in favor. Commissioner Thornley abstained from voting.

Commissioner Halcomb relinquished the Chair to Chair Thornley.
