A. August 27, 2024 Regular Meeting. Commissioner Steiner moved to approve; Commissioner Halcomb seconded. Passed unanimously.

- A. Letter of Support for Strong Motion Instrumentation at Port of Alaska Terminal 1. Commissioner Brennan discussed the draft letter and the pros and cons of strong motion instrumentation.

IV. NEW BUSINESS

A. GAC Resolution No. 2024-02 Recommending Minimum On-site Testing for

Geotechnical Technical Reports. Commissioner Steiner voiced concern that a minimum number of test borings is not an appropriate standard and inquired where onsite testing is. **Wayne Bolen** clarified that testing is required for any new commercial development, tenant improvements with changes to foundation, and new residential development in seismic zones 4 & 5 or additions around 50% of increased dwelling footprint.

Discussion on whether the commission is comfortable relying on other engineering reports for due diligence near the project area or if site-specific data is required.

Wayne Bolen clarified that they are not looking for specific number or depth requirements for site exploration. GAC cannot be the reviewing body for reliability of nearby data due to the timing of permits.

GAC Resolution No. 2024-02 has ongoing updates. **Commissioners** request a possible work session to finalize and approve.

GEOTECHNICAL ADVISORY COMMISSION RESOLUTION NO. 2024-02

A RESOLUTION RECOMMENDING MINIMUM ON-SITE EXPLORATION FOR REQUIRED GEOTECHNICAL REPORTS.

(GAC Case No. 2024-02)

WHEREAS, the Municipality of Anchorage (MOA) Geotechnical Advisory Commission (GAC) is established in the Anchorage Municipal Code (AMC) to act in an advisory capacity to the Assembly, the Mayor, boards, commissions, and heads of municipal departments and agencies on geotechnical engineering issues and natural hazards risk mitigation (AMC 21.02.080); and

WHEREAS, the Anchorage area has a complex geological setting; and

WHEREAS, decades of development and demolition in the Anchorage area with minimal and inconsistent oversight have allowed for conditions where past dumping, poor quality fill, and other site issues that are not readily observable from the surface; and

WHEREAS, site-specific geotechnical exploration provides a higher level of awareness of the possibility for risks in the soil; and

WHEREAS, geotechnical reports are required per AMC 23.85.R101.4 and IBC section 1803; and

WHEREAS, historical geotechnical data can be used to provide context on subsurface conditions; and

NOW, THEREFORE, BE IT RESOLVED that the Geotechnical Advisory Commission:

- A. Makes the following findings of fact:
 - 1. Historical data should not be solely relied upon, and further sitespecific exploration is required to support design recommendations. Verification language- EXPAND FINDING
 - 2.
- B. Recommends that the Municipality update its policy to require site-specific geotechnical exploration where geotechnical reports are required.
