- 2. APPROVAL OF AGENDA: Mr. Steele moved to approve the agenda. Mr. Loken SECOND and UNANIMOUNSLY APPROVED.
- 3. APPROVAL OF MINUTES:
 - a. Minutes of September 15, 2016. Mr. Steele moved to approve the minutes. Mr. Cowling second. Unanimously approved with minor edits.
- 4. **NEW BUSINESS**
 - a. Elections

Chair Bohne opened the floor to nominations for Chair. Mr. Cowling nominated Mr. Bohne. Mr. Steele second the motion. Mr. Bohne accepted the nomination. Unanimously approved.

c. Update and Approval of Appeal forms

Staff is bringing back the Appeal forms to the board; noting the highlighted areas on the appeal form, informing them of what new changes were made, stating only one board member sent in comments when it was emailed out to the full board for review and comment. The board openly discussed the cover letter. Much of the discussion was on whether to limit the amount of documents. It was agreed to update the requirements so the board could see what the final version looks like.

- iii, all wording will stay the same
- iv, by staff will be added to the end of the first sentence: *Time allowed for initial case presentation is limited to 10 minutes by staff*
- Items b and c will change to c and d.

Mr. Steele motioned to approve. Mr. Loken second the motion. Unanimously approved.

5. **REPORTS**

Staff noted the department was really busy this year; the numbers are up at the moment but are not expected to last. The Board asked about review times, inspections and who is the current Chief of inspections; it was noted times are down because we lost a structural plan reviewer to fire plan review and we decided not to fill the position due to the economic outlook so now we are behind in some structural reviews. Inspections are doing fine as this is the low time for them. Currently the Chief of Inspections is Hans Gisler. If there are issues, please bring them to us and we will deal with them.

Mr. Feller spoke on an issue regarding minor field changes. Staff recommended the changes be emailed to the reviewer and they can send it the lead or send it to the Chief and/or maybe even having a meeting to discuss some examples of issues.

Staff thanked the board for volunteering their time.
