2. APPROVAL OF AGENDA:

Before approval of the agenda the Board asked for an introduction of the new staff member. Mr. Doehl introduced himself as the new Building Official and Director of Development Services and he looked forward to working with everyone in the room.

3. APPROVAL OF MINUTES:

a. Minutes of November 14, 2018.

5. BOARD MEMBER COMMENTS/REPORTS

Staff commented we finally filled the Building Official position and noted our construction values are down by 8% compared to last year when we were down 10%. Structural inspections are still fully engaged in earthquake damage assessments and we continue to send them out on the weekends. Our goal is to be done by the end of March.

The Code adoption continues, and we are not as far along as we should be due to the earthquake efforts. Some code committees are making good progress, but the structural ones are a little behind. They will be working into the busy season.

House bill 76 concerns the state adoption of the Residential code. The first five sections are housekeeping for AHFC. Section 6 has several concerns with this section as it is not yet defined. MOA legal is looking at this section. Discussion continued for several minutes.

It was heard Eagle River might fall under Anchorage plan review and inspection, have we heard if this would happen soon. Staff replied politically we have not heard anything, but FEMA will issue a final mitigation report analyzing how things went. They will shine a light at the state on the lack of building to code enforcement. Municipality administration would like to see it go through a vote where Eagle River would vote to be let in, and Anchorage would vote to let them in. It is also being investigated by legal on just eliminating the service area and the building safety function would apply to the whole community.

The Board asked for an update on the solar energy code. Staff reported the state has adopted it but noted Building Safety has not formerly adopted it. After lengthy discussion it was agreed to continue later discussion at a later date and time.
