- 2. APPROVAL OF AGENDA: Mr. Strait moved to approved. Mr. Cowling second. The agenda was unanimously approved.

- 4. NEW BUSINESS
  - a. AO 2021-88(S), Section 7, Assembly Amendment #3

Chair Sobolesky opened the floor for discussion. After a lengthy debate regarding the amendment being unsafe and in conflict with state law it was agreed to have the building official create a policy to invoke 23.10.101.5 to address the conflict with state law. Mr. Kunder motioned to have the building official invoke 23.10.101.5 other laws to eliminate the conflict between 23.10.105.1 and state law regarding who can perform electrical, plumbing, and mechanical work. Mr. Hamels second the motion. Unanimously Approved.

Further discussion continued regarding writing a letter to the assembly informing them of the issues the amendment created.

Mr. Strait motioned to have the chair draft a letter to the assembly, discussing the newly created conflicts between municipal and state law and safety concerns resulting from unqualified individuals performing electrical and plumbing work requiring a certificate of fitness. Mr. Cowling second. Unanimously Approved.

#### b. Geotech Letter

Several board members are interested in attending a meeting and would investigate when the next meeting was scheduled.
