### c. Public comment

Mr. Varney mentioned a request he received from members of the Alaska Engineering Community regarding soils application rates that other states use in their codes. This was in response to the State Department of Environmental Conservation code re-write and their reluctance to grant drainfield reductions in systems utilizing advanced treatment, thereby eliminating a major advantage of advanced treatment systems. Orenco Systems has fifty on file, one for each state and a few western Canadian provinces. All information was forwarded to Mr. Garness.
