#### Anchorage Animal Care Control (AACC) Monthly Report and Public Outreach

#### Melissa Summerfield Reported:

- AACC has been busy as Summer is wrapping up.
- Cruelty cases are moving forward. There have been several court dates over the past month.
- We currently have two dogs under protective custody. We have sent the updated cost of care to the owner's attorney, informing them of the financial obligation. Our hope is that this will encourage the owner to release the dogs to us, allowing us to move forward.

• Unfortunately, we are currently dealing with a couple of hoarding cases. One case in particular required a previous response, and we will be going back out next week. We anticipate bringing in anywhere from 15 to 30 cats from that property. However, thanks to our recent cat adoption event, where 27 cats were successfully adopted, we now have the space at the shelter to manage this intake.

# Bernard Chastain – New Security Director for Denali Universal Services (DUS) Introduction:

- Hired as the new Security Director for DUS in early June.
- Retired from the state troopers after 26 years of service, finishing career as a colonel in the wildlife division. Has extensive experience in law enforcement across various parts of the state.
- The AACC contract with DUS is one of several security-related contracts Mr. Chastain manages.

#### Joel Jorgensen Reported:

- Approved by the warden to participate in the prison program in Seward for dogs needing more work on behavioral issues.
- Working to connect with the Fairbanks Animal Shelter and the Seward Animal Shelter to extend network.

- Update on the weather safety tool. The Assembly Information Memorandum (AIM) was presented to the assembly this week and was approved without any discussion or questions.
- Working with our civil legal team on the horse case and will proceed with a civil lawsuit to recover the cost of care for the horses. This will allow us to test the ability to use state law as a municipality.
- The mayor's municipal budget will be released at the start of October.
- Will be applying for a grant through the ASPCA for spay/neuter and vaccination funding.
