The procedure by which the public may speak to the Commission at its meeting is:

- 1. After the staff presentation is completed on public hearing items, the Chair will ask for public testimony on the issue.
- 2. Persons who wish to testify will follow the time limits established in the Commission Rules of Procedure.
 - a. Representatives of groups (community councils, PTA's etc.) 5 minutes.
 - b. Individuals 3 minutes.
- 3. When your testimony is complete, the Commission may ask you questions. You may only testify once on any issue unless questioned by the Commission.

NOTE: Persons planning to testify before the commission will be requested to identify themselves at the beginning of the hearing. Members of the public are asked to mute themselves except when they are testifying or answering questions from the Commission.

HHAND COMMISSION PURPOSE

Advise the mayor and the assembly on issues related o long-and short-term housing, homeless and ommunity development needs in the municipality, nd strategies to effect revitalization of lower- income nd at-risk neighborhoods. The commission shall:

.. Review and make recommendations on the proposed allocation of all federal, state, and municipal evenues targeted for housing and community levelopment programs managed by the municipality.

Identify and address long-and short-term housing ssues in Anchorage, including strategies to stabilize and monitor the housing market, achieve a range of ousing options for sale and for rent and cost effective and socially responsible strategies to preserve or increase the supply of affordable housing.

Advise the mayor and assembly as to policies, practices and legislation which affect housing and ommunity development issues, neighborhood evitalization strategies, and progress related to plans nd programs goals.

 Advise the planning and zoning commission about elevant housing and community development issues nd their connection with land use controls.

Description of the development and implementation of the housing and community development onsolidated plan by providing information and policy dvice about municipality's housing and community levelopment needs and priorities.

Advise the mayor and assembly as to the nfrastructure, facilities, transportation, and public ervices needs of lower-income and at-risk eighborhoods.

 Facilitate public participation in housing and heighborhood revitalization policies, plans, strategies, nd programs.

Coordinate with the Anchorage Continuum of Care in the development and implementation of the Anchorage plan to address homelessness.

Advise the mayor, and assembly on issues related to nomelessness.

0. Report to the mayor and assembly on the progress of the Anchorage plan to address homelessness. The eport shall be presented on or before June 1 of each ear and shall include recommendations for specific ctions to implement the plan.
