

- Strategic Direction

 - Target biggest community needs
 - Increase housing supply
 - Supportive services
- Transparent, competitive process for selecting projects

RFGP Background

- Housing Acquisition
 - First RFGP under new process
 - Reallocating past years' funds
 - Issued October 22, 2024
 - Proposals due November 25, 2024
 - Highest-scoring proposals incorporated into Substantial Amendments

Substantial Amendments

Substantial Amendments

- Required with major Action Plan changes
- Public Process
 - 30-day comment period
 - Public Hearing
 - Assembly Approval
 - May require two Assembly meetings (up to Assembly to decide)

Substantial Amendments

- Making changes to 2019, 2022, 2023, and 2024 Action
 Plans:
 - \$1,179,000 to Cook Inlet Housing Authority for Baxter
 Acquisition Project
 - \$1,144,847 to Habitat for Humanity Anchorage for ReStore Relocation

Baxter Acquisition Project

- Grantee: Cook Inlet Housing Authority
- Project: Acquisition of 4220 Baxter Road 2.7 acres
- Units: 24 initial phase, 20-30 future phases
- Amount: \$1,179,000 total
 - 2019 Action Plan Substantial Amendment 13: \$55,270
 - 2022 Action Plan Substantial Amendment 4: \$751,949
 - 2023 Action Plan Substantial Amendment 2: \$371,781

Habitat for Humanity Anchorage – ReStore Relocation

- Grantee: Habitat for Humanity Anchorage
- Project: Acquisition of 2422 Arctic Blvd for use as ReStore
- Amount: \$1,144,847 total (of \$1,669,000 request)
 - 2023 Action Plan Substantial Amendment 2: \$390,828
 - 2024 Action Plan Substantial Amendment 1: \$754,019
