  Assemblyman Littlefield talked about funding for the comprehensive plan.

Chair Cruickshank informed the board the State of Alaska and Anchorage Metropolitan Area Transportation Solutions (AMATS) have conflicting opinions on how federal dollars are to be spent on the local areas. The latest interpretation is any federal dollar project must be on the Transportation Improvement Program (TIP) and not on the Alaska Statewide Transportation Improvement Program (STIP). This is a big change.

Chair Cruickshank talked about the Glenn Highway: Airport Heights to Parks Highway Rehabilitation Project No: CFHWY00545/0001656 and the proposed timelines. Mr. Winsor will email the information he has to the board regarding the project.

Mr. Winsor discussed with the board naming a new road (the Centerfield connect) based on the history of Eagle River. Mr. Winsor has some thoughts of naming the road after the Joe Janke or Lee Jordan. Mr. Winsor requested the board go to their community councils for suggestions for any other nominations for the new road name.
