### 2. 3% Municipal Sales Tax

This item has been removed from consideration in the spring municipal election and will instead appear as a special election item in early summer. Currently there are 5 different tax proposals in process and it is likely that there will be more proposals considered by the Assembly.

Timing is critical as GBOS can comment on it before it goes to the Assembly to appear on the ballot but not after. Specific timing is not known as the item is in process with the Assembly. GBOS recommends having the item on the agenda in February to stay on top of the timing and proposals under consideration.

### 3. Consider Resolution of Support for (S) Version of the Girdwood Comprehensive Plan

Group reviews draft language for a Resolution that supports the (S) version provided at the meeting. The (S) version accepts changes that were mutually accepted by LUC, GBOS, Imagine!Girdwood and Planning Dept. It does not include items that were not accepted by the community, including Planning Dept recommendations about Virgin Creek area, land north of the Airport and changes to vegetative buffers.

It is likely that an (S1) version will be proposed later this week, however the specific language that may be proposed is not yet known. The process is confusing and the various amendments to the AO are difficult to track. Group discusses the need to be specific about what the community wants in this resolution so that this cannot be lost in the evolution of this discussion.

Motion: GBOS and LUC move to take 5 minute break to review (S) version of the Girdwood Comprehensive Plan. KO/JW Assent

### Motion:

GBOS moves to amend draft Resolution 2025-01 to add a Whereas statement emphasizing the community commitment to the Virgin Creek area and land north of the Airport to remain designated as open space and affirming vegetative buffers.

Motion by KO/2<sup>nd</sup> JW

Motion carries 3-0 in roll call vote (ME abstains)

### Return to Motion:

GBOS Moves to approve the resolution 2025-XX as amended.

Motion by JW/KO Motion carries 3-0 in roll call vote (ME abstains)

It is noted that once the language is produced, GBOS will review and will have 24 hours to reconsider their vote.

4. Revision to Resolution 2024-15 Proposed No Substantive change to Girdwood Community Council boundary Resolution passed in December didn't discuss the amendments to community council boundaries related to changes reflecting tide in Turnagain Arm.
