1. Welcome New member: Kellie Okonek
Kellie Okonek agrees to take on the role of Police and Roads/Utilities until reassignment after the election.

2. Legislative Report – Sen. Cathy Giessel's aide Paige states that Giessel is working on a new group addressing energy solutions, among other projects.

Assembly members - R. Sulte, Z. Johnson: No report

Anchorage School Board Liaison – Carl Jacobs: Focus is now on Math proficiency in ASD. ASB is working on right sizing plan for the district, which likely involves closure of some elementary schools based on population shift and decline in some neighborhoods.

HLBAC Report - HLBAC meeting October 24 at 1:30PM.

3. Supervisor Reports

ME: Assembly considering resolution at the 10/22 meeting that will encourage capital projects (ie bonding) for Parks and Recreation in Anchorage toward parts of town with high population density. Girdwood already has a difficult time bonding for anything, but this could make bonding even more prohibitive for Girdwood Parks and Rec projects. ME has been appointed to the Budget Advisory Commission. ME has traveled to a conference focused on housing issues of Mountain Towns held in the Lower 48.

- 4. Committee updates to GBOS: 3 min each; items not on the agenda but items of interest to the community PSAC: Tommy O'Malley shares photos and information from the Kids and Cops program at the Ice Cream Shop last weekend. GHEC: Brett Wilbanks provided a progress report on GHEC activities that is included in the meeting packet.
- 5. Status of Proposed Girdwood Developments. No update. The report from September is unchanged.
- 6. Service Provider Reports (5 mins each)

Fire - Chief Weston: See meeting packet for report

Police – Chief Achee: See meeting packet for report. YTD Statistics are on the PSAC page.

Roads/Parks & Rec – Kyle Kelley: See meeting packet for report. GVSA has a donor for replacement of the California Creek Bridge behind the ACS/Police station building. Planning to build in 2025. Roads have been graded for winter. Snow clearing equipment is being prepared for the winter. Delay in acquiring the gravel from Chugach Electric project on the Highway. Gravel may be moved to Girdwood later this year if agreement is met. Culvert on Davos will be replaced with a fish passage compliant one next spring. Culvert at Ruane will likely be replaced in 2026. Finalizing work on the EPA grant to secure these funds.

# **PUBLIC COMMENT:**

Ky Holland: Candidate for State House.

Hayley Johnston: Encourages Girdwood/Turnagain Arm residents serve on the Chugach State Park Advisory Board.

Term is 3 years with 2 term limit.

Amanda Tuttle: HLBAC meeting is THU at 1:30.

Brice Wilbanks: uncovered loads of gravel on Alyeska Highway last week created air quality issue. He encourages that the contractor or project manager should be responsible for sweeping the road.

# **OLD BUSINESS:**

7. GVSA capital budget program – Timberline Road Bond (Staff/Supv. Sullivan)

GBOS received a report in the beginning of the year that outlined 3 options for paving part of Timberline Road. The options were based on different build types, from thinner layer of chipseal to full dig-out and build. The mid-point estimate for paving is for a Concrete Treated Base, which requires less dig-out. The cost estimates ran from \$1.2M-\$2.8M. Traffic study of timberline this summer shows that Timberline receives 1600-1800 unique trips per day, which is fairly close to the volume of Arlberg Road, which is paved. Paving would create narrower lanes for traffic calming and would provide a clearer pedestrian pathway separate from the lanes of traffic. Paving is required for other types of traffic calming, such as speed bumps and additional signage. Paving of Timberline Road has been added to the State Capital Improvement Project List at \$2.5M. Recommendation from staff is for GBOS to also pursue those funds in a bonding effort in the spring election. The opportunity to vote on it will help determine if majority of Girdwood voters approve of this

project, even if it fails to get a majority of Area-wide voters. This will add confidence to the CIP effort at the state level. Project is too expensive for Girdwood to just save up for as with other capital projects.

## KO voted no after learning she could not abstain.

Discussion centered on public comment that this plan should be in consultation with the State Dept of Natural Resources. Individual believes that the plan should be rescinded and re-done. She requests legal review of the proper authority to oversee Land Use Planning. Imagine! Girdwood response is that this would be highly impactful to all planning efforts in Anchorage and that the plan will be subject to all levels of review, including Legal. GBOS requests a written list of the concerns that she has so that they can be reviewed.

11. Girdwood Housing Implementation Plan – Discussion and recommendations from GHEC (Supvs.Edgington/Wingard)

14. Agenda Item LUC 2410-05: Request for LUC recommendation for GBOS Resolution of Support for extension of water mains to Old Girdwood and Mine Roads to be added to AWWU project list.(Edgington)

Updated draft Resolution of support is displayed. ME suggests passing this resolution conditional upon Land Use approval in November. Land Use had this item as new business but without anyone to present it. LUC requested it return as New Business in November. Urgency is in getting this project on the AWWU project list. Several people from Old Girdwood and Mine Roads state that they would not connect at this time as they are satisfied with their wells.

19. Agenda Item LUC 2407-04: GHEC request for LUC and GBOS to consider support for Service Area STR registration and regulation. (Wilbanks/Schechter/Supv. Edgington)

GHEC has finished their work on committee level and the STR framework was reviewed and accepted by Land Use.

There are two ways to go about creating the AO – either via assembly/legal or with planning/legal. Assembly has just passed the AO to receive more data from the STR booking platforms. Discussion with Assembly Members Sulte and/or Johnson may help to determine the right direction as well.

22. Agenda Item LUC 2410-06: LUC recommendation for GBOS Resolution Marijuana Tax Fund for Childcare and Early Childhood Education to fund Girdwood projects (Krystal Hoke)

Assembly created a group to study and recommend how the funds collected from Marijuana Tax for Childcare and Early Education should be distributed. The plan they have recommended is that for 2024 the \$2.9M collected should have \$500,000 dedicated to capital projects. Krystal would like to request a portion of that is requested to go to the GVSA (GHEC account) and then on to the Little Bears construction project. Additionally, the plan for 2025 is that 1% of the the \$5M anticipated revenues is requested to be dedicated to the GVSA (GHEC) for early childhood education. Urgency in this is budget discussions and likely passing of the 2025 Municipal budget on November 19. It is thought that it would be better to get this in front of the Assembly sooner so that they can review it. GBOS decides to add it as a Special Meeting item after the MOA GBOS meeting on October 28.

Motion to extend the meeting to 10:20 ME/BB Assent

This was introduced at GHEC and LUC in October. Language of the Resolution discussed on October 28 should include statement that support is contingent on support from GHEC.
