GBOS report: Mike Edgington – See written report in meeting packet.

Assembly recently took action to require location data from STR platforms, this data will begin to be reported in January 2025.

P&Z hearing on text amendment to change code for gC-1 and gC-2 is slated for Nov 4. This is on the GHEC agenda. Assembly is considering changes to Planned Use Development requirements, which includes removal of density limits and would impact Holtan Hills development.

PUBLIC COMMENT:

Brian Burnett: Encourage all to be engaged in the Girdwood Comprehensive Plan municipal review and adoption process. Introduction is planned for Nov 6 at the Assembly. A work session is likely Nov 14 or 15. Final hearing and vote on November 19.

Note: See meeting minutes from Aug 2024 GHEC meeting. Group declined to take action at that time from a housing and economic perspective.

Old Business:

 GHEC Review and vote on recommendation that GBOS write a Resolution of Support for P&Z project number 2024-0110: T21 Text Amendment-AO 2024-XXX amending 21.09.040 & 21.09.050 to provide Mixed-Use Development within Girdwood Valley. Planning and Zoning Commission at a Public Hearing on 11/04/24 https://www.muni.org/CityViewPortal/Planning/Status?planningId=18076.

This item was initiated by GHEC and has recommendation as well from LUC. It is now ready to be considered by Planning and Zoning Commission. Draft Assembly Ordinance and proposed GBOS Resolution of Support are included in the meeting packet.

GHEC moves to recommend GBOS Resolution of Support for the T21 Text Amendment to provide mixed use development within gC-1 and gC-2 as presented.

2. STR Registration discussion, review updated STR Registration & Regulation Framework proposal (Wilbanks) Wilbanks has amended the proposal framework to match the earlier discussion of registration costs and fees. He states that the fee chart could be amended as the program matures and mechanisms and results are better understood.

Group discusses the "validated" complaint concept as there may be property owners with neighbors issuing nuisance complaints. There are questions about the adjudication of these complaints.

Group discusses that the Assembly has just passed an ordinance to require reporting from rental platforms that will clarify the locations of STR activity within the MOA by zip code. Assembly may not be ready yet to take further action until some evaluation of that data is made and the level of STR activity is documented through these reports.

Group recommends that a community meeting should be held at some point specifically on this topic. Item is on the agenda for LUC next week.

3. Develop organizational structure to handle receiving HLB managed property and strategy for executing a development project on that land

4. Housing Implementation Plan: Discuss options for contracting for a housing consultant specializing in resort communities and scope of work

GHEC has their own outline of a Housing Implementation Plan and GHEC progress report. Group discusses holding a work session on this topic specifically, or setting aside part of a future meeting to review this more fully.

GHEC moves to send their current Progress Report and GHEC Housing Implementation Plan including assessment of need to GBOS.

Jennifer Wingard states that GBOS seeks specific direction in a request to hire a contractor to work on a Housing Implementation Plan.

Motion:

GHEC moves to support funding to hire a consultant for a Housing Implementation Plan at this time.

Motion fails 0-5 by roll call vote

GHEC clarifies that they are not ready at this time to recommend spending funds on a contractor for the Housing Implementation Plan. They want to assess what areas there are that may need outside assistance.

5. Status of EPA Community Change Grant due Nov 21 for Glacier Creek flood hazard mitigation recommended by GHEC and NTE \$7500 approved by GBOS

Project funding was approved by GBOS in September. Team working on this is meeting and aiming for November 21 deadline. Item will be moved to program updates in future meetings.

 - a. Feasibility study for Gravel Extraction and infil/exfil storage within Girdwood @ NTE \$77,000 from the GVSA TBA account. (Wilbanks): Pending public/private partnership

b. Update on Feasibility study and 30% design for RV Camping in Girdwood, proposed for HLB Parcel 6-134 @ NTE \$39,000 from the GVSA TBA account as recommended by GHEC to GBOS.

New Business:

11. Marijuana Tax Fund for Childcare and Early Education Funds to Girdwood (Little Bears) (Krystal Hoke) Group working on distribution of the new Marijuana Tax is making recommendations to the Assembly. Revenues Areawide from tax are expected to be \$2.9M in 2024 and \$5M in 2025. Capital improvements to Early Childhood Education are part of the recommendations from the committee. Krystal seeks to have a portion of the funding come to Girdwood for Little Bears, likely in the First Quarter Budget Revisions. She envisions a fund being set up through GHEC to support economic development through funding for Little Bears Projects. Group requests more information on what specifically the funds would be used for. It is unclear if funds would be held by GHEC or granted directly to Little Bears.
