

Minutes Final Girdwood Trails Committee Regular Meeting Tuesday, August 6, 2024 7:00PM

Girdwood Trails Committee meetings are taking place on Teams with in-person attendance at the Girdwood Community Room, 250 Egloff Rd.

GTC Voting members are defined as any person eighteen (18) years of age or older who has attended one or more Trails Committee meetings in the last 12 months, and is:

- a) a current resident and/or property owner, business owner or designated representative of a non-profit association; and
- b) who has resided in, owned property in, owned a business located in, or operated as a non-profit association for the preceding ninety (90) days or longer in Girdwood Valley.

Attendance is verified through a sign-in sheet available at each meeting, or equivalent process.

The Girdwood Board of Supervisors, its committees, and subcommittees are subject to the Alaska Open Meetings Act as found in Alaska Statute 44.62.310 and Anchorage Municipal Code1.25 - Public Meetings.

The Girdwood Trails Committee operates under the Girdwood Public Meetings Standards of Conduct.

Public Comment (3 minutes each):

Brian Burnett states that inability to successfully promote trail projects effectively on public land has compromised this use in current planning efforts with the Girdwood Comprehensive Plan. He will work harder on these projects in the future.

Old Business:

1. Status and potential action on the Girdwood Comprehensive Plan

Planning and Zoning Commission resolution has been received. As expected, there are 4 items that were recommended to the Commission by P&Z staff that are not in alignment with the community's goals, two of which are specifically impactful to Trails efforts and not in alignment with the adopted Girdwood Trails Plan.

Group discusses how to address this with the Assembly when the Girdwood Comprehensive plan goes forward for review and adoption in September.

Specific talking points from the trails perspective are:

Review of the history and context of the value of the lands that are in misalignment in the plans

Duration of discussion of the Girdwood Trails Management Plan, Girdwood Trails Plan, Forest Loop Trail Discussion and Virgin Creek drainage.

These are all reflected in the Girdwood Comprehensive Plan that was put forward by the community. GTC was on summer break, so GTC has not yet voted to support the GCP as it was presented to the community prior to engaging in municipal process.

Assembly is likely to have this item introduced via consent agenda in September. A Work Session is likely, and then a hearing and vote. No dates are confirmed yet for any of these steps in the process and will be communicated broadly in the community once they are known.

LUC and GBOS will be discussing this at a Joint meeting on MON Aug 12.

It is noted that Barb has travel planned in September and may need to request another member of the GTC executive committee to attend the Assembly meeting.

2. Review of Summer Trail work completed and upcoming

Brushing: Crews have completed brushing on Lower Iditarod, Beaver Pond, and the dike trail from Townsquare to the school.

Repairs/Future Improvements: The trail bridge from Townsquare to Crow Creek Road has been leveled.

Boardwalk repair on the trail behind the school

Start soon on installing the turnpike to resolve mud holes on the Beaver Pond trail

Repair the boardwalk and netting on all trails and install netting on several boardwalk areas without it.

3. Update on Winner Creek Trail Bridge at Glacier Creek

fall/winter/spring to help raise additional funds for this project.

Design continues with our contractors towards a complete design set for this fall and bid the project for construction in 2025. In September, we will need to discuss a Capital fundraising plan with GTC for the Suspension bridge and Hand tram interpretive center. We'll be looking for volunteers to help organize a plan and pull off fundraising events over the

RTP Grant cycle has been announced for 2025. Staff recommends application for grant to work on some aspect of the bridge, possibly the hand tram interpretive center. Staff will request GTC recommendation of GBOS Resolution of Support for this project likely in September.

4. Consider Community Trails Info message for upcoming month to be shared on social media

GTC recommendation is to communicate about Trail Etiquette, perhaps using a graphic such as the on one the new Trails Map draft.

5. Update of Trail maps

Trails subcommittee reviewed the map on Monday. Subcommittee recommended removing Stumpy's Summer Trail and Deb's Way from the map by a narrow margin and small group and requests that GTC as a group consider this recommendation and provide direction. A number of smaller adjustments are also being made to the map. Group is working toward having a version to provide to GTC for approval soon.

Concerns have to do with lack of permission to access across airport land and lack of parking. Dave Hamre offers to work with Deb Essex on gaining permission for airport access. There are new managers at Statewide Aviation and some different approaches about non-aviation use on airport land.
