**Old Business:**

1. Status of the Girdwood Comprehensive Plan: Assembly hearing is scheduled for Dec 17.  
Group is encouraged to learn more from the Imagine!Girdwood website and meetings and to watch the Assembly work session held last FRI, which is recorded and accessible from the Assembly website.
2. Update on Winner Creek Trail Bridge at Glacier Creek  
On track for the 90% plans to be complete Dec 21, then there will be an internal review and cost estimate review.  
Goal is to bring the 90% plan to GTC in February for presentation and put the project out to bid in March.
3. Consider Community Trails Info message for upcoming month to be shared on social media  
Currently experiencing significant thaw. Meadows are not ready for use.
4. Consider Trails in Virgin Creek Area  
Brenden Raymond-Yacobian is the leader on this project and isn't available to attend this meeting. Discussions so far have been regarding trails accessed from Virgin Creek Road to connect to the Danich Trail. Projects include acquiring easement, improving access, installation of a trail sign/marker and building a trail to access to the bluff as social trail is inadequate for volume of users.
