Dear Municipality Parks and Recreation,

Thank you to the Municipality of Anchorage for supporting pools. I know that pool maintenance and upkeep is costly, and your support of these facilities is important to the aquatic community and the community at large.

I have served as a USA Swimming Official and a National Federation of High School Swim/Dive Official for many years. Recently, I had the opportunity to view the new diving structures at Bartlett Pool firsthand, and I am very concerned. One of my primary roles as Meet Referee is to ensure both safety and a fair playing field. In my opinion, it is only a matter of time before a swimmer hits their head or upper extremities on the new 3-meter diving structures. I also think that the swimmer's concern of injury in lanes 4 and 5 could result in an altered relay start off the blocks and could result in a negative psychological effect on the swimmer which effects performance.

Additionally, I have concerns about blocked egress and ADA compliance. There is at least one athlete in Anchorage who uses a wheelchair. At this time, I believe she would have difficulty accessing lanes 4 and 5. Bartlett's deck was already crowded and the additional 3-meter board in addition to the concrete blocks under the 1-meter boards makes it even more congested.

As a Meet Referee for USA Swimming, I am assigned to a meet at Bartlett in October. I reached out to USA Swimming Risk Management and shared pictures and videos of the new structures. They agree with my concerns and are consulting their legal team and insurance company to give us guidance on how to conduct swim competitions with the current configuration. It is possible that our insurance may not support competition in lanes 4 and 5.

A group of 12 local USA Swimming and NFHS Swim/Dive Meet Referees are discussing how to conduct upcoming swim meets at Bartlett. Although these conversations are still ongoing, the consensus currently is to operate all swim competition out of the shallow end of the pool. We can ensure safety and a fair playing field in the shallow end.

Although the swim community was not initially provided with a copy of a report from the contractor illustrating other pools with similar set-ups, we now have that report and have started outreaching pool managers to see if this similar set-up works for them. None of the pools in the report have the same set up so it's a bit like comparing apples to oranges. This is what I have learned thus far.

- UNLV's Buchanan Natatorium underwent renovations in 2009 and looks nothing like the pictures in the report.
- Tarbell Pool, Lewiston Maine. The Associate Head Coach from Bates College stated "As you say, our set up is a little different in that we have 1 3m board and 2 1m boards. As for the 3m board, we don't have too many issues with the proximity of the board to the

starting block. Generally the larger swimmers may modify their starts in a relay a little but as the arms in such a start do not begin the rotational swing until they have stepped and are already moving forward and downward means that there is little chance that they will come into contact with the board itself. Alternatively, in some pools that have similar setups, will place a retaining chain under the board of the 3m, and fix it to the first level of bars on the safety barrier around the top level of the 3m construction. That raises the board significantly so removing it from the area of concern.”

- Nanaimo Bay Aquatics Center, NB, British Columbia. Outreached but have not heard back.
- Minnesota State University Pool. Outreached but have not yet heard back.
- Deerfield High School Pool, Minnesota. Not outreached. They do not have 3-meter boards.
- Hobart High School Pool, Hobart Indiana. Spoke with the Pool Manager who voiced concern about our design due to safety reasons and said a design like ours would never pass Indiana codes. He is willing to Facetime to show the Hobart Pool set-up.
- Hampton Aquaplex, Hampton Virginia. Although their set-up is different than ours, their General Manager states “ We haven't had any issues. I should have some free time in the coming days and I can send you photos/video as well for reference and we can set up a time to chat.”
- Kokomo, Indiana High School picture looks nothing like Kokomo High School Pool. I do not know where the picture in the report came from.
- Plymouth State University Pool, New Hampshire. Outreached but have not heard back.
- Eau Claire YMCA Pool, Eau Clair, WI . Not outreached. They do not have 3-meter boards
- Äventyrsbadet Sydpoolen - Södertälje – Sweden. Not outreached.

I would like to mention that I applaud the diving community on the upgrades that they brought to many of the municipality pools. Unfortunately, the new 3-meter boards at Bartlett will negatively impact swim competitions. Bartlett Pool is the premiere location for swim competitions in the state. It is the only 50-meter pool and it is the only pool that can adequately host large competitions. It hosts most of the statewide competitions bringing in hundreds of swimmers and their families several times per year. It is my understanding that the diving club has approximately 20 members. They also have new dual 3-meter dive boards near-by at East Pool.

I am a parent of a swimmer who is college bound and set to receive an athletic scholarship. My son is 6 foot 2 inches with a long reach, and he is not the largest swimmer on his team. If he or another swimmer suffers injuries, I expect the Municipality will bear that legal responsibility. I hope none of us find ourselves in that situation. As a Meet Referee, I am working hard at mitigating risks related to these new boards. Unfortunately, that means the swim community suffers.

Dear Anchorage Leaders,

Thank you for your longtime investment in youth recreation and competitive athletics. My family has benefited from your outstanding aquatics facilities for over a decade. In particular, Bartlett High School's competition pool has been an excellent venue for championship swim meets. Our family travels from rural Alaska to Anchorage at least twice yearly for swim meets. For many young swimmers, qualifying for a meet at Bartlett is the pinnacle of their season. Bartlett is the biggest pool venue they've ever been in, and the excitement, pride, and nerves(!) they experience are truly a joy to witness.

Our family has also spent lots of time on deck at Bartlett. My husband volunteers as a meet official at every meet he attends, and I am likely to be sitting behind the starting blocks as a timer. It has always been crowded on deck at the start/finish, but swimmers, officials, and volunteers work together to keep the area safe and serviceable.

Our family's youngest swimmer is now 18, and competing in her final ASAA season as a senior in high school. We just learned about the installation of the new diving boards at Bartlett, and the strong probability that the newly cramped space will make championship meets impossible at Bartlett. We are so saddened to think that her last championship swims in Alaska may not be at Bartlett.

When our daughter was a freshman in high school, Lydia Jacoby was a senior and had just returned to Alaska as an Olympic Gold Medalist. The energy at the ASAA State swim meet that fall was electric. In fact, two Tokyo Olympians were in the pool that weekend, as Jillian Crooks, who has represented Turks and Caicos, was swimming for Homer High School. Lydia and Jillian shared the pool with swimmers who were swimming at State for the very first time. It was a shining example of sportsmanship, camaraderie, and achievement, and one we will never forget.

My understanding is the new diving board installation creates an unsafe situation from the starting blocks of the middle lanes. These are also the lanes where the fastest swimmers are placed, and the lanes that are the most likely to finish with times that are fast enough to qualify for meets outside Alaska. Having to block off those middle lanes from competition could hinder swimmers' ability to achieve

those qualifying times.

I urge you to find a location for the new diving boards at another Anchorage pool. Without a dive tank at Bartlett, there simply isn't room to squeeze both competitive swimming and expanded diving into one single space. While I'm disappointed this situation wasn't anticipated earlier to avoid problems for upcoming championship meets, I'm hopeful that you will be able to identify a solution that meets the needs of both sports for the long run.

Thank you for taking the time to consider my perspective, and for your work as public servants for Anchorage community members, and all those in Alaska who benefit from the many amenities and experiences that can only be found in Anchorage.

Good Afternoon Mr. Braniff,

I am following up on our request to have the high diving boards removed at Bartlett. As the swim community learns about the installation, and now that we are in the water, it is becoming increasingly clear that the high boards are unacceptable to us. We have been following some of the arguments and the following may be relevant as you consider how to move forward:

- Swim community members around the state have asked for a fairly succinct writeup of our position. This can be found at the following link:

- Recently, local USA Swimming and National USA Swimming sanctioning and liability officials held a conference call. These officials must sign off on the safety and competitive equity of a pool before meets can be held. At present, the officials are concerned about the installation and are reviewing the matter. My feeling is that even if everyone finds that the installation somehow meets the "letter of the code", it only highlights faults in the code and review process. It is not reasonable to hang a decision with such impact on the letter of the code when there is so little comfort with that argument.
- The argument has been made that this same form of installation has been successful at a number of facilities throughout the country. We have been reaching out to facilities that have been given as examples of similar board installations in order to compare them and ask about their experience. In all cases so far, these facilities and coaches have expressed concern and surprise at the design that has been employed at Bartlett. They have asserted that our design is nothing like theirs and that it would not have been approved in their jurisdiction.
- The argument has also been made that when we raised concerns about the board layout when the contractors arrived to begin work, we gave some input and signed off on the boards. We did give input that turned out to be based on a faulty assumption of the design, but did not express our approval. A true and robust design process cannot, in any instance, be considered fair and complete when input is sought only as the shovel hits the dirt.
- It has also been argued that a review and stakeholder input process was not required because this is a replacement project. From our point of view, this project goes far beyond a replacement and fundamentally changes the functionality of the space.

I realize that this issue is a tough one and as a 15 year ASD administrator I can sympathize. The most important thing, however, is to do the right thing for kids and the community by returning Bartlett to a safer more functional design. As I have repeated every time I speak on this issue, Alaska Swimming absolutely supports diving and we are glad they are getting improved equipment. There are quality alternative locations and options for diving, however, so it is not reasonable or necessary to ask the swim community to tolerate this poor design in perpetuity at Bartlett Pool.

The busy swim season is now upon us so I would urge action to resolve this issue. In reality, the only way out is through. I respectfully request an update on your approach to this problem and what we can expect in the near future.

Please know that I appreciate what you do as you seek to elevate recreation in Anchorage. I am always available for a conversation about this or any concern.

Hi Mike,

I hope you are well. I was wondering if you have finalized a resolution regarding the diving boards at Bartlett.

on 9/22, I am the director of a USA Swimming Age Group Meet *The Fall Harvest Swim Meet*; with almost 300 kids that I have to postpone or cancel. There is not a feasible way to host a fair or safe swim meet on our competition side of the pool and we usually use both ends of the pool for age group meets. We have about 12-15. meets a year that touches thousands of swimmers. Our club directs the kick off event.

I know you realize the summary of what has happened. It would be great not to lose this swim season.

- 1) No public process was followed to change the footprint and install new equipment to the within a public facility.
- 2) Multiple user groups were not made aware or invited to be part of this process.
- 3) A smaller user group made 100% of the decisions without Municipality oversight or contacting the other user groups.
- 4) The Municipality forgone the standard process of accepting 30% of an outside Grant and settled for 10%.
- 5) The contract did not go out for a bid to Municipal contractors.
- 6) Thousands of users are now denied the use of a space they have been upkeeping, maintaining and purchasing items for such as Blocks, timing equipment, lane lines, scoreboards and other improvement areas.
- 7) The diving project installed new boards at every pool within the Municipality and they have many choices. The swimmers do not have many choices as this is the one competition pool, the only 50 meter pool, and a pool used by many entities.

With multiple locations for the divers to access high dives and low dives and Bartlett to remain with low dives for current competition, my recommendation is to please remove these boards and store them in the basement of Bartlett until a decision can be made where to move them too. Or store them indefinitely at Bartlett and bring them out if a championship event should be won by our city. This would be the rarest occasion but we will have the boards to do so.

If Bartlett is in need of a high dive, then a low profile, the exact same footprint that was removed and thrown away?? needs to be put back in. where it is staggered and not infringing on the space, the competition blocks, along with adhering to safety and not blocking fire exits.

This project just did not "replace diving boards" but rather changed the entire foot print of the

deck, added equipment that was not there before, blocked fire exits and has restricted the use of all of the other user groups using the pool.

Is there any way we could remove these boards and place them in storage before I cancel the meet we are hosting for the 300 plus swimmers?

I understand you are currently working on this. I wanted to check on the timeline.

To: Anchorage Swim and Dive Leaders; Municipal Leaders, Alaska State Legislators and Our Fire Department Safety,

I write to you today regarding the new diving boards that have been installed at the Bartlett Pool.

First of all, Thank you to the legislature who appropriated the special funding and the private individuals who pushed for this project along for the municipality for installing them. We need upgrades!

The Anchorage area were able to obtain 10 new, 1 meter boards that were installed at every pool within the Anchorage Municipality. These new, 1 meter boards help improve safety and will be used during High School season which is approximately 3 months. The two, 1 meter board installed at Bartlett greatly improve the area.

In addition to the 1 meter boards, four 3 meter diving boards were installed. Two at East High and two at Bartlett.

East, Service, West and Chugiak all have their own "Dive Tanks" and or deep areas. These is outside of the shared swimming space. The utilization of these boards do not encroach on another users groups area. This is an outstanding improvement.

The new 3 meter diving boards, (2 at Bartlett) encroach greatly on multiple users and this is why I write today.

The Bartlett pool houses 20 plus swim meets a year between High School and the Club season host events such as Regions, State, Junior Olympics, Sumer National Championships and multiple others and this pool is used for State Wide Competitions. Most being sanctioned with USA Swimming. Safety is of the utmost concern with USA

Swimming when we host meets.

There are over 1500 swimmers currently using our pools. There are approximately 50 divers. I look forward to seeing diving grow.

The swim clubs and ASD pools have paid for multiple upgrades such as Score Boards, Lane lines, diving blocks and have kept the lights on in the pools. (This is another area for discussion at a later time).

As a swim leader, to my knowledge, I only heard about the 3 meter diving boards after they were installed. I visited the deck and as a host of many meets and a safety enforcer, there are multiple issues with the new 3 meters boards. First of all, Bartlett only had 1, 3 meter board which was at a staggered placement not directly over our swim blocks and not encroaching on our blocks or our fire exits. It was a surprise to me that in where there was 1, 3 meter diving boards, it now sits two. They are no longer staggered and directly impede the swimmer blocks to the point of being placed directly over them and 1 inch behind them. They also take up much of the deck space where we place chairs, timers, swimmers and officials. The safety of having a concrete board directly over swimmers heads (yes it will affect the taller swimmer first) but to get on the block you can now only access one side. Regardless whether you're tall or short, the close proximity of even accessing the top of the block hurts the athletes to include add fear that you will hit them every time you stand or dive. These new boards also impede user space and affect traffic.

How we got here?

Having served on the Parks and Rec Commission along with multiple recreation boards, I have never seen a public process not involve all of the user groups, altering the public building without public input, and not try and make this work for all, especially those who have been actively using the space for years.

The reason?

Bartlett can host National events in the future if we put two high dives?

The Reality?

Anchorage for ASD will be using 1 meter spring boards only and never the 3 meter spring boards. There is no separate Dive tank so Bartlett has swimming going on all day and night. The 3 meter boards will not be used at Bartlett on any sort of regular bases and most likely not at all. To have to work around these blocks for the rare chance they may be used doesn't really help complement both user groups. Divers will be able to use the 3 meters at East High at any time.

Safety

Obstacles, concussions, fear of slamming into a board, ADA (our team has a swimmer in a wheel chair that competes) Safety to exit and sharing of users all need to be considered. To my understanding, the fire Marshall approved the exit as you only need one door and not two. Per square footage a foot was added under the ladder and on paper increased the square footage however no one can really sit under the latter it is not usable space. I commend the fire Marshall for helping and I ask that they come back to see what a swim meet will look like. We will be staging a swim meet tomorrow minimally to take pictures but I invite you all to come and work with us in person. We will be placing 2-3 chairs behind every block. When obstacles encroach in a space, fire safety standards change things. We will also assume a wheel Chair coming to the blocks, place 2-3 timers (two are used if the automatic system works, if it fails we must place 3) for USA swimming Sanctions. 4-6 officials, 20 plus swimmers at once all cycling and an open corridor for walking, timing cables for tripping, rugs to cover the chords and more.

Solutions

Due to the fact we all need to work together, I would like this city to follow the public process or at least engage multiple user groups and go beyond who may be using the pool as many of the rest of us also use that pool. When we try and alter Kincaid for the NSAA we have to include, biking, biathlon, frisbee, soccer, nature lovers, skiers, runners, and would never make decisions in a small vacuum.

The fact we have these 3 meter boards and can bid for a National Event in the future is great. If we were to ever get a National Event, (and the odds are low for anytime in the near future) the solutions would be to use the fact we have them to bring up events but until that happens to keep things working, we should remove the boards so that swimming may continue without hazard and put the boards back in prior to the event. I realize that will cost some money, but on the rare occasion they will be needed this cost could be part of the event. When we host National Ski Events to include olympic trials we have to put up and take down all of our gear to keep it out of the way of public use. We also enhance the area during the event and then put it all away. We even rolled out \$30,000 work of internet cable to host the event at Kincaid and then rolled it right back up after the event. We bring in trailers that take up the parking lot and then break them all down. My point is, events happen but they can't encroach on other users full time.

After talking too many, I see this perhaps being the best solution.

Summary Facts:

Bartlett does not have an independent Dive Tank so it will most likely never be used for diving practice. East will be used. Currently Bartlett has been given to a private entity to manage so open swim hours are also not available to be jumping off the high dive.

Currently with the implementation of all the new diving board there is about a 3-5 diver ratio per one board. As far as swim pools, teams are staggering to have enough space.

Bartlett does not have the deck space that other pools have.

The new High Dives encroach to the point of a user, safety and management issue to host swim meets.

A big Thank you for the new boards!

I applaud the community for getting the new boards.

I have added pictures of the area and the hazards. It would be great to share these with all along with an unperson meeting.

We are almost 80% there. I am asking we come together to solve the space issue at Bartlett and look forward to a multi group resolution. This is solvable.

Hi again. I know you are likely growing weary of the diving board topic, as am I.

I wanted to give you the latest update. As Meet Ref, I have tried to mitigate risk and worked towards being able to give our swimmers a normal swim meet with use of lanes 4 and 5 for relays. I truly have tried to make this situation work.

- ASD and ASAA were planning to hang some flagging or some sort of barrier on the 3-meter diving structure to keep swimmers from hitting their heads when climbing on the blocks. Basically, forcing them to step up on the blocks from the side and not from behind.
- The dive community raised the boards (in a bit of a rinky-dink manner but it works) and this took care of the concern that swimmers would hit their heads on the board during the relay take-offs.
- The latest issue is that now that the boards are raised, swimmers were actually allowed to attempt a relay take off during practice and right away two swimmers hit their arms on the dive structure during the backswing of their relay start. I honestly did not think this would happen. When I outreached the pools with similar set-ups listed in the contractor's report, one pool indicated that they "generally did not have any problems" but they also stated swimmers had to adjust their relay starts. Another pool measured the proximity of their blocks to their diving structure and had a similar measurement to ours. Ours is ½ to one-inch closer measurement.

So, I am out of ways to mitigate, and we are at a point where our meets, including championship meets will continue to be run without relays in those two middle lanes.

I want to also point out that I am at Bartlett pool on a regular basis, and I have yet to see anyone use the 3-meter boards. Could you tell me how many hours in the month of September the swim community has rented Bartlett pool and how many hours Artic Dive has rented Bartlett pool?

Therefore, it was vital for someone like me with Olympic aspirations to have access to these facilities in order to best represent the state at national and international levels.

The facility at Bartlett High School is the only one large enough to accommodate many competitions Alaska Swimming hosts throughout the year. With hundreds of kids from around the state dreaming of traveling to different cities to compete, Anchorage has always provided that meeting ground for the biggest meets of the season.

Additionally, Bartlett Pool is home to club teams, lap swimmers, learn to swim programs, and so much more. It has baffled me over the past decade how many initiatives there have been to close pools when they are not only a place for high level athletes to train, but a place for our kids to learn to swim, a place for our elders to go to exercise, a place for dreams to be realized, and a place for the community to come together. Rather than closing pools, we should be promoting them and encouraging their use within the Alaskan community. Bartlett Pool is essential to the growth and success of the sport of swimming in Alaska.

We appreciate that there are steps being taken to discuss how this affects both parties and our community. However, in the meantime, we should consider removing the high dives until further decision is made. We are underway with the high school swim season and the start of the 24-25 club season. There are no events planned for the high dives in the coming months so all they are currently are objects interfering with competition and further increase of safety hazards. High school and club meets generate thousands of dollars for the clubs hosting them. If we have to cancel club meets (like the fall harvest coming up in just a few weeks) due to safety concerns those teams boosters miss out on funding for their athletes.

It seems reasonable to take down and stow the high dives, until further decisions are made, so that we can keep the pool functional for the season that is upon us. Please consider this in the coming days as this is something I am asking to happen promptly.

Again, thank you for looking into this issue.

Hi again. I wanted to pass along how I felt the Big 8 Invite went with the new diving boards. I asked for coach and swimmer feedback at the meet.

The deck was more congested and to move from one side of the deck to the other to address an Official with a raised hand took longer than usual. Both the 1-meter and the 3-meter boards added to this problem. This was more of an inconvenience than anything else. I can deal with inconvenience. Its the safety piece that has me concerned.

A few swimmers reported that the space behind the blocks was more congested, and it was difficult to engage in their usual pre-race routine.

We had two swimmers and one timer report that they hit their heads on the 3- meter diving structures. Luckily, all reported just a bonk and not a hard hit. There was one swimmer who practiced a relay start in Lane 5 (no one was supposed to do that) and grazed her fingertips across the board. This particular swimmer is pretty tall. She is one of the taller female swimmers.

I still feel strongly that we have a safety concern in lanes 4 & 5 and I do not plan to run relays in those lanes. I need to think more about running individual events in these lanes after having people hit their heads at this meet.

In addition, I heard from one of the coaches that I had outreached regarding the contractor's report. Again, this is comparing apples to oranges. This is what the Minnesota State Head Coach stated:

Sorry for the delayed response. I've sent you a few pictures of our 3-meter board from a few different angles. The distance from the back of the block to the 3-meter support base is 18-inches. The distance from the starting block platform to the 3-meter boards is approx. 7 ½ feet.

Our board is centered in between the starting blocks (lanes 4 & 5). In the video that you sent me, it appears that your board nearly directly over a starting block. I'm 6-1 and have more than enough room from the front of the block and the board itself. When I reach up and over, I

can touch the board with my fingertips. We haven't had any issues with our set-up, but it does appear like we have more space than your set-up.

I'm doubtful that I will hear from any other pools that I outreached a couple of weeks ago. If I do hear from someone, I will pass it on. I appreciate all of your time and consideration on this matter.

Hi everyone. I wanted to circle back around to that report from the contractor and let you know what coaches/aquatic directors I have heard from. None of the pools in the report have the same set up so it's a bit like **comparing apples to oranges**. This is what I have learned thus far.

- UNLV's Buchanan Natatorium underwent renovations in 2009 and looks nothing like the pictures in the report.
- Tarbell Pool, Lewiston Maine. The Associate Head Coach from Bates College stated "As you say, our set up is a little different in that we have 1 3m board and 2 1m boards. As for the 3m board, we don't have too many issues with the proximity of the board to the starting block. Generally the larger swimmers may modify their starts in a relay a little but as the arms in such a start do not begin the rotational swing until they have stepped and are already moving forward and downward means that there is little chance that they will come into contact with the board itself. Alternatively, in some pools that have similar setups, will place a retaining chain under the board of the 3m, and fix it to the first level of bars on the safety barrier around the top level of the 3m construction. That raises the board significantly so removing it from the area of concern." ***This statement is coming from a college coach with elite athletes. We have developmental swimmers using the starting blocks. Right now, there is a 6'3"-6'4"ish autistic swimmer

in the area who has worked hard on developing his starts and it would be inappropriate to ask him to modify to keep from smacking his arms.***

- Nanaimo Bay Aquatics Center, NB, British Columbia. Outreached but have not heard back.
- Minnesota State University Pool. Outreached but have not yet heard back.
- Deerfield High School Pool , Minnesota. Not outreached. They do not have 3-meter boards.
- Hobart High School Pool, Hobart Indiana. Spoke with the Pool Manager who voiced concern about our design due to safety reasons and said a design like ours would never pass Indiana codes. He is willing to Facetime to show the Hobart Pool set-up.
- Hampton Aquaplex, Hampton Virginia. Although their set-up is different than ours, their Assistant General Manager answered the questions I sent her. She also sent a picture of a 6'5" gentleman on their blocks for reference. She is willing to have more discussion with our group and send more pictures and video.
 - Does your current set up work well for swim competitions? Is your start end on the same end as the diving boards? *Our "start end" varies depending on the course. If we are running single course, then we will start at the end without boards. If we are running dual course we start from both ends. If we are running long course, our primary start has no blocks, however, our 50's start under the boards and so do chase starts.*
 - Any injuries to swimmers related to the close proximity of the diving structures?
None
 - What is the closest measurement of the 3-meter diving structure to the starting block? *Approximately 18-24 inches.*
 - If a swimmer is standing on the block, can they reach up and touch the board?
Only if they are above 6 foot.
- Kokomo, Indiana High School. The Athletic Director states *"That pool is not our pool. We do have 3 diving boards like that, but we have a separate diving well and lap pool, so our starting blocks are not under the diving boards. I would be concerned as well, as the clearance does not seem appropriate. Please let me know if you need anything additional."*
- Plymouth State University Pool, New Hampshire. Outreached but have not heard back.
- Eau Claire YMCA Pool, Eau Clair, WI . Not outreached. They do not have 3-meter boards
- Äventyrsbadet Sydpoolen - Södertälje – Sweden. Not outreached.

I also want to share with you that the area Meet Referees discussed how to best host upcoming swim competitions at Bartlett. We had wanted to be in alignment but could not come to an agreement. There were no Meet Refs who responded that they would be comfortable running a meet per usual. Everyone who responded voiced safety and equity concerns. Most of the Meet Ref's comfort zone is hosting competition in the shallow end only.

My comfort zone extends to running individual events in all lanes of the deep end but not running relays in lanes 4 & 5. So, for this weekend's big high school meet, I am the Meet Ref and that will be how I'm running things. I'm not happy with this set up but I feel like I'm making the best decision for the swimmers under less-than-ideal circumstances. This is a huge disservice to our hard-working athletes who embrace competition. Everyone loves a good relay race. They are one of the most fun and exciting parts of a swim competition and we just removed the middle lanes.

If I hear back from other pools in that contractor's report. I will let you know.

Thank you to the Municipality of Anchorage for supporting pools. I know that pool maintenance and upkeep is costly, and your support of these facilities is important to the aquatic community and the community at large.

I have served as a USA Swimming Official and a National Federation of High School Swim/Dive Official for many years. Recently, I had the opportunity to view the new diving structures at Bartlett Pool firsthand, and I am very concerned. One of my primary roles as Meet Referee is to ensure both safety and a fair playing field. In my opinion, it is only a matter of time before a swimmer hits their head or upper extremities on the new 3-meter diving structures. I also think that the swimmer's concern of injury in lanes 4 and 5 could result in an altered relay start off the blocks and could result in a negative psychological effect on the swimmer which effects performance.

Additionally, I have concerns about blocked egress and ADA compliance. There is at least one athlete in Anchorage who uses a wheelchair. At this time, I believe she would have difficulty accessing lanes 4 and 5. Bartlett's deck was already crowded and the additional 3-meter board in addition to the concrete blocks under the 1-meter boards makes it even more congested.

As a Meet Referee for USA Swimming, I am assigned to a meet at Bartlett in October. I reached out to USA Swimming Risk Management and shared pictures and videos of the new structures. They agree with my concerns and are consulting their legal team and insurance company to give us guidance on how to conduct swim competitions with the current configuration. It is possible that our insurance may not support competition in lanes 4 and 5.

A group of 12 local USA Swimming and NFHS Swim/Dive Meet Referees are discussing how to conduct upcoming swim meets at Bartlett. Although these conversations are still ongoing, the consensus currently is to operate all swim competition out of the shallow end of the pool. We

can ensure safety and a fair playing field in the shallow end.

Although the swim community was not initially provided with a copy of a report from the contractor illustrating other pools with similar set-ups, we now have that report and have started outreaching pool managers to see if this similar set-up works for them. None of the pools in the report have the same set up so it's a bit like comparing apples to oranges. This is what I have learned thus far.

- UNLV's Buchanan Natatorium underwent renovations in 2009 and looks nothing like the pictures in the report.
- Tarbell Pool, Lewiston Maine. The Associate Head Coach from Bates College stated *"As you say, our set up is a little different in that we have 1 3m board and 2 1m boards. As for the 3m board, we don't have too many issues with the proximity of the board to the starting block. Generally the larger swimmers may modify their starts in a relay a little but as the arms in such a start do not begin the rotational swing until they have stepped and are already moving forward and downward means that there is little chance that they will come into contact with the board itself. Alternatively, in some pools that have similar setups, will place a retaining chain under the board of the 3m, and fix it to the first level of bars on the safety barrier around the top level of the 3m construction. That raises the board significantly so removing it from the area of concern."*
- Nanaimo Bay Aquatics Center, NB, British Columbia. Outreached but have not heard back.
- Minnesota State University Pool. Outreached but have not yet heard back.
- Deerfield High School Pool , Minnesota. Not outreached. They do not have 3-meter boards.
- Hobart High School Pool, Hobart Indiana. Spoke with the Pool Manager who voiced concern about our design due to safety reasons and said a design like ours would never pass Indiana codes. He is willing to Facetime to show the Hobart Pool set-up.
- Hampton Aquaplex, Hampton Virginia. Although their set-up is different than ours, their General Manager states *" We haven't had any issues. I should have some free time in the coming days and I can send you photos/video as well for reference and we can set up a time to chat."*
- Kokomo, Indiana High School picture looks nothing like Kokomo High School Pool. I do not know where the picture in the report came from.
- Plymouth State University Pool, New Hampshire. Outreached but have not heard back.
- Eau Claire YMCA Pool, Eau Clair, WI . Not outreached. They do not have 3-meter boards
- Äventyrsbadet Sydpoolen - Södertälje – Sweden. Not outreached.

I would like to mention that I applaud the diving community on the upgrades that they brought to many of the municipality pools. Unfortunately, the new 3-meter boards at Bartlett will negatively impact swim competitions. Bartlett Pool is the premiere location for swim competitions in the state. It is the only 50-meter pool and it is the only pool that can adequately host large competitions. It hosts most of the statewide competitions bringing in hundreds of swimmers and their families several times per year. It is my understanding that the diving club has approximately 20 members. They also have new dual 3-meter dive boards near-by at East Pool.

I am a parent of a swimmer who is college bound and set to receive an athletic scholarship.

My son is 6 foot 2 inches with a long reach, and he is not the largest swimmer on his team. If he or another swimmer suffers injuries, I expect the Municipality will bear that legal responsibility. I hope none of us find ourselves in that situation. As a Meet Referee, I am working hard at mitigating risks related to these new boards. Unfortunately, that means the swim community suffers.

Mike,

This is great news that you are intending to hold a meeting. I think a meeting with stakeholders and an additional meeting with the Public would be ideal. As the President of one of the swim clubs that rents the pools and a stakeholder, the first time I heard about this was in August of 2024 after they were installed.

This is all really common sense. There is NO room to host high level Swim competitions with this new addition to the Bartlett pool. You have seen it in pictures, you have seen it from precedence and you have seen a true meet now. A user group should NOT have to modify its use so vastly when another user group alters a facility. It must work for all. It is not up to the Diving community to force what they think the Swim Community can do. The fact that there are multiple pools that can house the diving now, there is no reason for these two user groups to continue to have to plead any case.

I am including my response to the news who asked.

There were a lot of behind the scenes pathways that you did with Diving Only. Now Swimming is caught to defend its resources and this is being perceived as a "fight". We refuse to engage in this as a fight. This is the most unfair process I have ever been part of. I was the chair of the Parks and Rec Commission for 6 years and have led many citywide facility initiatives within parks and rec to better Anchorage and its user groups.

We refuse to continue this "he said, she said environment".

It's pretty black and white and common sense.

USA Swimming and Alaska Swimming have been the primary user group in this pool and pay for it. It is the ONLY venue to host high level sanctioned competitions. This has been altered to the point of not being able to operate fair, safe and equitable swim meets. It is not up to the diving community, the diving coach and the persons who obtained the grants to tell the Swimming community that their opinions are not valid and go to these extremes to call the Swimming community liars. Swimming is showing you through facts, Rules, operations, pictures, insurance sanctioning, a live meet and most important precedence.. This is not productive and should be stopped immediately.

Diving for some reason got carte blanche to move ahead with a project for Diving without consulting/fully engaging the primary user group and only after the fact of the installment, was it discovered that this setup will not work for Swimming. Instead of

evaluating the steps and mistakes, this has now become political. It is absolutely not necessary that our community facilities be caught up in a political battle between the will of the divers, the leaders who obtained the money and the Engineers that did not approve this with Swimming Meets in mind and others who pushed forward the funding and the high stakes personnel that allowed this to happen privately.

The easiest thing to do is admit that 90% of the project was successful and diving got diving boards in 6 pools. We're talking 1 pool here, that does not work.

Why don't we take this time to not spend money on new studies but rather get the East High Pool up and running so it may be used to dive and swim.

The fact that the Muni let blocks of concrete alter the decks without a public process along with adding structures that did not exist is the issue. This was not a **replacement** project. Because our pools serve multiple user groups and should be also used to enhance swim lessons for safety within this community, the best design would have been low profile equipment in the same exact space so that can be removed if ever needed and a better sight line for the life guards be included in the design process.

I am attaching my response to the news piece in blue.

ADA Compliance in Sport Misunderstandings:

We are confusing ADA compliance with building code and Adaptive access for fair Sport.

When adding chairs, blocking the access, adding timers and hundreds of swimmers, wheelchairs do not have easy access for movement or exit.

When talking about ADA in competition;

Please remember all when an International Referee is pulling through equity for Adaptive and Able bodies athletes adding to compliance, not only is ADA for safety and life saving measures it is also to provide the most equitable competition for all. Adhering to the Ted Stevens Act and the USOPC/IOC. (US Olympic and Paralympic Committee). This issue is not just about access to one lane. I have noted in the text in blue the scenario of what it means to have access to all blocks. **Discrimination** is the word I point out from the rules. Please note, Diving is arguing they have found many pools this layout is found in the lower 48. (well despite finding this to be quite false by calling the pools they list), why would Anchorage go backwards when they didn't have too?

Perhaps in smaller towns, limited private college facilities, or areas that may have no other options, they may need to create a pool structure like this. But Anchorage does not have too. We have multiple pools that have this same set up for the diving community and they can operate different pools.

So why would we take a step backwards? We don't need to look to these older and small community pools to be our model, This is unconventional thinking to go backwards when we at one point looked to host the Winter Olympics. We can do better, Anchorage and going backwards by deliberately blocking able and disabled athlete/members from being treated the exact same, and is not something we should be proud of.

While the LSC can choose to limit access only if space is an issue, We Alaskans didn't have a space issue, until just now and we have precedence that we operated like the other 95% of the pools.

If possible we need to accommodate everyone in a fair and open competition to include Able Bodied and Disabled athletes.

We don't have to limit their access and why would we? For the Diving community to use these very small subset examples as a model? They could be viewed as now promoting discrimination against disabled athletes. This was probably an unintended consequence but the reality is clear. Anchorage Alaska, home of many Olympians, to include a Gold Medalist Swimmer and many Winter Paralympic Golds should not take a step backwards in equity.

"While all feedback is welcome, this is a local tax payers issue and we must work together to build a stronger community. It is irregardless the needs of pools outside Anchorage as every community and use is different.

We must work within the anchorage municipal process which almost always forces a public process and is required to alter buildings. This did not happen. This was not a diving board replacement project at Bartlett. Kudos to all the other pools that have separate diving tanks. Bartlett is a SHARED space so therefore the diving community needed to SHARE the planning.

This project was an addition and a change which altered a building with additions. It doesn't fall under "replacement" codes. It was not handled with multiple user groups or the public and specifically the main user groups using the facility. The public process was not followed. Swimming has been the primary user group of the Bartlett pool and there are way more than a few NHFS swim meets going on at Bartlett so their endorsement is almost meaningless to the majority of the needs of this pool. And we all know that the NHFS and USA swimming often don't meet up with the same rules, ethics regarding sanctioned needs.

The NHFS has zero jurisdiction over this pool for the majority of its use. And USA Diving also has never hosted a sanctioned national meet in this pool as USA Diving is NOT USA swimming. This pool is primarily used as a USA Swimming sanctioned venue, and USA swimming did not pass this and our sanctioning is in jeopardy which will affect the thousands of swimmers locally and statewide. I applaud the 30-60 divers who got boards in all the pools. We are talking about 1 of the 5 pools that needs to be relooked at. The divers have plenty of opportunities to dive at the multiple pools. The swimmers have one choice where to hold sanctioned meets in an 8 lane 50 meter competition pool.

The swimming community has paid the majority of the costs to keep the pools running. Swimming has paid for the upgrades, blocks, scoreboards, facilities fees, lifeguards, and more. The public process does not exclude.

If the diving community would like to produce a list or the 100s of pools they speak of, the swim community will continue to contact those pools for reference and with this active research it has been noted that much of this information produced is false and the information is incorrect.

This is the beauty of the public process. Transparency. Multiple users share information up front and work together. This did not happen. The swimmers can not use the lanes due to safety. The blocks are obstructed from the back and to each side along with overhead. The fire marshal passed an empty pool and the building code is for open swims not high level competitions and the engineer did not have a swim meet within this code. Any empty building will pass general codes. There was no awareness on how to run a fair and sanctioned competition.

Fire codes with buildings and schools are very different when there are no desks, tables, chairs in it. You can fit more people. Passing inspection of diving boards where there are no swimmers, chairs on deck, timers, timing equipment, access to exits, access to the block or fire exists is not customary to say it's safe. No one can exit through a locker room due to safe sport and there is one exit on that pool deck that is operational and now it is partially blocked. The fire Marshall and building engineer did not have a swim meet in mind. There is no public process I have ever been part of that excluded the primary user group.

When lane 4 and 5 are the fastest lanes and like track and field they are the most advantageous that all swimmers look to earn. We have denied the use of these. And when ADA is mentioned it is not up to anyone to block the use of an adaptive athlete and tell them lane 1 is all you get. That is called discrimination. The swimmer regardless of adaptive or able bodied must have use of all lanes as their ability and speed determines what lane they get, not any adult that assumes a wheelchair athlete or any other adaptive athlete gets access to only lane one. They need to have access to ALL lanes for fairness as all able bodied or adaptive swimmers need access to those lanes they earn if some are blocked is NOT equitable.

I would like USA diving and the engineers to put that in writing that ADA swimmers do not have access to the most advantageous lanes if they should earn them. It is not up to any of us to decide who gets what lane in a swim meet. Every swimmer gets equal access to all lanes to include lane 4 and 5 as they are earned based on performance and are not assigned arbitrarily.

When you have 500 swimmers on the deck, there is no room. The pool area for swimming now has even less space, this is a safety issue. You can not safely get out of the exit with chairs and the crammed swimmers maneuvering around the blocks can barely get in and out of the pool and now we have more obstacles around them.

This pool has precedence and the city has a public process when it comes to multiple user groups. The municipality, assembly and mayor should uphold those processes.

This is now due the addition of new diving boards NOT a replacement . Please produce all the documents that say altering the current use of any of our facilities does not follow the public process? With the addition of diving boards versus replacement it most certainly does.

The fact the word replacement was misused and is why this all passed. Bring back the original board and put one low profile diving board back on its original place. That's what a replacement is. If the diving community were ever to get a sanctioned meet where two high rises would be needed, East high and UAA can house this type of meet or these boards can be removed, stored below Bartlett and put up when that rare meet may come to anchorage just like any other National event we bring to this city. Kincaid does not allow us to permanently alter the stadium. We break down what we build after a national event to allow all user groups

to share the public park. There is no difference here.

In summary, In order to slide under the code of “replacement” , replacement must Replace the exact structure that was removed. This did not happen. New structures were added thus changing the use, the access, the safety and the landscape of the use. The engineer, fire marshal municipality and legislature that approved this did not include multiple user groups and only included diving, they did not follow the public process with multi user groups.

In fact the municipality did not even collect the traditional fees associated with this type of grant and to be honest those fees could have helped the pools and paid to get water back into East high pretty quickly. I think keeping water in the pools and replacing pumps that close pools to include paying lifeguards to keep the pools running would have been a great addition to this grant. This is really all common sense."

Hi Mike,

I hope you are well. I was wondering if you have finalized a resolution regarding the diving boards at Bartlett.

on 9/22, I am the director of a USA Swimming Age Group Meet *The Fall Harvest Swim Meet*; with almost 300 kids that I have to postpone or cancel. There is not a feasible way to host a fair or safe swim meet on our competition side of the pool and we usually use both ends of the pool for age group meets. We have about 12-15. meets a year that touches thousands of swimmers. Our club directs the kick off event.

I know you realize the summary of what has happened. It would be great not to lose this swim season.

- 1) No public process was followed to change the footprint and install new equipment to the within a public facility.
- 2) Multiple user groups were not made aware or invited to be part of this process.
- 3) A smaller user group made 100% of the decisions without Municipality oversight or contacting the other user groups.
- 4) The Municipality forgone the standard process of accepting 30% of an outside Grant and settled for 10%.
- 5) The contract did not go out for a bid to Municipal contractors.
- 6) Thousands of users are now denied the use of a space they have been upkeeping,

maintaining and purchasing items for such as Blocks, timing equipment, lane lines, scoreboards and other improvement areas.

7) The diving project installed new boards at every pool within the Municipality and they have many choices. The swimmers do not have many choices as this is the one competition pool, the only 50 meter pool, and a pool used by many entities.

With multiple locations for the divers to access high dives and low dives and Bartlett to remain with low dives for current competition, my recommendation is to please remove these boards and store them in the basement of Bartlett until a decision can be made where to move them too. Or store them indefinitely at Bartlett and bring them out if a championship event should be won by our city. This would be the rarest occasion but we will have the boards to do so.

If Bartlett is in need of a high dive, then a low profile, the exact same footprint that was removed and thrown away?? needs to be put back in. where it is staggered and not infringing on the space, the competition blocks, along with adhering to safety and not blocking fire exits.

This project just did not "replace diving boards" but rather changed the entire foot print of the deck, added equipment that was not there before, blocked fire exits and has restricted the use of all of the other user groups using the pool.

Is there any way we could remove these boards and place them in storage before I cancel the meet we are hosting for the 300 plus swimmers?

I understand you are currently working on this and thank you! I wanted to check on the timeline.

To: Anchorage Swim and Dive Leaders; Municipal Leaders, Alaska State Legislators and Our Fire Department Safety,

I write to you today regarding the new diving boards that have been installed at the Bartlett Pool.

First of all, Thank you to the legislature who appropriated the special funding and the private individuals who pushed for this project along for the municipality for installing them. We need upgrades!

The Anchorage area were able to obtain 10 new, 1 meter boards that were installed at every pool within the Anchorage Municipality. These new, 1 meter boards help improve safety and will be used during High School season which is approximately 3 months. The two, 1 meter board installed at Bartlett greatly improve the area.

In addition to the 1 meter boards, four 3 meter diving boards were installed. Two at East High and two at Bartlett.

East, Service, West and Chugiak all have their own "Dive Tanks" and or deep areas. These is outside of the shared swimming space. The utilization of these boards do not encroach on another users groups area. This is an outstanding improvement.

The new 3 meter diving boards, (2 at Bartlett) encroach greatly on multiple users and this is why I write today.

The Bartlett pool houses 20 plus swim meets a year between High School and the Club season host events such as Regions, State, Junior Olympics, Sumer National Championships and multiple others and this pool is used for State Wide Competitions. Most being sanctioned with USA Swimming. Safety is of the utmost concern with USA Swimming when we host meets.

There are over 1500 swimmers currently using our pools. There are approximately 50 divers. I look forward to seeing diving grow.

The swim clubs and ASD pools have paid for multiple upgrades such as Score Boards, Lane lines, diving blocks and have kept the lights on in the pools. (This is another area for dicssussion at a later time).

As a swim leader, to my knowledge, I only heard about the 3 meter diving boards after they were installed. I visited the deck and as a host of many meets and a safety enforcer, there are multiple issues with the new 3 meters boards. First of all, Bartlett only had 1, 3 meter board which was at a staggered placement not directly over our swim blocks and not encroaching on our blocks or our fire exits. It was a surprise to me that in where there was 1, 3 meter diving boards , it now sits two. They are no longer staggered and directly impede the swimmer blocks to the point of being placed directly over them and 1 inch behind them. They also take up much of the deck space where we place chairs, timers, swimmers and officials. The safety of having a concrete board directly over swimmers heads (yes it will affect the taller swimmer first) but to get on the block you can now only access one side. Regardless whether you're tall or short, the close proximity of even accessing the top of the block hurts the athletes to include add fear that you will hit them every time you stand or dive. These new boards also impede user space and affect traffic.

How we got here?

Having served on the Parks and Rec Commission along with multiple recreation boards, I have never seen a public process not involve all of the user groups, altering the public building without public input, and not try and make this work for all, especially those who have been actively using the space for years.

The reason?

Bartlett can host National events in the future if we put two high dives?

The Reality?

Anchorage for ASD will be using 1 meter spring boards only and never the 3 meter spring boards. There is no separate Dive tank so Bartlett has swimming going on all day and night. The 3 meter boards will not be used at Bartlett on any sort of regular bases and most likely not at all. To have to work around these blocks for the rare chance they may be used doesn't really help complement both user groups. Divers will be able to use the 3 meters at East High at any time.

Safety

Obstacles, concussions, fear of slamming into a board, ADA (our team has a swimmer in a wheel chair that competes) Safety to exit and sharing of users all need to be considered. To my understanding, the fire Marshall approved the exit as you only need one door and not two. Per square footage a foot was added under the ladder and on paper increased the square footage however no one can really sit under the latter it is not usable space. I commend the fire Marshall for helping and I ask that they come back to see what a swim meet will look like. We will be staging a swim meet tomorrow minimally to take pictures but I invite you all to come and work with us in person. We will be placing 2-3 chairs behind every block. When obstacles encroach in a space, fire safety standards change things. We will also assume a wheel Chair coming to the blocks, place 2-3 timers (two are used if the automatic system works, if it fails we must place 3) for USA swimming Sanctions. 4-6 officials, 20 plus swimmers at once all cycling and an open corridor for walking, timing cables for tripping, rugs to cover the chords and more.

Solutions

Due to the fact we all need to work together, I would like this city to follow the public process or at least engage multiple user groups and go beyond who may be using the pool as many of the rest of us also use that pool. When we try and alter Kincaid for the NSAA we have to include, biking, biathlon, frisbee, soccer, nature lovers, skiers, runners, and would never make decisions in a small vacuum.

The fact we have these 3 meter boards and can bid for a National Event in the future is great. If we were to ever get a National Event, (and the odds are low for anytime in the near future) the solutions would be to use the fact we have them to bring up events but until that happens to keep things working, we should remove the boards so that swimming may continue without hazard and put the boards back in prior to the event. I realize that will cost some money, but on the rare occasion they will be needed this cost could be part of the event. When we host National Ski Events to include olympic trials we have to put up and take down all of our gear to keep it out of the way of public use. We also enhance the area during the event and then put it all away. We even rolled out \$30,000 work of internet cable to host the event at Kincaid and then rolled it right back up after the event. We bring in trailers that take up the parking lot and then break them all down. My point is, events happen but they can't encroach on other users full time.

After talking too many, I see this perhaps being the best solution.

Summary Facts:

Bartlett does not have an independent Dive Tank so it will most likely never be used for diving practice. East will be used. Currently Bartlett has been given to a private entity to manage so open swim hours are also not available to be jumping off the high dive. Currently with the implementation of all the new diving board there is about a 3-5 diver ratio per one board. As far as swim pools, teams are staggering to have enough space.

Bartlett does not have the deck space that other pools have.

The new High Dives encroach to the point of a user, safety and management issue to host swim meets.

A big Thank you for the new boards!

I applaud the community for getting the new boards.

I have added pictures of the area and the hazards. It would be

great to share these with all along with an unperson meeting.

We are almost 80% there. I am asking we come together to solve the space issue at Bartlett and look forward to a multi group resolution. This is solvable.

The new diving boards, installed without proper review, approval, or consultation with all relevant swim teams, have created significant safety issues and negatively impacted the use of this vital facility.

The new diving boards, which are positioned over the diving blocks, occupy an excessive amount of space and have led to dangerous conditions for swimmers. Many swimmers could incur injuries such as hitting their hands, legs, and bodies on the boards. This configuration compromises not only the safety of the swimmers but also the effectiveness and safety of officials and timers who volunteer their time at the pool during swim meets and practices. It is crucial to find a solution that accommodates both the diving community and the swimmers, as was done with the previous diving boards. This would ensure that both groups can use the facility safely and effectively, preserving the pool's role as a premier competitive venue in our state.

High school swim season is underway and this has negatively impacted the swimmers and their ability to compete. Thank you for your attention to this pressing matter. I trust that you will take swift action to address these concerns and work towards a resolution that benefits all parties involved.

Dear Mr. Reeves:

Anchorage is a small town. We're reminded of this when shopping, working, visiting offices or even meeting staff at our children's schools. Recently, there has been a disagreement between the swimming and diving community regarding the newly installed diving boards at Bartlett High School swimming pool. Unfortunately, this disagreement and difference in opinions regarding these new diving boards have moved from private discussions and exploded onto the social media and local news. It's unfortunate because it has pitted two sporting communities that really are in dire need of uniting. It wasn't too long ago when swimming AND diving were at risk of being eliminated as a high school sport. Even the University of Alaska Anchorage has long eliminated swimming and diving teams, unable to justify the expenses of maintaining a university team.

Now, these two communities are divided and waging a public battle over what should be a celebration of a wonderful resource for the diving community. How can it be that a welcome injection of funding to a sport that was once at risk of being eliminated, and well-intentioned improvements cause such division? As Leo Tolstoy stated, "The road to hell is paved with good intention." In this case, a \$400,000 grant. The division arose due to miscommunication and unclear vision to the swimming community regarding the dimensions and installation of the high diving boards. The swimming community could view these high diving board installations as a "bait and switch." They were informed one thing but once installation was completed, the dimensions and location of the diving boards were not what was described or demonstrated (with PVC pipes) to be. The diving community view the objections to the new high diving boards by the swimming community as a method of "pushing the divers" out of the Bartlett pool, when they are trying to expand their sport and presence.

We should all take a collective breath. We should try to remove politics and personal egos out of the equation. We should commend the people who pursued this grant and also appreciate those who approved these funds to improve the diving opportunities in the Municipality of Anchorage pools. We should refocus ourselves on what is truly important, which are the kids. What is most important are the children, yours and mine who utilize these facilities, who utilize Bartlett High School swimming pool for practices and competitions. The opposing parties can argue, there's approximately 60 divers in the state versus approximately 1500 swimmers. They can also argue, "MY child jumped off the starting blocks at Bartlett swimming pool and wasn't encumbered or endangered." However, it's not about one child, but ALL the children who utilize the Bartlett swimming pool that is the ONLY 50 meter Olympic size pool in the State of Alaska. It's the same pool that PJ Foy competed in on his way to qualifying for the Olympic swimming time trials in Indiana this year. It's the same pool that many other Olympic swimming qualifiers competed in, and the same one that Lydia Jacoby competed in on her way to winning an Olympic gold medal for the United States of America in the breaststroke.

The Olympics are held every four years. Imagine if the next Lydia Jacoby is injured on the starting blocks during a meet because of these high diving boards that numerous swimming coaches, officials, swimmers, parents and even USA Swimming has deemed as unsafe to swimmers. How will the Municipality of Anchorage reimburse for the shattered Olympic hopes and dreams of a future Olympic swimmer? Will stating that "the requisite building permits"

were cleared and “USA Diving Association President stated that it was safe” be sufficient to defend accusations of negligence, and comfort the injured Olympic hopeful swimmer? What type of lawsuit liabilities will our collective property taxes have to fund for the Municipality of Anchorage? How much compensation would be enough to an injured swimmer and their family for a lost chance to compete in the Olympic time trials or even the Olympics?

It's understandable why the swimming community is fixated on the Bartlett High School Swimming pool. It's the only 50 meter Olympic size pool in the state and for swimmers, there is no other 50 meter Olympic swimming pool to utilize. But why is the diving community so fixated on Bartlett swimming pool, which doesn't have a separate diving area like East High school swimming pool, West High school swimming pool or even University of Alaska Anchorage? East High School swimming pool has reopened after a long hiatus, and the same number of high dives and low dives (two each) were installed at East swimming pool as Bartlett swimming pool. No one seems to have an answer as to why the diving community in Anchorage, which consists of about 20 divers are so insistent on keeping these high dives at Bartlett swimming pool when there are other diving facilities that may be utilized. Does someone have an answer to this question? It should also be noted that these high dives aren't even utilized on the high school competition level and they could certainly be removed and installed at a later time if needed, like if an NCAA diving competition is held in Alaska?

All those involved in improving the diving facilities should be lauded. But let's not lose sight of what's truly important. The safety of all the children who utilize Bartlett pool including those children whose wingspan and height are above average, like PJ Foy and Mathew Baker. Because the liabilities to the Municipality of Anchorage of what if... what IF an Olympic swimming hopeful suffers trauma to their head and neck due to the diving boards? What IF he/she fractures hands, wrists or forearms on the diving board and its structural base, warming up or jumping off the starting blocks during a race? What would you say to an Olympic swimming hopeful who injures himself/herself on diving boards that aren't even being utilized, when they have to miss the Olympics that happen once every four years... “Sorry about that... Try again in four years?”

Instead of battling over Bartlett swimming pool, let the swimming and diving community come together to support East High School swimming pool improvements so that divers may have an unfettered area for their Olympic dreams to be pursued. In the meantime, please remove the unutilized high dives at Bartlett High School swimming pool which pose a danger to the swimmers, making it a liability to the Municipality of Anchorage, and make it safer for all who utilize the pool.
